15 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General 16 Assembly that any funds disbursed under the authority of the appropriations 17 contained in this act shall be in compliance with the stated reasons for 18 which this act was adopted, as evidenced by the Agency Requests, Executive 19 Recommendations and Legislative Recommendations contained in the budget 20 manuals prepared by the Department of Finance and Administration, letters, or 21 summarized oral testimony in the official minutes of the Arkansas Legislative 22 Council or Joint Budget Committee which relate to its passage and adoption. 23

24 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 25 authorized by this act shall be limited to the appropriation for such agency 26 and funds made available by law for the support of such appropriations; and 27 the restrictions of the State Procurement Law, the General Accounting and 28 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 29 Procedures and Restrictions Act, or their successors, and other fiscal 30 control laws of this State, where applicable, and regulations promulgated by 31 the Department of Finance and Administration, as authorized by law, shall be 32 strictly complied with in disbursement of said funds.

34 SECTION 5. EFFECTIVE DATE. This act is effective on and after July 1, 35 2018. 36
