24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26	SECTION 1. Arkansas Code § 5-4-307 is amended to read as follows:
27	5-4-307. Time period — Calculation.
28	(a) Except as provided in subsection (c) of this section, a period of
29	suspension or probation commences to run <del>on the day it is imposed</del> <u>when the</u>
30	circuit court pronounces the probationer's sentence in the courtroom or upon
31	the entry of a sentencing order, whichever occurs first.
32	(b)(1) Whether <i>imposed</i> pronounced or entered at the same or a
33	different time, multiple periods of suspension or probation run concurrently.
34	(2) The period of a suspension or probation also runs
35	concurrently with any federal or state term of imprisonment or parole to
36	which a defendant is or becomes subject to during the period of the

1	suspension or probation.
2	(c) If a court sentences a defendant to a term of imprisonment and
3	suspends imposition of sentence as to an additional term of imprisonment, the
4	period of the suspension commences to run on the day the defendant is
5	lawfully set at liberty from the imprisonment.
6	
7	SECTION 2. Arkansas Code § 16-93-306(a), concerning the supervision of
8	a probationer by the Department of Community Correction, is amended to add a
9	new subdivision to read as follows:
10	(3) The Department of Community Correction shall assume
11	supervisory responsibilities over a probationer when the circuit court
12	pronounces the probationer's sentence in the courtroom or upon the entry of a
13	sentencing order, whichever occurs first.
