15	(3) An inactive licensee may provide services listed in
16	subsection (a) of this section on a volunteer basis if no compensation is
17	received, the services are not attest services, and no documents are signed
18	as a CPA or PA by the inactive licensee; and
19	(4) An inactive licensee who has returned to work involving the
20	practice of public accounting and has applied with the board to upgrade his
21	or her license to active status may engage in the activities listed in
22	subsection (a) of this section if he or she is supervised by another active
23	licensee and no documents are signed as a CPA or PA by the inactive licensee
24	until his or her application is approved by the board.
