20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. Arkansas Code § 19-6-301, concerning special revenues  
23 enumerated, is amended to add an additional subdivision to read as follows:  
24 (263) Driving record information fees collected under § 27-23-  
25 117.  
26

27 SECTION 2. Arkansas Code § 19-6-404(1), concerning the Department of  
28 Arkansas State Police Fund, is amended to read as follows:

29 (1) Those special revenues as specified in § 19-6-301(1), (5),  
30 (7), (8), (38)-(40), (94), (150), (168), (175), (184)-(186), (190), (218)-  
31 (220), (222), (226), (227), (234), ~~and (252), and (263);~~

33 SECTION 3. Arkansas Code § 27-23-117(3), concerning the distribution  
34 of a driving record, is amended to read as follows:

35 (3) To others, authorized to receive the information pursuant to  
36 § 27-50-906, upon request and payment of a fee of ~~seven dollars (\$7.00)~~ eight



1 dollars and fifty cents (\$8.50).

SECTION 4. Arkansas Code § 27-23-118(c), concerning the deposit and distribution of the driving record fee is amended to read as follows:

(c) The fee set out in § 27-23-117(3) shall be deposited as special revenues into the State Treasury and distributed as follows:

(1) One dollar (\$1.00) of the fee shall be deposited to the credit of the Revenue Division of the Department of Finance and Administration in the Commercial Driver License Fund; ~~and~~

(2) ~~The remaining six~~ Six dollars (\$6.00) of the fee shall be deposited to the credit of the State Highway and Transportation Department Fund for distribution as provided in the Arkansas Highway Revenue Distribution Law, § 27-70-201 et seq.; and

(3) The remaining one dollar and fifty cents (\$1.50) of the fee shall be deposited to the credit of the Department of Arkansas State Police Fund.
