33 Market Facilitation Program to a taxpayer are not deductible or otherwise
34 permitted to offset any other income from the tax year in which the loss or
35 expenses are incurred.

36

1 SECTION 38. EFFECTIVE DATE. Section 37 of this act is effective for
2 tax years beginning on or after January 1, 2020.

3
4 SECTION 39. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
5 authorized by this act shall be limited to the appropriation for such agency
6 and funds made available by law for the support of such appropriations; and
7 the restrictions of the State Procurement Law, the General Accounting and
8 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
9 Procedures and Restrictions Act, or their successors, and other fiscal
10 control laws of this State, where applicable, and regulations promulgated by
11 the Department of Finance and Administration, as authorized by law, shall be
12 strictly complied with in disbursement of said funds.

13
14 SECTION 40. LEGISLATIVE INTENT. It is the intent of the General
15 Assembly that any funds disbursed under the authority of the appropriations
16 contained in this act shall be in compliance with the stated reasons for
17 which this act was adopted, as evidenced by the Agency Requests, Executive
18 Recommendations and Legislative Recommendations contained in the budget
19 manuals prepared by the Department of Finance and Administration, letters, or
20 summarized oral testimony in the official minutes of the Arkansas Legislative
21 Council or Joint Budget Committee which relate to its passage and adoption.

22
23 SECTION 41. EMERGENCY CLAUSE. It is found and determined by the
24 General Assembly, that the Constitution of the State of Arkansas prohibits
25 the appropriation of funds for more than a one (1) year period; that the
26 effectiveness of this Act on July 1, 2020 is essential to the operation of
27 the agency for which the appropriations in this Act are provided; with the
28 exception that Section 37 and Section 38 in this Act shall be in full force
29 and effect from and after the date of its passage and approval, and that in
30 the event of an extension of the Legislative Session, the delay in the
31 effective date of this Act beyond July 1, 2020, with the exception that
32 Section 37 and Section 38 in this Act shall be in full force and effect from
33 and after the date of its passage and approval, could work irreparable harm
34 upon the proper administration and provision of essential governmental
35 programs. Therefore, an emergency is hereby declared to exist and this Act
36 being necessary for the immediate preservation of the public peace, health

1 and safety shall be in full force and effect from and after July 1, 2020;
2 with the exception that Section 37 and Section 38 in this Act shall be in
3 full force and effect from and after the date of its passage and approval.
