15 TO AMEND PROVISIONS OF THE ARKANSAS CODE  
16 CONCERNING MANDATED VISION SCREENINGS FOR  
17 PUBLIC SCHOOL STUDENTS.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Arkansas Code § 6-18-1501(a)(1)(A)(i), concerning vision  
23 screenings, is amended to read as follows:

24 (a)(1)(A)(i) ~~Beginning with the 2006-2007 school year, all~~ All  
25 children in prekindergarten (preK), kindergarten (K), grades one (1), two  
26 (2), four (4), six (6), and eight (8) and all transfer students shall receive  
27 an eye and vision screening.  
28

29 SECTION 2. Arkansas Code § 6-18-1501(b), concerning vision screenings,  
30 is amended to read as follows:

31 (b) ~~An eye and vision screening shall include the following~~ The  
32 Division of Elementary and Secondary Education, in conjunction with the  
33 Arkansas Commission on Eye and Vision Care of School-Age Children, shall  
34 adopt rules to establish the tests, procedures, equipment, and instruments  
35 that shall be used to perform eye and vision screenings. ~~approved by the~~

- 6 ~~(3) A plus lens visual acuity test using a Snellen eye chart at~~

- 9 ~~(4) Visual screening instrument tests, which include:~~
  - 10 ~~(A) Lateral muscle balance test at far;~~
  - 11 ~~(B) Vertical muscle balance test at far;~~
  - 12 ~~(C) Fusion or binocularity at far;~~
  - 13 ~~(D) Lateral muscle balance test at near;~~
  - 14 ~~(E) Fusion or binocularity at near; and~~
  - 15 ~~(F) Color perception.~~
