26	provides only dental benefits or eye and vision care benefits; and		
27	(3) "Positron emission tomography" means an imaging test that		
28	uses radioactive substances to visualize and measure metabolic processes in		
29	the body to help reveal how tissue and organs are functioning.		
30	(b) A healthcare insurer that offers a health benefit plan in this		
31	state shall provide coverage for positron emission tomography to screen for		
32	or to diagnose cancer in a patient upon the recommendation of the patient's		
33	physician when the patient has a prior history of cancer.		
34	(c) Benefits under subsection (b) of this section are subject to any		
35	health benefit plan provisions that apply to other services covered by the
