13	to his or her retirement benefits, at one-half $(\frac{1}{2})$ the rate as fixed by law		
14	for a regularly elected <del>circuit judge</del> :		
15	(1) Circuit court judge, if the retired judge served at any time		
16	as a circuit court judge; or		
17	(2) District court judge, if the retired judge served only as a		
18	district court judge.
