Provided, however, that institutions and 2 agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or 3 4 funds, or both available to it, for the purpose of supplementing the State 5 Treasury funds for financing the entire costs of the project or projects 6 enumerated herein. Provided further, that the appropriations and funds 7 otherwise provided by the General Assembly for Maintenance and General 8 Operations of the agency or institutions receiving appropriation herein shall 9 not be used for any of the purposes as appropriated in this act.

10 (B) The restrictions of any applicable provisions of the State 11 Purchasing Law, the General Accounting and Budgetary Procedures Law, the 12 Revenue Stabilization Law and any other applicable fiscal control laws of 13 this State and regulations promulgated by the Department of Finance and 14 Administration, as authorized by law, shall be strictly complied with in 15 disbursement of any funds provided by this act unless specifically provided 16 otherwise by law.

SECTION 3. LEGISLATIVE INTENT.
