7 (b) The county judge of any county is authorized to submit bids for 8 work to be performed on state aid roads under the provisions of this 9 subchapter, and nothing contained herein shall be construed to limit or 10 restrict the right of a county judge to submit bids for work to be performed 11 by county forces so long as the bids are in accordance with procedures 12 prescribed in § 27-67-206, and the aggregate cost thereof does not exceed two 13 hundred thousand dollars (\$200,000) five hundred thousand dollars (\$500,000). 14

15 SECTION 3. Arkansas Code § 27-72-312(b) and (c), concerning the use of 16 the State Aid Road Fund, are amended to read as follows:

(b) Not more than twenty-five percent (25%) of a <u>A</u> county's allotment
from the fund shall may be used for the purposes of resealing, micro
surfacing, and other methods of pavement preservation.

(c) No Other than funds spent on pavement preservation projects under
 subsection (b) of this section, funds shall not be spent hereunder on any a
 project which shall that does not culminate directly in a paved hard-surfaced
 road.
