24	(a) A licensee shall have his or her driver's license or a digital
25	copy of the driver's license provided by the Office of Driver Services under
26	$\frac{1}{27-16-801}$ in his or her immediate possession at all times when operating a
27	motor vehicle and shall display the driver's license or a digital copy of the
28	driver's license upon demand of a justice of the peace, a peace officer, or
29	an employee of the Office of Driver Services.
30	(b) No person charged with violating this section shall be convicted
31	if he or she produces in court a driver's license issued to him or her and
32	valid at the time of his or her arrest.
33	
34	SECTION 2. Arkansas Code § 27-16-801(a)(6), concerning the issuance of
35	a driver's license, is repealed.
36	(6)(A) The Office of Driver Services may offer an applicant with

3	opportunity to verify the identity and license status of the person.
4	(3) A law that requires a person to surrender his or her
5	Arkansas driver's license to a law enforcement officer shall not apply to the
6	mobile device used to display his or her digitized driver's license.
7	(e)(1) A digitized driver's license:
8	(A) May be accepted by a public entity for all state
9	purposes authorized for a driver's license; and
10	(B) May be accepted by a private entity for all state
11	purposes for a driver's license.
12	(f) The fees collected under subsection (b) this section shall be
13	deposited into the State Treasury to the credit of the State Central Services
