20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Department of Education - Arkansas State Library for the 2017-2018 fiscal
24 year, the following maximum number of regular employees.

15 SECTION 2. EXTRA HELP - STATE OPERATIONS. There is hereby authorized,
 16 for the Department of Education - Arkansas State Library - State Operations
 17 for the 2017-2018 fiscal year, the following maximum number of part-time or
 18 temporary employees, to be known as "Extra Help", payable from funds
 19 appropriated herein for such purposes: seven (7) temporary or part-time
 20 employees, when needed, at rates of pay not to exceed those provided in the
 21 Uniform Classification and Compensation Act, or its successor, or this act
 22 for the appropriate classification.

24 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby
 25 appropriated, to the Department of Education - Arkansas State Library, to be
 26 payable from the State Library Fund Account, for personal services and
 27 operating expenses of the Department of Education - Arkansas State Library -
 28 State Operations for the fiscal year ending June 30, 2018, the following:

9 SECTION 4. EXTRA HELP - FEDERAL OPERATIONS. There is hereby
 10 authorized, for the Department of Education - Arkansas State Library -
 11 Federal Operations for the 2017-2018 fiscal year, the following maximum
 12 number of part-time or temporary employees, to be known as "Extra Help",
 13 payable from funds appropriated herein for such purposes: five (5) temporary
 14 or part-time employees, when needed, at rates of pay not to exceed those
 15 provided in the Uniform Classification and Compensation Act, or its
 16 successor, or this act for the appropriate classification.

17

18 SECTION 5. APPROPRIATION - FEDERAL OPERATIONS. There is hereby
 19 appropriated, to the Department of Education - Arkansas State Library, to be
 20 payable from the federal funds as designated by the Chief Fiscal Officer of
 21 the State, for personal services and operating expenses of the Department of
 22 Education - Arkansas State Library - Federal Operations for the fiscal year
 23 ending June 30, 2018, the following:

 15 determined by the Chief Fiscal Officer of the State, for operating expenses,
 16 grants to libraries, and promotional items by the Department of Education -
 17 Arkansas State Library - Grants Administration - Cash for the fiscal year
 18 ending June 30, 2018, the following:

 32 SECTION 8. APPROPRIATION - STATE LIBRARY REVOLVING. There is hereby
 33 appropriated, to the Department of Education - Arkansas State Library, to be
 34 payable from the State Library Revolving Fund, for operating expenses of the
 35 Department of Education - Arkansas State Library - State Library Revolving
 36 for the fiscal year ending June 30, 2018, the following:

12 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 13 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
 14 FORWARD. At the close of the fiscal year ending June 30, ~~2017~~ 2018, any
 15 unexpended balance of monies provided from the State Library Fund Account for
 16 Books and Subscriptions, as provided in the State Operations Appropriation of
 17 this Act, shall be transferred forward and made available for the same
 18 purpose for the fiscal year ending June 30, ~~2017~~ 2018.

19 Any carry forward of unexpended balance of funding as authorized herein,
 20 may be carried forward under the following conditions:

21 (1) Prior to June 30, ~~2017~~ 2018 the Agency shall by written statement
 22 set forth its reason(s) for the need to carry forward said funding to the
 23 Department of Finance and Administration Office of Budget;

24 (2) The Department of Finance and Administration Office of Budget shall
 25 report to the Arkansas Legislative Council all amounts carried forward by the
 26 September Arkansas Legislative Council or Joint Budget Committee meeting
 27 which report shall include the name of the Agency, Board, Commission or
 28 Institution and the amount of the funding carried forward, the program name
 29 or line item, the funding source of that appropriation and a copy of the
 30 written request set forth in (1) above;

31 (3) Each Agency, Board, Commission or Institution shall provide a
 32 written report to the Arkansas Legislative Council or Joint Budget Committee
 33 containing all information set forth in item (2) above, along with a written
 34 statement as to the current status of the project, contract, purpose etc. for
 35 which the carry forward was originally requested no later than thirty (30)
 36 days prior to the time the Agency, Board, Commission or Institution presents

1 its budget request to the Arkansas Legislative Council/Joint Budget
2 Committee; and

3 (4) Thereupon, the Department of Finance and Administration shall
4 include all information obtained in item (3) above in the budget manuals
5 and/or a statement of non-compliance by the Agency, Board, Commission or
6 Institution.

7 The provisions of this section shall be in effect only from July 1, 2016
8 2017 through June 30, ~~2017~~ 2018.

9
10 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
12 OF FUNDS - PROMOTIONAL ITEMS. The Chief Fiscal Officer of the State shall
13 establish upon request from the Arkansas Department of Education - Arkansas
14 State Library a special appropriation line item to be used in the acquisition
15 of promotional items. When the Department of Education - Arkansas State
16 Library wishes to transfer monies from its operating expenses to promotional
17 items, the request shall be forwarded to the Chief Fiscal Officer of the
18 State for processing after prior approval by the Arkansas Legislative Council
19 or Joint Budget Committee. Determining the maximum number of employees and
20 the maximum amount of appropriation and general revenue funding for a state
21 agency each fiscal year is the prerogative of the General Assembly. This is
22 usually accomplished by delineating such maximums in the appropriation act(s)
23 for a state agency and the general revenue allocations authorized for each
24 fund and fund account by amendment to the Revenue Stabilization Law.
25 Further, the General Assembly has determined that the Department of Education
26 - Arkansas State Library may operate more efficiently if some flexibility is
27 provided to the Department of Education - Arkansas State Library authorizing
28 broad powers under this Section. Therefore, it is both necessary and
29 appropriate that the General Assembly maintain oversight by requiring prior
30 approval of the Legislative Council or Joint Budget Committee as provided by
31 this Section. The requirement of approval by the Legislative Council or
32 Joint Budget Committee is not a severable part of this Section. If the
33 requirement of approval by the Legislative Council or Joint Budget Committee
34 is ruled unconstitutional by a court of competent jurisdiction, this entire
35 section is void.

36 The provisions of this section shall be in effect only from July 1, 2017

1 through June 30, 2018.

2
 3 SECTION 11. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 4 authorized by this act shall be limited to the appropriation for such agency
 5 and funds made available by law for the support of such appropriations; and
 6 the restrictions of the State Procurement Law, the General Accounting and
 7 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 8 Procedures and Restrictions Act, or their successors, and other fiscal
 9 control laws of this State, where applicable, and regulations promulgated by
 10 the Department of Finance and Administration, as authorized by law, shall be
 11 strictly complied with in disbursement of said funds.

12
 13 SECTION 12. LEGISLATIVE INTENT. It is the intent of the General
 14 Assembly that any funds disbursed under the authority of the appropriations
 15 contained in this act shall be in compliance with the stated reasons for
 16 which this act was adopted, as evidenced by the Agency Requests, Executive
 17 Recommendations and Legislative Recommendations contained in the budget
 18 manuals prepared by the Department of Finance and Administration, letters, or
 19 summarized oral testimony in the official minutes of the Arkansas Legislative
 20 Council or Joint Budget Committee which relate to its passage and adoption.

21
 22 SECTION 13. EMERGENCY CLAUSE. It is found and determined by the
 23 General Assembly, that the Constitution of the State of Arkansas prohibits
 24 the appropriation of funds for more than a one (1) year period; that the
 25 effectiveness of this Act on July 1, 2017 is essential to the operation of
 26 the agency for which the appropriations in this Act are provided, and that in
 27 the event of an extension of the legislative session, the delay in the
 28 effective date of this Act beyond July 1, 2017 could work irreparable harm
 29 upon the proper administration and provision of essential governmental
 30 programs. Therefore, an emergency is hereby declared to exist and this Act
 31 being necessary for the immediate preservation of the public peace, health
 32 and safety shall be in full force and effect from and after July 1, 2017.
