18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. Arkansas Code § 17-44-102(d), concerning the records
21 required of certain scrap metal transactions, is amended to read as follows:

22 (d) The record of each scrap metal purchase transaction shall contain
23 the following information taken at the time of sale and be kept on record:

24 (1) The name, address, gender, birth date, and identifying
25 number from the seller's driver's license, military identification card,
26 passport, or other form of government-issued photo identification;

27 (2) A photocopy of the government-issued photo identification
28 provided under subdivision (d)(1) of this section;

29 (3) The date of the scrap metal purchase transaction;

30 ~~(4) The digital thumbprints of the seller;~~

31 ~~(5)-(A)-(4)(A)~~ (4)(A) A ~~general~~ specific description of the ~~predominant~~
32 ~~types of~~ scrap metal purchased.

33 (B) The ~~general~~ specific description shall be made in
34 accordance with the custom of the trade and shall include without limitation:

35 (i) Any identifying marks or unique characteristics;

(ii) Serial numbers, if applicable;

~~(6)~~(5) A general description of the configuration of the scrap metal and whether the material is insulated;

~~(7)~~(6) The weight, quantity, or volume, recorded in accordance with the custom of the trade, of the scrap metal purchased;

~~(8)~~(7) The consideration paid;

~~(9)~~(8) The license plate number of the vehicle used in transporting the materials to the scrap metal recycler's place of business; and

~~(10)~~~~(A)~~(9)(A) A clearly identifiable date-and-time-stamped digital photograph of the:

(i) Seller; and

(ii) Scrap metal in the form in which it was purchased.

(B) The name of the person taking the photographs under this subdivision ~~(10)~~(9) shall be recorded and provided with the photographs.
