16 TO PREVENT A PUBLIC SCHOOL DISTRICT FROM
17 USING PUBLIC FUNDS TO PAY THE
18 PROFESSIONAL ORGANIZATION MEMBERSHIP DUES
19 OF A TEACHER OR A CLASSIFIED EMPLOYEE.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code § 6-17-805 is amended to read as follows:

25 6-17-805. Deduction for professional membership dues – Prohibition on
26 use of public funds – Definitions.

27 (a)(1) Upon the written request of ~~any a~~ a teacher or classified
28 employee, ~~the a public school district~~ the a public school district board of directors ~~of any school~~
29 ~~district of the state~~ shall deduct from the salary of ~~that~~ the teacher or
30 classified employee such sums as the teacher or classified employee shall
31 specify for the payment of membership dues in any bona fide teacher's or
32 classified employee's educational professional organization designated by the
33 teacher or classified employee in the request.

34 (2) Except as provided in subdivision (a)(1) of this section, a
35 public school district shall not use public funds to pay membership dues to a
36 teacher's, classified employee's, or public school district board of



1 directors member's educational professional organization that uses public
2 funds to directly or indirectly engage in lobbying.

3 (b) ~~The~~ A teacher or classified employee may request under subdivision
4 (a)(1) of this section a lump-sum deduction or have the sum to be deducted
5 spread over the school year.

6 (c) ~~The~~ A public school district board of directors, or its authorized
7 representative, shall transmit the sum deducted to the organizations
8 designated by the teacher or classified employee in ~~the~~ his or her request
9 under subdivision (a)(1) of this section.

10 (d) All requests under subdivision (a)(1) of this section shall bear
11 the manual signature of the teacher or classified employee.

12 (e) ~~The~~ A request under subdivision (a)(1) of this section shall be
13 filed with the contract of the teacher or classified employee and shall be
14 subject to audit by Arkansas Legislative Audit.

15 (f) As used in this section:

16 (1) "Classified employee" means ~~any~~ a person employed by a
17 public school district under a written annual contract and who is not
18 required to have a teaching license issued by the Department of Education as
19 a condition of employment; and

20 (2) "Teacher" means ~~any~~ a person, including without limitation a
21 superintendent and assistant superintendent, holding a license issued by the
22 State of Arkansas and employed by a public school district in a teaching,
23 instructional, supervisory, administrative, or educational and scientific
24 capacity.
