Page 1, line 8, delete "DIVISION OF YOUTH SERVICES"

AND

Page 1, line 9, delete "HIGH SCHOOL SYSTEM" and substitute "EDUCATIONAL CAREER ALTERNATIVE SCHOOL"

AND

Page 1, Delete the subtitle in its entirety and substitute:

"TO ESTABLISH THE REGIONAL EDUCATIONAL CAREER ALTERNATIVE SCHOOL FOR ADJUDICATED YOUTH."

AND

Delete "SECTION 1." and "SECTION 2." of the bill

AND

Page 2, delete lines 17-19 and substitute the following language:

"SECTION 1. Arkansas Code Title 6, Chapter 11, Subchapter 2 is amended to add an additional section to read as follows:

6-11-208. Regional Educational Career Alternative School."

AND

Page 2, delete lines 30 and 31 and substitute the following language:

"(2) "Regional school for adjudicated youth" means a campus of the Regional Educational Career Alternative School operated by the Department of Career Education that provides educational and support"

"(b)(1) The Department of Career Education shall operate the Regional Educational Career Alternative School for"

"(2)(A) The Regional Educational Career Alternative School for adjudicated youth may"

(A) Department of Workforce Services;

(B) Division of Youth Services of the Department of Human Services; and

(C) Department of Education."

SECTION 4. Arkansas Code § 9-27-323(e), concerning diversion agreements, is amended to add an additional subdivision to read as follows:

(e) Diversion agreements shall be limited to providing for:

(1) Nonjudicial probation under the supervision of the intake officer or probation officer for a period during which the juvenile may be required to comply with specified conditions concerning his or her conduct and activities;

(2) Participation in a court-approved program of education, counseling, or treatment;

(3) Participation in a court-approved teen court; ~~and~~

- (4) Participation in a juvenile drug court program; and
- (5) Enrollment in the Regional Educational Career Alternative

School.
