Subtitle of House Bill No. 1752

TO AMEND THE MINIMUM WAGE ACT OF THE STATE OF ARKANSAS; TO PROVIDE AN EXCEPTION
TO THE DEFINITION OF "EMPLOYER"; AND TO AMEND THE MINIMUM WAGE ACT OF THE STATE
OF ARKANSAS RESULTING FROM INITIATED ACT 5 OF 2018.

Amendment No. 1 to House Bill 1752

Amend House Bill No. 1752 as originally introduced:

Page 1, delete lines 10 through 13, and substitute the following:
"ARKANSAS; TO AMEND THE MINIMUM WAGE ACT OF THE STATE OF ARKANSAS RESULTING
FROM INITIATED ACT 5 OF 2018; AND FOR OTHER PURPOSES."

AND

Delete the subtitle in its entirety and substitute:

"TO AMEND THE MINIMUM WAGE ACT OF THE
STATE OF ARKANSAS; AND TO AMEND THE
MINIMUM WAGE ACT OF THE STATE OF
ARKANSAS RESULTING FROM INITIATED ACT 5
OF 2018."

AND

Delete SECTION 1 in its entirety and substitute the following:

"SECTION 1. Arkansas Code § 11-4-210, as amended by Initiated Act 5 of
2018, is amended to remove obsolete provisions and to read as follows:

11-4-210. Minimum wage.

~~(a)(1) Beginning October 1, 2006, every employer shall pay each of his
or her employees wages at the rate of not less than six dollars and twenty-
five cents (\$6.25) per hour except as otherwise provided in this subchapter.~~

~~(2) Beginning January 1, 2015, every employer shall pay each of
his or her employees wages at the rate of not less than seven dollars and
fifty cents (\$7.50) per hour, beginning January 1, 2016, the rate of not less
than eight dollars (\$8.00) per hour, and beginning January 1, 2017, the rate~~



~~of not less than eight dollars and fifty cents (\$8.50) per hour, except as otherwise provided in this subchapter.~~

~~(3)(A) Beginning Except as provided in subsection (c) of this section, beginning January 1, 2019, every employer shall pay each of his or her employees wages at the rate of not less than nine dollars and twenty-five cents (\$9.25) per hour, beginning January 1, 2020 the rate of not less than ten dollars (\$10.00) per hour and beginning January 1, 2021 the rate of not less than eleven dollars (\$11.00) per hour except as otherwise provided in this subchapter.~~

(b) With respect to any full-time student attending any accredited institution of education within this state and who is employed to work an amount not to exceed twenty (20) hours during weeks that school is in session or forty (40) hours during weeks when school is not in session, the rate of wage shall be equal to but not less than eighty-five percent (85%) of the minimum wage provided in this section.

(c) The minimum wage in Arkansas shall be nine dollars and twenty-five cents (\$9.25) per hour for the following employers:

(1) An individual, partnership, association, corporation, business trust, or person or group of persons acting directly or indirectly in the interest of an employer in relation to an employee for a work week in which fewer than twenty-five (25) employees are employed;

(2) A private nonprofit developmental service provider whose operations are primarily funded by state reimbursement or federal reimbursement, or both, on a fee-for-service schedule; and

(3) A private nonprofit entity whose annual operating budget is less than one million dollars (\$1,000,000)."
