TO ENSURE THAT BENEFICIARIES OF THE ARKANSAS MEDICAID PROGRAM HAVE ACCESS TO
NEW PRODUCTS AND LABEL EXPANSIONS APPROVED BY THE UNITED STATES FOOD AND DRUG
ADMINISTRATION; AND TO CREATE THE RARE DISEASE ADVISORY COUNCIL.

Amendment No. 1 to Senate Bill 143

Amend Senate Bill No. 143 as originally introduced:

Page 2, delete line 31, and substitute the following:

"(a) As used in this section, "rare disease or condition" means any disease or condition that affects:

(1) Less than two hundred thousand (200,000) persons in the United States; or

(2) More than two hundred thousand (200,000) persons in the United States and for which there is no reasonable expectation that the cost of developing and making available in the United States a drug for the disease or condition will be recovered from sales in the United States of the drug.

(b) There is established the Rare Disease Advisory Council within the"
