19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 *SECTION 1. Arkansas Code 12-12-1001, concerning criminal history*
22 *reporting definitions, is amended to add an additional subdivision to read as*
23 *follows:*

24 *(14) "Juvenile aftercare and custody information" means*
25 *information maintained by the Division of Youth Services regarding the status*
26 *of a juvenile committed or otherwise placed in the custody of the Division of*
27 *Youth Services from the date of commitment until the juvenile is released from*
28 *aftercare or custody, whichever is later. Juvenile aftercare and custody*
29 *information may include the name, address, and phone number of a contact*
30 *person or entity responsible for the juvenile.*

32 *SECTION 2. Arkansas Code 12-12-1003(a), concerning the collection of*
33 *criminal history information, is amended to read as follows:*

34 *(a) This subchapter governs the ~~collection, maintenance, and~~*
35 *~~dissemination of:~~*

36 *(1) Collection, maintenance, and dissemination of criminal*

1 history information on identifiable individuals charged or pleading guilty or
2 nolo contendere to, or being found guilty of, criminal offenses under the laws
3 of the State of Arkansas; and

4 (2) The dissemination of juvenile aftercare and custody
5 information.

7 SECTION 3. Arkansas Code 12-12-1008(a), concerning the dissemination of
8 criminal justice information, is amended to read as follows:

9 (a) Pending conviction, and nonconviction information available through
10 the Arkansas Crime Information Center, plus information obtained through the
11 Interstate identification Index of from another state's record system, and
12 juvenile aftercare and custody information shall be disseminated to criminal
13 justice agencies and officials for the administration of criminal justice.
