10 HOSPITALS; AND FOR OTHER PURPOSES.

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. Arkansas Code § 20-9-219 is amended to read as follows:
20 20-9-219. Inspections of facilities.

21 (a) As used in this section:

22 (1) "Accrediting organization" means an organization that awards
23 accreditation or certification to hospitals or managed care organizations and
24 has been recognized by the U.S. Centers for Medicare and Medicaid Services
25 for deemed status, including without limitation the Joint Commission;

26 ~~(1) "Department" means the Division of Health of the Department~~
27 ~~of Health and Human Services and "Division" means the Division of Health~~
28 ~~Facilities Services of the Division of Health of the Department of Health and~~
29 ~~Human Services;~~

30 (2)(A) "Hospital" means a facility used for the purpose of
31 providing inpatient diagnostic care or treatment, including general medical
32 care, surgical care, obstetrical care, psychiatric care, and specialized
33 services or specialized treatment which is subject to the rules and
34 ~~regulations for hospitals and related institutions in Arkansas.~~

35 (B) "Hospital" does not mean a facility primarily for the
36 provision of long-term care;



1 (3) "Inspection" means the on-site review of the physical plant
2 *and practices as governed by the current rules and regulations of hospitals*
3 ~~and related institutions;~~

4 (4) "Investigation" means a specific inspection by the division
5 related to a complaint or complaints; and

6 ~~(5) "Joint Commission on Accreditation of Healthcare~~
7 ~~Organizations" means the national accrediting body for hospitals, which~~
8 ~~performs on-site surveys of compliance with its regulations at regular~~
9 ~~intervals to ensure that the hospital provides quality care sufficient to~~
10 ~~justify accreditation; and~~

11 (6) "Survey" means the on-site formal review process of a
12 hospital by the Division of Health Facilities Services at regular intervals
13 to ensure compliance with applicable rules and regulations adopted by the
14 Division of Health of the Department of Health and Human Services.

15 (b) The Division of Health of the Department of Health and Human
16 Services shall make such inspections and surveys as it may prescribe by
17 ~~regulation~~ rule.

18 (c) Each hospital accredited by ~~the commission~~ an accrediting
19 organization shall be deemed by the Division of Health of the Department of
20 Health and Human Services to be licensable without further survey by the
21 personnel of the Division of Health Facilities Services if:

22 (1) The hospital holds current, full accreditation; and

23 (2) The Division of Health Facilities Services receives a copy
24 of the hospital's official accreditation certificate and the complete report
25 issued by ~~the commission~~ an accrediting organization within thirty (30) days
26 of receipt by the hospital from ~~the commission~~ an accrediting organization ~~or~~
27 ~~within thirty (30) days of July 30, 1999.~~

28 (d) No hospital shall be required to submit accreditation by ~~the~~
29 ~~commission~~ an accrediting organization, but whenever a hospital does not
30 submit a ~~commission~~ an accreditation certificate, the personnel of the
31 Division of Health of the Department of Health and Human Services shall
32 conduct such surveys as are prescribed by regulation.

33 (e)(1) Nothing in this section shall affect the right of an authorized
34 representative of the Division of Health of the Department of Health and
35 Human Services to enter upon or into the premises of a hospital at any time
36 to make an inspection as part of an investigation when the Division of Health

1 of the Department of Health and Human Services does so in response to a
2 complaint or specific identifiable information that the hospital is not
3 meeting minimum quality standards.

4 (2) If the Division of Health Facilities Services upon review of
5 ~~a commission~~ an accrediting organization report reasonably determines that a
6 hospital may not be meeting state licensure standards, it may perform a
7 survey of that hospital and take such steps as are necessary to enforce the
8 standards of the Division of Health of the Department of Health and Human
9 Services.

10 (f) A validation survey may be conducted on five percent (5%) of
11 deemed hospitals during any calendar year to determine continued compliance
12 with state regulations.

13 (g) The Division of Health of the Department of Health and Human
14 Services shall continue to have authority over new construction, renovations,
15 and alterations of the hospitals as set forth in the current regulations.

16 (h) All hospitals shall notify the Division of Health Facilities
17 Services within thirty (30) days when there is a change in accreditation
18 status.

19 (i) A staff member of the Division of Health Facilities Services may
20 accompany ~~the commission~~ an accrediting organization team that conducts any
21 hospital accreditation survey as an ex officio member for the purpose of
22 observation.
