14 CONCERNING TERMS OF CERTAIN MEMBERS OF
15 ADVERTISING AND PROMOTION COMMISSIONS.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. Arkansas Code § 26-75-605(a), concerning membership of
21 advertising and promotion commissions, is amended to read as follows:

22 (a) ~~Any~~ A municipality levying a tax pursuant to this subchapter shall
23 create by ordinance a municipal advertising and promotion commission, to be
24 composed of seven (7) members, as follows:

25 (1)(A) Four (4) members shall be owners or managers of
26 businesses in the tourism industry, and the owner or manager shall reside in
27 the levying municipality or, if the governing body of the municipality
28 provides ~~for~~ by ordinance, the owner or manager may reside outside of the
29 municipality but within the county where the municipality is located.

30 (B) At least three (3) of these members shall be owners or
31 managers of hotels, motels, or restaurants and shall serve ~~for~~ staggered
32 terms of four (4) years;

33 (2) Two (2) members of the commission shall be members of the
34 governing body of the municipality and selected by the governing body and
35 shall serve at the will of the governing body; and

36 (3)(A) One (1) member shall be from the public at large who



1 ~~shall reside~~ resides within the levying municipality or in the county of the
2 levying municipality and shall serve for a term of ~~four (4)~~ two (2) years.

3 (B)(i) A member under subdivision (a)(3)(A) of this
4 section may not serve more than two (2) consecutive terms.

5 (ii) However, a member under subdivision (a)(3)(A)
6 of this section may serve successive terms after an intervening term of
7 nonservice before each successive term.

8
9 SECTION 2. Temporary language – Not to be codified.

10 For a member serving on a municipal advertising and promotion
11 commission under § 26-75-605(a)(3) on the effective date of this act, this
12 act applies at the expiration of the member's current term.
