## Subtitle

14 TO AMEND THE DEFINITIONS OF

16 UNDER THE UNIFORM MOTOR VEHICLE

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code § 27-14-207(2) and (3), regarding the  
25 definitions of “manufactured home” and “mobile home” under the Uniform Motor  
26 Vehicle Administration, Certificate of Title, and Antitheft Act, are amended  
27 to read as follows:

28 (2) “Manufactured home” means ~~a dwelling unit constructed in a~~  
29 ~~factory~~ a factory-built structure:

30 (A) Produced in accordance with the ~~federal Manufactured~~  
31 ~~Home Construction and Safety Standards Act~~ National Manufactured Housing  
32 Construction and Safety Standards Act of 1974, 42 U.S.C. § 5401 et seq.; and

33 (B) Designed to be used as a dwelling unit;

34 (3) “Mobile home” means a ~~dwelling unit constructed~~ structure:

35 (A) Built in a factory ~~prior to~~ before the enactment of
