21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code § 15-22-501 is amended to read as follows:
24 15-22-501. Definitions.

25 As used in this subchapter+,

26 ~~(1) "Commission" means the Arkansas Natural Resources~~
27 ~~Commission; and~~

28 ~~(2) "Water development project"~~ "water development project" means
29 the construction, acquisition, ownership, replacement, operation, and
30 maintenance of facilities, including land, easements, and works of
31 improvement, for the protection, conservation, preservation, development,
32 utilization, and proper disposal of the state's water resources and related
33 land resources in order to:

34 ~~(A)~~ (1) Provide for the people of the state adequate supplies of
35 quality water for municipal, industrial, agricultural, recreational, and
36 domestic purposes, water for navigation, and access to the state's lakes and



1 streams, and parks and other recreational sites along their shores; ~~and~~
2 ~~(B)(2)~~ Reclaim, preserve, and protect the state's land resources
3 and to adequately protect the wealth of the state from disastrous floods; and

4 (3) Collect or treat sewage, including, without limitation,
5 wastewater treatment plants, intercepting sewers, outfall sewers, force
6 mains, pumping stations, instrumentation and control systems, and other
7 appurtenances necessary or useful for the collection, removal, reduction,
8 treatment, purification, disposal, and handling of liquid and solid waste,
9 sewage and industrial waste, and refuse.
