17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 *SECTION 1. Arkansas Code § 14-14-104 is amended to read as follows:*
20 *14-14-104. Publication requirements.*

21 ~~*(a) Unless otherwise specifically provided, when a county government*~~
22 ~~*is required to publish, publication shall be by a:*~~

23 ~~*(1) A one-time insertion in a newspaper of general circulation*~~
24 ~~*in the county-; or*~~

25 ~~*(b) Where no newspaper of general circulation exists in a county,*~~
26 ~~*publication may be made by*~~ *(2) Publication on an Internet website owned by*
27 *or affiliated with the county and by posting in three (3) public places which*
28 ~~*have been designated by ordinance.*~~

30 *SECTION 2. Arkansas Code § 14-14-105 is amended to read as follows:*
31 *14-14-105. Notice by publication.*

32 *Unless otherwise specifically provided, when notice of a hearing or*
33 *other official act is required by a county government, the following*
34 *provisions shall apply:*

35 *(1)(A) The notice shall be published two (2) times with at least*
36 *six (6) days separating each publication. The first publication shall be no*



1 more than thirty (30) days prior to the action, and the last publication
2 shall be no less than three (3) days prior to the action.

3 (B) Alternatively, the notice may be published for
4 fourteen (14) consecutive days on an Internet website owned by or affiliated
5 with the county and by posting in three (3) public places which have been
6 designated by ordinance;

7 (2) The published notice shall contain:

8 (A) The date, time, and place at which the hearing or
9 other action will occur;

10 (B) A brief statement of the action to be taken; and

11 (C) Any other information which may be required by the
12 specific provision of law requiring notice.

14 SECTION 3. Arkansas Code § 14-14-903(d) is amended to read as follows:

15 (d) Codification of Ordinances.

16 (1) No later than 1980 and at five-year intervals thereafter,
17 all county ordinances enacted in each of the several counties shall be
18 compiled into a uniform code and published.

19 (2) The uniform code may be published on an Internet website
20 owned by or affiliated with the county.
