## For An Act To Be Entitled

9 AN ACT TO PROVIDE FOR THE DISTRIBUTION OF FUNDS  
10 COLLECTED FOR THE DESIGN-USE CONTRIBUTION FEE FOR THE  
11 COMMITTED TO EDUCATION SPECIAL LICENSE PLATE TO THE  
12 DEPARTMENT OF EDUCATION; TO DECLARE AN EMERGENCY; AND  
13 FOR OTHER PURPOSES.

## Subtitle

16 TO PROVIDE FOR THE DISTRIBUTION OF FUNDS  
17 COLLECTED FOR THE DESIGN-USE CONTRIBUTION  
18 FEE FOR THE COMMITTED TO EDUCATION  
19 SPECIAL LICENSE PLATE TO THE DEPARTMENT  
20 OF EDUCATION AND TO DECLARE AN EMERGENCY.

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
25

26 *SECTION 1. Arkansas Code § 27-24-1402(b)(2) is amended to read as*  
27 *follows:*

28 *(2) ~~Arkansas Committed to Education Foundation~~ Department of*  
29 *Education Fund Account for the Committed to Education special license plate;*

31 *SECTION 2. Arkansas Code § 27-24-1402(c)(2)(C), concerning special*  
32 *license plate applications, is amended to read as follows:*

33 *(C)(i) The ~~department~~ Department of Finance and*  
34 *Administration shall not remit funds to the organization or allow the*  
35 *organization to use the proceeds from the special license plate unless the*  
36 *organization complies with the provisions of this section.*



1 (ii) The Department of Education is exempt from this  
2 subdivision (b)(2)(C).

3  
4 SECTION 3. Arkansas Code § 27-24-1402(d)(5)(A), concerning special  
5 license plate applications, is amended to read as follows:

6 (5)(A) Except as provided under subdivision (d)(5)(B) of this  
7 section, the name of the organization or state agency is not interpreted by  
8 the ~~department~~ Department of Finance and Administration as promoting a  
9 special product, a trademark, or a brand name.

10  
11 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the  
12 General Assembly of the State of Arkansas that the funds that are received  
13 from the Committed to Education special license plate are needed to assist  
14 the state in providing the resources needed for the state's public school  
15 system; and that this act is necessary to make the funds immediately  
16 available for use in funding education. Therefore, an emergency is declared  
17 to exist and this act being necessary for the preservation of the public  
18 peace, health, and safety shall become effective on July 1, 2011.
