15 TO AMEND CERTAIN DEFINITIONS USED IN THE
16 ARKANSAS ALTERNATIVE FUELS DEVELOPMENT
17 ACT.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code § 15-13-102(5) and (6), concerning
23 definitions used in the Arkansas Alternative Fuels Development Act, is
24 amended to read as follows:

25 (5)(A) "Biofuel" means a renewable, biodegradable, combustible
26 liquid or gaseous fuel derived from biomass or other renewable resources that
27 can be used as transportation fuel, combustion fuel, or refinery feedstock
28 and that meets the American Society for Testing and Materials International
29 Specifications and Test Methods and federal quality requirements as in effect
30 on February 1, 2007, for each category or grade of fuel.

31 (B) "Biofuel" includes without limitation:

- 32 (i) Biodiesel or renewable diesel;
33 (ii) Renewable gasoline;
34 (iii) Renewable jet fuel;
35 (iv) Renewable naphtha;
36 (v) Biocrude; ~~and~~



1 (vi) Biogas; and
2 ~~(vi)~~ (vii) Other renewable, biodegradable, mono alkyl
3 ester combustible fuel derived from biomass;

4 (6)(A) "Biomass" means any matter derived from plants, ~~or~~
5 animals, or waste materials that is used for the production of alternative
6 fuels.

7 (B) "Biomass" includes residues or byproducts from:

- 8 (i) Agricultural production;
- 9 (ii) Agricultural processing;
- 10 (iii) Algae;
- 11 (iv) Forest or wood resources;
- 12 (v) Forestry or wood production; ~~or~~
- 13 (vi) Forestry or wood processing; or
- 14 (vii) Landfill refuse.

15 (C) "Biomass" includes plant material from crops that are
16 produced for use in the production of alternative fuels and cellulosic
17 biomass.

18 (D) "Biomass" does not include recycled petroleum oil;
