7 **HOUSE CONCURRENT RESOLUTION**

8 TO PROVIDE FOR A RECESS OF THE EIGHTY-EIGHTH GENERAL
9 ASSEMBLY AT THE CLOSE OF BUSINESS ON MARCH 2, 2012;
10 TO AUTHORIZE THE PRESIDENT PRO TEMPORE OF THE SENATE
11 AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, BY
12 JOINT PROCLAMATION, TO RECONVENE THE GENERAL ASSEMBLY
13 AT ANY TIME BEFORE 12:00 NOON, MARCH 9, 2012, FOR THE
14 PURPOSE OF CONSIDERING VETOES, CORRECTING ERRORS OR
15 OVERSIGHTS, OR TO ADJOURN THE EIGHTY-EIGHTH GENERAL
16 ASSEMBLY AT ANY TIME BEFORE THAT DATE IF THEY
17 DETERMINE THAT THERE IS NO NEED TO RECONVENE; TO
18 PROVIDE THAT IF THE GENERAL ASSEMBLY IS NOT
19 RECONVENED OR ADJOURNED BEFORE 12:00 NOON, MARCH 9,
20 2012, THE FISCAL SESSION OF THE EIGHTY-EIGHTH GENERAL
21 ASSEMBLY IS ADJOURNED SINE DIE ON THAT DATE; AND TO
22 AUTHORIZE ADDITIONAL RECESSES OF EITHER OR BOTH
23 CHAMBERS FOR PERIODS OF FOUR (4) CONSECUTIVE DAYS OR
24 LONGER.

35 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-EIGHTH GENERAL
36 ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:

(a) That the Fiscal Session of the Eighty-Eighth General Assembly of the State of Arkansas shall enter into recess at the close of business in each chamber on March 2, 2012, or at an earlier time as may be agreed upon by the House of Representatives and the Senate;

(b) That under Arkansas Constitution, Article 6, § 15, before adjournment of the General Assembly, the Governor is afforded five (5) days after receipt of a bill to sign a bill or veto a bill; therefore, from March 2, 2012, to March 9, 2012, the House of Representatives and the Senate shall be open so that the office of the Chief Clerk of the House of Representatives and the office of the Secretary of the Senate may receive communications, vetoes of bills by the Governor, and notification of errors and oversights;

(c) That the Speaker of the House of Representatives and the President Pro Tempore of the Senate may, by joint proclamation:

(1) Reconvene the General Assembly at any time before 12:00 noon, March 9, 2012, for the purpose of:

(A) Considering vetoes; or

(B) Correcting errors and oversights; or

(2) Adjourn the Fiscal Session of the Eighty-Eighth General Assembly at any time before 12:00 noon, March 9, 2012, if they determine it is not necessary to reconvene;

(d) That if the General Assembly is not reconvened or adjourned before 12:00 noon, March 9, 2012, the Fiscal Session of the Eighty-Eighth General Assembly is adjourned sine die on that date; and

(e) That during the Fiscal Session, in addition to the recess provided for in subdivision (b), the:

(1) House of Representatives may recess for periods of four (4) consecutive days or longer, by declaration of the Speaker of the House; and

(2) Senate may recess for periods of four (4) consecutive days or longer, by declaration of the President Pro Tempore.
