18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is
21 hereby appropriated, to the Arkansas Northeastern College, to be payable from
22 the General Improvement Fund or its successor fund or fund accounts, for the
23 Arkansas Northeastern College the following:

24 (A) Effective July 1, 2013, the balance of the appropriation provided
25 in Item (A) Section 1 of Act 22 of 2012, for construction of a Nursing and
26 Allied Health building, in a sum not to exceed.....\$1,150,000.

27 (B) Effective July 1, 2013, the balance of the appropriation provided
28 in Item (B) Section 1 of Act 22 of 2012, for deferred maintenance, in a sum
29 not to exceed.....\$240,000.

30 (C) Effective July 1, 2013, the balance of the appropriation provided
31 in Item (C) Section 1 of Act 22 of 2012, for replacement and renewal of
32 equipment and library holdings, in a sum not to exceed.....\$210,000.

33 (D) Effective July 1, 2013, the balance of the appropriation provided
34 in Item (D) Section 1 of Act 22 of 2012, to prevent the loss of funding for
35 personal services, operating expenses and economic development grants to
36 support the continuation of the Arkansas Delta Training and Education

2 (E) Effective July 1, 2013, the balance of the appropriation provided

32 Recommendations and Legislative Recommendations contained in the budget
33 manuals prepared by the Department of Finance and Administration, letters, or
34 summarized oral testimony in the official minutes of the Arkansas Legislative
35 Council or Joint Budget Committee which relate to its passage and adoption.

1 SECTION 29. EMERGENCY CLAUSE. It is found and determined by the
 2 General Assembly, that the Constitution of the State of Arkansas prohibits
 3 the appropriation of funds for more than a one (1) year period; that the
 4 effectiveness of this Act on July 1, 2013 is essential to the operation of
 5 the agency for which the appropriations in this Act are provided, and that in
 6 the event of an extension of the legislative session, the delay in the
 7 effective date of this Act beyond July 1, 2013 could work irreparable harm
 8 upon the proper administration and provision of essential governmental
 9 programs. Therefore, an emergency is hereby declared to exist and this Act
 10 being necessary for the immediate preservation of the public peace, health
 11 and safety shall be in full force and effect from and after July 1, 2013.
