19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 21-6-307(a), concerning sheriffs' fees in
22 civil and criminal cases, is amended to read as follows:

23 (a)(1)(A) The A county sheriff shall charge the following fees shall
24 be charged in a civil case by each of the sheriffs of the several counties of
25 the State of Arkansas:

21 ~~(15)~~ For taking and entering every bail or delivery

23 ~~(16)~~ (x) For attending every a trial of a ~~criminal~~

25 ~~(17)~~ (xi) For serving a subpoena for special

26 jurors..... 20.00

27 (B) Before taking an action under subdivision (a)(1)(A) of

28 this section, a sheriff may require payment of the associated fee.

29 (2)(A) A county sheriff shall charge the following fees in a

30 criminal case:

31 (i) For serving a warrant or order of arrest from a

32 court..... \$50.00

33 (ii) For taking and entering a bail or delivery

34 bond..... 20.00

35 (iii) For attending a trial of a criminal case of

36 confession in open court..... 50.00

2 criminal case shall be included in the judgment for costs under § 16-90-113.
