17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18

19 *SECTION 1. DO NOT CODIFY. Legislative findings.*

20 *The General Assembly of the State of Arkansas finds that:*

21 *(1) Areas of Boone County and Carroll County are cut off from*
22 *public and emergency services by the waters of Table Rock Lake;*

23 *(2) The areas are commonly known as the Backbone Bluff and the*
24 *Cricket Creek Public Use Area;*

25 *(3) Problems associated with the provision of services in these*
26 *areas have existed for several years, but the number of calls for service*
27 *were minimal due to the sparse population of the areas; and*

28 *(4) Changing the boundaries of Boone County and Carroll County*
29 *will address these problems.*
30

31 *SECTION 2. DO NOT CODIFY. The boundaries of Carroll County and Boone*
32 *County are changed as follows:*

33 *(a) Effective January 1, 2014, the western boundary of Boone County,*
34 *Arkansas, is identified as follows: Beginning at the intersection center of*
35 *channel of Table Rock Lake in the North East Quarter of Section 15, Township*
36 *21 North Range 22 West with the Eastern boundary of said Section; thence*



1 meandering West following the center of channel of Table Rock Lake through
2 Section 15 Township 21 North Range 22 West past the Cricket Creek Public Use
3 Area, thence meandering northeasterly following the center of channel of
4 Table Rock Lake through Section 10 Township 21 North Range 22 West, thence
5 meandering northerly following the center of channel of Table Rock Lake
6 through Section 11 Township 21 North Range 22 West, thence meandering
7 northwesterly following the center of channel of Table Rock Lake through
8 Section 10 Township 21 North Range 22 West to a point due south of the center
9 of channel of the strait between Backbone Bluff and the island lying to the
10 west, thence north through the strait to a point in the center of channel of
11 Table Rock Lake, thence meandering easterly following the center of channel
12 of Table Rock Lake through Section 11 Township 21 North Range 22 West to the
13 point of intersection with the Arkansas state and Missouri state boundary.

14 (b) Effective January 1, 2014, the eastern boundary of Carroll County,
15 Arkansas, is identified as follows: Beginning at the intersection center of
16 channel of Table Rock Lake in the North East Quarter of Section 15, Township
17 21 North Range 22 West with the Eastern boundary of said Section; thence
18 meandering West following the center of channel of Table Rock Lake through
19 Section 15 Township 21 North Range 22 West past the Cricket Creek Public Use
20 Area, thence meandering northeasterly following the center of channel of
21 Table Rock Lake through Section 10 Township 21 North Range 22 West, thence
22 meandering northerly following the center of channel of Table Rock Lake
23 through Section 11 Township 21 North Range 22 West, thence meandering
24 northwesterly following the center of channel of Table Rock Lake through
25 Section 10 Township 21 North Range 22 West to a point due south of the center
26 of channel of the strait between Backbone Bluff and the island lying to the
27 west, thence north through the strait to a point in the center of channel of
28 the Table Rock Lake, thence meandering easterly following the center of
29 channel of Table Rock Lake through Section 11 Township 21 North Range 22 West
30 to the point of intersection with the Arkansas state and Missouri state
31 boundary.
