21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. Arkansas Code § 5-11-202(A)(3), concerning membership of
24 the State Parks, Recreation, and Travel Commission, is amended to read as
25 follows:

26 (3) ~~One~~ If one (1) or more commissioners emeriti is designated
27 under § 15-11-203, one (1) or more ~~commissioner emeritus~~ commissioners
28 emeriti.

30 SECTION 2. Arkansas Code § 15-11-203 is amended to read as follows:
31 15-11-203. Commissioner emeritus.

32 (a) ~~Any A~~ person who has shall be known and designated as a
33 "commissioner emeritus" if he or she:

34 (1) Has served, is now serving, or serves in the future as a
35 member for the State Parks, Recreation, and Travel Commission, as established
36 by §§ 15-11-201, 15-11-202, and 15-11-204 – 15-11-207, or its predecessor



1 commissions ~~and who has served or serves;~~

2 (2) Has served for twenty-four (24) years as a member of the
3 commission or its predecessor commissions ~~shall be known and designated as a~~
4 ~~“commissioner emeritus”;~~ and

5 (3) Was known and designated as a "commissioner emeritus" under
6 this section on or before the effective date of this act.

7 (b) A commissioner emeritus shall serve as a member of the commission
8 for the remainder of his or her life ~~and,~~ shall be notified of all commission
9 meetings, and is entitled to the same expenses and other allowances for
10 attending commission meetings as is provided by law for other commission
11 members.

12 ~~(c) The Governor shall cause an appropriate commission to be prepared~~
13 ~~and issued to each commissioner emeritus of the commission. The commissioner~~
14 ~~emeritus shall file the commission with the Secretary of State and take the~~
15 ~~official oath of office before entering upon his or her duties as a~~
16 ~~commissioner emeritus.~~
