10 VOLUNTARY ENHANCED SECURITY DRIVER'S LICENSE AND
11 IDENTIFICATION CARD ACT; TO DECLARE AN EMERGENCY; AND
12 FOR OTHER PURPOSES.

16 TO EXTEND THE EXPIRATION DATE FOR THE
17 ARKANSAS VOLUNTARY ENHANCED SECURITY
18 DRIVER'S LICENSE AND IDENTIFICATION CARD
19 ACT, AND TO DECLARE AN EMERGENCY.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. Arkansas Code § 27-16-1213(a), concerning the expiration of
25 the Arkansas Voluntary Enhanced Security Driver's License and Identification
26 Card Act, is amended to read as follows:

27 (a) This subchapter expires on June 30, ~~2015~~ 2017, or on the date
28 Congress repeals the REAL ID Act of 2005, Pub. L. 109-13, whichever date is
29 earlier.

31 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
32 General Assembly of the State of Arkansas that it is in the interest of
33 Arkansans to continue the issuance of enhanced security driver's licenses and
34 identification cards; that it is sound public policy to extend the expiration
35 of the Arkansas Voluntary Enhanced Security Driver's License and
36 Identification Card Act; and that this act is necessary because without an



1 extension of the expiration date, the Arkansas Voluntary Enhanced Security
2 Driver's License and Identification Card Act will expire on June 30, 2015.
3 Therefore, an emergency is declared to exist, and this act being immediately
4 necessary for the preservation of the public peace, health, and safety shall
5 become effective on:

6 (1) The date of its approval by the Governor;

7 (2) If the bill is neither approved nor vetoed by the Governor,
8 the expiration of the period of time during which the Governor may veto the
9 bill; or

10 (3) If the bill is vetoed by the Governor and the veto is
11 overridden, the date the last house overrides the veto.
