21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. Arkansas Code Title 12, Chapter 27, Subchapter 1, is  
24 amended to add an additional section to read as follows:

25 12-27-148. Confidentiality of emergency preparedness document of the  
26 Department of Community Correction.

27 (a) The following sections of the Department of Community Correction's  
28 official Emergency Preparedness Manual are confidential and shall not be  
29 subject to disclosure under the Freedom of Information Act of 1967, § 25-19-  
30 101 et seq.:

- 31 (1) Command Post Checklist;
- 32 (2) Command Notifications;
- 33 (3) Internal Notifications;
- 34 (4) External Notifications;
- 35 (5) Recall Notifications;
- 36 (6) Family Notifications;



- 1           (7) Tactical Systems;
- 2           (8) Command Structure;
- 3           (9) Emergency Locations;
- 4           (10) Emergency Equipment;
- 5           (11) Emergency Deactivation;
- 6           (12) Emergency Plans;
- 7           (13) Work Stoppage Directive;
- 8           (14) Evacuation Diagrams; and
- 9           (15) Facility Maps, Utility Locations.

10           (b) If a section of the manual described in subsection (a) of this  
11 section becomes part of a criminal investigation, the section is available  
12 for public viewing at the conclusion of the criminal investigation if the  
13 section is not otherwise exempt from disclosure by law.

14           (c) An amendment or addition to a section of the manual described in  
15 subsection (a) of this section shall be reviewed annually by the Charitable,  
16 Penal and Correctional Institutions Subcommittee of the Legislative Council.
