## Subtitle

14 TO AMEND THE LAW CONCERNING THE POWERS OF  
15 A REGIONAL AIRPORT AUTHORITY.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
19

20 SECTION 1. Arkansas Code § 14-362-109(19)(B) and (C), concerning the  
21 powers of a regional airport authority, are amended to read as follows:

22 (B)~~(i)~~ The tolls and fees may be charged and collected  
23 from vehicles accessing or departing from the airport, and the authority is  
24 empowered to make reasonable tolls and fees in accordance with industry  
25 standards and to make reasonable classifications of vehicles for this  
26 purpose.

27 ~~(ii)(a) The tolls or fees levied for use of airport~~  
28 ~~roads by private off facility parking services at an airport located in a~~  
29 ~~county with a population of at least three hundred sixty thousand (360,000)~~  
30 ~~and in a city with a population of at least one hundred seventy five thousand~~  
31 ~~(175,000) according to the most recent federal decennial census shall not~~  
32 ~~exceed the local sales tax rate of the municipality in which the airport is~~  
33 ~~located.~~

34 ~~(b) Private off facility parking services~~  
35 ~~shall have full access to drop off and pick up airport passengers and the~~  
36 ~~same queuing access as all commercial shuttles, limos, taxi cabs, airport-~~



1 ~~owned vans or buses, and valet services.~~

2                   (C) ~~For an airport located in a county with a population~~  
3 ~~of at least three hundred sixty thousand (360,000) and in a city with a~~  
4 ~~population of at least one hundred seventy five thousand (175,000) according~~  
5 ~~to the most recent federal decennial census, The tolls and fees fixed by the~~  
6 authority shall not be subject to supervision or regulation by any other  
7 commission, board, bureau, or agency of the State of Arkansas;
