25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

27 SECTION 1. Arkansas Code Title 17 is amended to add an additional
28 chapter to read as follows:

CHAPTER 2

30

FRESH START ACT OF 2019

31

32 17-2-101. Title.

33 This chapter shall be known and may be cited as the "Fresh Start Act of
34 2019".

35

36 17-2-102. Purpose.



1 The purpose of this chapter is to help individuals with criminal
2 records reenter and move to the workforce and stay out of prison.

3
4 17-2-103. Definitions.

5 As used in this chapter:

6 (1) "Criminal record" means any type of felony or misdemeanor
7 conviction;

8 (2) "Licensing entity" means an office, board, commission,
9 department, council, bureau, or other agency of state government having
10 authority to license, certify, register, permit, or otherwise authorize an
11 individual to engage in a particular occupation or profession; and

12 (3) "Licensure" means a license, certificate, registration,
13 permit, or other form of authorization required by law or rule that is
14 required for an individual to engage in a particular occupation or
15 profession.

16
17 17-2-104. Anti-discrimination.

18 An individual shall not be disqualified from pursuing, practicing, or
19 engaging in any occupation or profession for which licensure is required
20 solely or in part because of a prior conviction of a crime, unless the crime
21 for which the individual was convicted directly relates to the duties and
22 responsibilities of the occupation or profession.

23
24 17-2-105. Required revision of licensing restrictions based on
25 criminal records.

26 (a)(1) On or before one hundred twenty (120) days of the effective
27 date of this chapter, a licensing entity shall revise existing rules
28 concerning licensure to explicitly list the specific criminal convictions
29 that could disqualify an applicant from receiving licensure for a particular
30 occupation or profession.

31 (2) A licensing entity shall not, as a basis upon which
32 licensure may be granted or in any rule that the licensing entity
33 promulgates:

34 (A) Use vague or generic terms, including without
35 limitation the phrase "moral turpitude" and "good character"; or

36 (B) Consider arrests without a subsequent conviction.

1 (3) In its rulemaking, a licensing entity shall list only
2 disqualifying criminal records that are specific and directly related to the
3 duties and responsibilities for the occupation or profession.

4 (b)(1) A licensing entity shall use the preponderance of the evidence
5 standard of proof in examining the factors to determine whether an applicant
6 with a disqualifying criminal conviction will be denied licensure.

7 (2) A licensing entity shall make a determination under
8 subdivision (b)(1) of this section based on the following factors:

9 (A) The nature and seriousness of the offense for which
10 the individual was convicted;

11 (B) The passage of time since the commission of the
12 offense;

13 (C) The relationship of the offense to the ability,
14 capacity, and fitness required to perform the duties and discharge the
15 responsibilities of the occupation or profession; and

16 (D) Any evidence of rehabilitation or treatment undertaken
17 by the individual that might mitigate against a direct relationship between
18 an element of the offense for which an applicant was convicted and a
19 responsibility inherent to the particular occupation or profession.

20 (c)(1) Notwithstanding any other law, if an individual has a valid
21 criminal conviction for an offense that could disqualify the individual from
22 receiving licensure, the disqualification shall not be considered for more
23 than five (5) years from the date of the conviction if the individual:

24 (A) Was not convicted of an offense that was violent or
25 sexual in the nature offense;

26 (B) Was not convicted more than one (1) time for any
27 felony offense and does not have a background that gives reason to believe
28 that he or she might pose a grave, serious, or substantial risk concerning
29 public safety that gives cause for denying licensure; or

30 (C) Has not been convicted of any other offense during the
31 five-year disqualification period.

32 (2)(A) The potential disqualification period may last longer if
33 an applicant with a disqualifying criminal conviction was incarcerated for an
34 offense that was not violent or sexual in nature at any time during the
35 previous five (5) years.

36 (B) If the disqualification period lasts longer than the

1 period specified under subdivision (c)(2)(A) of this section, the
2 disqualification shall last no longer than five (5) years from the date that
3 the individual was released from incarceration.

4 (d) Subsections (a), (b), and (c) shall apply to any new occupational
5 licensure created after the effective date of this chapter.

6
7 17-2-106. Petition for review of licensing entity decisions.

8 (a)(1) An individual with a criminal record may petition a licensing
9 entity at any time for a determination of whether the criminal record of the
10 individual will disqualify the individual from licensure.

11 (2) The petition shall include details on the criminal record of
12 the individual.

13 (3) The licensing entity shall inform the individual of his or
14 her standing within thirty (30) days of receiving the petition from the
15 applicant.

16 (4) The licensing entity may charge a fee to recoup costs
17 associated with the petition not to exceed twenty-five dollars (\$25.00) for
18 each petition.

19 (b) If a licensing entity denies an individual licensure solely or in
20 part because of a prior conviction of an offense by the individual, the
21 licensing entity shall notify the individual in writing of the following:

22 (1) The grounds and reasons for the denial or disqualification;

23 (2) The rights of the individual to a hearing to challenge the
24 decision of the licensing entity;

25 (3) The earliest date that the individual may reapply for
26 licensure; and

27 (4) The fact that evidence of rehabilitation may be considered
28 upon reapplication.

29 (c) A licensing entity shall document a determination that a criminal
30 conviction of an applicant is specifically listed as a disqualifying
31 conviction and is directly related to the duties and responsibilities of the
32 occupation or profession in written findings for each of the factors listed
33 in § 17-2-105(b) by a preponderance of the evidence sufficient for a
34 reviewing court.

35 (d) In an administrative hearing or civil litigation, the licensing
36 entity shall carry the burden of proof regarding whether the criminal

1 conviction directly relates to the occupation or profession for which
2 licensure is sought.

3
4 17-2-107. Construction.

5 This chapter applies to all occupations or professions except for peace
6 officers and other law enforcement personnel.

7
8 17-2-108. Rules.

9 (a) A licensing entity shall adopt necessary rules for the
10 implementation of this chapter.

11 (b)(1) When adopting the initial rules to implement this chapter, the
12 final rule shall be filed with the Secretary of State for adoption under §
13 25-15-204(f):

14 (A) On or before January 1, 2020; or

15 (B) If approval under § 10-3-309 has not occurred by
16 January 1, 2020, as soon as practicable after approval under § 10-3-309.

17 (2) A licensing entity shall file the proposed rule with the
18 Legislative Council under § 10-3-309(c) sufficiently in advance of January 1,
19 2020, so that the Legislative Council may consider the rule for approval
20 before January 1, 2020.

21
22 SECTION 2. Arkansas Code § 17-11-302(b), concerning application and
23 certificate of registration to become a registered abstractor, is amended to
24 read as follows:

25 (b) The application shall be in a form prepared by the board and
26 shall contain such information as may be necessary to assist the board in
27 registration ~~and to determine if the applicant is of good moral character.~~

29 SECTION 3. Arkansas Code § 17-11-304(a), concerning issuance or
30 reapplication of a certificate of registration by the Arkansas Abstracters'
31 Board, is amended to read as follows:

32 (a) If the applicant satisfactorily passes the examinations ~~and is of~~
33 ~~good moral character~~, the applicant shall be certified as a registered
34 abstractor, and the certificate provided for shall be issued to him or her.
35 The privileges granted by the certificate shall continue unless revoked, as
36 provided in this chapter, or unless the certificate is otherwise surrendered

35 SECTION 174. Arkansas Code § 17-105-114 is amended to add an
36 additional subdivision to read as follows:

1 17-105-114. *Disciplinary authority.*

2 Upon finding that a physician assistant has committed any offense
3 described in § 17-105-113 or a felony listed as required under § 17-2-
4 105(a)(1), the Arkansas State Medical Board may:

5 (1) Refuse to grant a license;

6 (2) Administer a public or private reprimand;

7 (3) Revoke, suspend, limit, or otherwise restrict a license;

8 (4) Require a physician assistant to submit to the care,
9 counseling, or treatment of a physician or physicians designated by the
10 board;

11 (5) Suspend enforcement of its finding thereof and place the
12 physician assistant on probation with the right to vacate the probationary
13 order for noncompliance; or

14 (6) Restore or reissue, at its discretion, a license and impose
15 any disciplinary or corrective measure which it may have imposed.

23 SECTION 176. Arkansas Code § 17-107-310, concerning the disciplinary
24 authority of a license for an orthotist, prosthetist, and pedorthist, is
25 amended to add an additional subdivision to read as follows:

26 (14) Has committed a felony listed as required under § 17-2-
27 105(a)(1).

29 SECTION 177. EMERGENCY CLAUSE. It is found and determined by the
30 General Assembly of the State of Arkansas that there is a shortage of certain
31 occupations or professions in certain parts of the State of Arkansas; that
32 individuals with criminal records cannot obtain licenses in certain
33 occupations or professions despite the shortages; that the inability of
34 individuals with criminal records to obtain licenses is increasing recidivism
35 in the State of Arkansas; that this act requires that the licensing entities
36 make certain administrative rules requiring licenses that would impact

1 individuals with criminal records; and that this act is immediately necessary
2 to ensure that individuals have certainty that they will be able to obtain
3 licenses before entering occupational programs or schools in the fall of this
4 year, to decrease the shortages of certain occupations or professions, to
5 reduce recidivism in the State of Arkansas, and to allow licensing entities
6 to make administrative rules at the earliest possible date to ensure
7 certainty in the requirements of licenses. Therefore, an emergency is
8 declared to exist, and this act being immediately necessary for the
9 preservation of the public peace, health, and safety shall become effective
10 on:

11 (1) The date of its approval by the Governor;

12 (2) If the bill is neither approved nor vetoed by the Governor,
13 the expiration of the period of time during which the Governor may veto the
14 bill; or

15 (3) If the bill is vetoed by the Governor and the veto is
16 overridden, the date the last house overrides the veto.
