## For An Act To Be Entitled

9 AN ACT CONCERNING THE ARKANSAS FUTURE GRANT PROGRAM;  
10 TO AMEND ELIGIBLE PROGRAMS OF STUDY FOR A STUDENT WHO  
11 RECEIVES AN ARKANSAS FUTURE GRANT; TO AMEND THE  
12 PROVISION RELATED TO THE MENTORING OF A STUDENT WHO  
13 RECEIVES AN ARKANSAS FUTURE GRANT; AND TO AMEND THE  
14 PROVISION REGARDING REQUIRED COMMUNITY SERVICE HOURS  
15 FOR A STUDENT WHO RECEIVES AN ARKANSAS FUTURE GRANT;  
16 AND FOR OTHER PURPOSES.

20 TO AMEND ELIGIBLE PROGRAMS OF STUDY FOR A  
21 STUDENT WHO RECEIVES AN ARKANSAS FUTURE  
22 GRANT; TO AMEND THE PROVISION RELATED TO  
23 THE MENTORING OF A STUDENT; AND TO AMEND  
24 THE PROVISION REGARDING REQUIRED  
25 COMMUNITY SERVICE HOURS.

28 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
29

30 SECTION 1. Arkansas Code § 6-82-1802(b)(2), concerning eligibility  
31 requirements for an Arkansas Future Grant, is amended to read as follows:

32 (2) Is enrolled part-time or full-time at an approved  
33 institution of higher education in a program of study that leads to an  
34 associate degree or a certification in a:

35 (A) Science, technology, engineering, accounting, finance,  
36 nursing, education, or mathematics field, including without limitation



1 computer science, information technology, data analysis, or graphic design;

3 (B) Regional high-demand field; ~~and~~ or

4 (C) State high-demand field; and

6 SECTION 2. Arkansas Code § 6-82-1804(a)(1)(B)(ii), concerning monthly  
7 mentoring for a student who receives an Arkansas Future Grant, is amended to  
8 read as follows:

9 (ii) Certify to the Department of Higher Education  
10 that at least one (1) time each ~~calendar month~~ semester the mentor has  
11 provided mentoring services by telephone, email, or in person to each student  
12 he or she is mentoring;

13  
14 SECTION 3. Arkansas Code § 6-82-1804(a)(2)(A), concerning community  
15 service requirements for a student who receives an Arkansas Future Grant, is  
16 amended to read as follows:

17 (2)(A) Complete at least ~~fifteen (15)~~ ten (10) hours of  
18 community service each semester the student receives a grant.
