8 AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
9 IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF
10 HIGHER EDUCATION; AND FOR OTHER PURPOSES.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
21 DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the Arkansas
22 State University, to be payable from the Development and Enhancement Fund,
23 for the Arkansas State University the following:

24 (A) Effective July 1, 2020, the balance of the appropriation provided
25 in Item (A) of Section 1 of Act 351 of 2019, for construction, renovation,
26 maintenance, equipment, personal services and operating expenses of the
27 various institutions and entities of the Arkansas State University System, in
28 a sum not to exceed\$15,000,000.

29 (B) Effective July 1, 2020, the balance of the appropriation provided
30 in Item (B) of Section 1 of Act 351 of 2019, for information technology
31 infrastructure upgrades and security, in a sum not to exceed\$3,193,448.

32 (C) Effective July 1, 2020, the balance of the appropriation provided
33 in Item (C) of Section 1 of Act 351 of 2019, for costs of construction of a
34 College of Engineering building, in a sum not to exceed\$1,093,847.

35 (D) Effective July 1, 2020, the balance of the appropriation provided
36 in Item (D) of Section 1 of Act 351 of 2019, for College of Education and



1 Communications restrooms renovation, in a sum not to exceed\$1,090,000.

2 (E) Effective July 1, 2020, the balance of the appropriation provided
3 in Item (E) of Section 1 of Act 351 of 2019, for Library HVAC system
4 renovation and modernization, in a sum not to exceed\$2,822,705.

5 (F) Effective July 1, 2020, the balance of the appropriation provided
6 in Item (F) of Section 1 of Act 351 of 2019, for critical maintenance, in a
7 sum not to exceed\$670,000.

8 (G) Effective July 1, 2020, the balance of the appropriation provided
9 in Item (G) of Section 1 of Act 351 of 2019, for deferred maintenance, in a
10 sum not to exceed\$2,720,000.

11 (H) Effective July 1, 2020, the balance of the appropriation provided
12 in Item (H) of Section 1 of Act 351 of 2019, for the purchase, replacement,
13 and renewal of equipment and library holdings, in a sum not to exceed
14\$2,962,756.

15 (I) Effective July 1, 2020, the balance of the appropriation provided
16 in Item (I) of Section 1 of Act 351 of 2019, for maintenance of the
17 facilities of the Arkansas State University System, in a sum not to exceed
18\$15,000,000.

19
20 SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
21 DYESS COLONY RURAL LIFE RESEARCH CENTER. There is hereby appropriated, to
22 the Arkansas State University, to be payable from the Arkansas Natural and
23 Cultural Resources Grant and Trust Fund, for the Arkansas State University
24 the following:

25 (A) Effective July 1, 2020, the balance of the appropriation provided
26 in Section 25 of Act 902 of 2019, for the acquisition, management,
27 stewardship or preservation of state owned lands, historic sites, buildings,
28 structures or objects, in a sum not to exceed\$512,050.

29
30 SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
31 PFEIFFER FARMSTEAD - PHASE 1. There is hereby appropriated, to the Arkansas
32 State University, to be payable from the Arkansas Natural and Cultural
33 Resources Grant and Trust Fund, for the Arkansas State University the
34 following:

35 (A) Effective July 1, 2020, the balance of the appropriation provided
36 in Section 25 of Act 902 of 2019, for the acquisition, management,

1 stewardship or preservation of state owned lands, historic sites, buildings,
2 structures or objects, in a sum not to exceed\$126,000.

3

4 SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
5 SUSTAINABLE BUILDING DESIGN. There is hereby appropriated, to the Arkansas
6 State University, to be payable from the Sustainable Building Design
7 Revolving Loan Fund, for the Arkansas State University the following:

8 (A) Effective July 1, 2020, the balance of the appropriation provided
9 in Item (A) of Section 4 of Act 277 of 2019, for construction, renovation,
10 maintenance and operating expenses, in a sum not to exceed\$171,957.

11

12 SECTION 5. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - DEVELOPMENT AND
13 ENHANCEMENT. There is hereby appropriated, to the Arkansas Tech University,
14 to be payable from the Development and Enhancement Fund, for the Arkansas
15 Tech University the following:

16 (A) Effective July 1, 2020, the balance of the appropriation provided
17 in Item (A) of Section 2 of Act 351 of 2019, for construction, renovation,
18 maintenance, equipment, personal services and operating expenses of the
19 various institutions and entities of the Arkansas Tech University, in a sum
20 not to exceed\$15,000,000.

21 (B) Effective July 1, 2020, the balance of the appropriation provided
22 in Item (B) of Section 2 of Act 351 of 2019, for costs of construction of a
23 Student Union, in a sum not to exceed\$3,500,000.

24 (C) Effective July 1, 2020, the balance of the appropriation provided
25 in Item (C) of Section 2 of Act 351 of 2019, for costs of construction of an
26 O Street and Campus Entrance, in a sum not to exceed\$1,928,302.

27 (D) Effective July 1, 2020, the balance of the appropriation provided
28 in Item (D) of Section 2 of Act 351 of 2019, for renovation for Brown
29 building academic utilization, in a sum not to exceed\$1,180,438.

30 (E) Effective July 1, 2020, the balance of the appropriation provided
31 in Item (E) of Section 2 of Act 351 of 2019, for costs of land purchase, in a
32 sum not to exceed\$555,600.

33 (F) Effective July 1, 2020, the balance of the appropriation provided
34 in Item (F) of Section 2 of Act 351 of 2019, for renovation of campus signage
35 to be ADA compliant, in a sum not to exceed\$1,035,660.

36 (G) Effective July 1, 2020, the balance of the appropriation provided

1 in Item (G) of Section 2 of Act 351 of 2019, for critical maintenance, in a
2 sum not to exceed\$1,150,000.

3 (H) Effective July 1, 2020, the balance of the appropriation provided
4 in Item (H) of Section 2 of Act 351 of 2019, for deferred maintenance, in a
5 sum not to exceed\$2,460,000.

6 (I) Effective July 1, 2020, the balance of the appropriation provided
7 in Item (I) of Section 2 of Act 351 of 2019, for the purchase, replacement,

9\$1,394,203.

10 (J) Effective July 1, 2020, the balance of the appropriation provided

13 (K) Effective July 1, 2020, the balance of the appropriation provided

16 (L) Effective July 1, 2020, the balance of the appropriation provided

19 (M) Effective July 1, 2020, the balance of the appropriation provided

29 University, to be payable from the Development and Enhancement Fund, for the
30 Henderson State University the following:

31 (A) Effective July 1, 2020, the balance of the appropriation provided
32 in Item (A) of Section 3 of Act 351 of 2019, for technology infrastructure
33 upgrades, in a sum not to exceed\$476,000.

34 (B) Effective July 1, 2020, the balance of the appropriation provided
35 in Item (B) of Section 3 of Act 351 of 2019, for renovation of the Russell
36 Fine Arts Building, in a sum not to exceed\$6,610,000.

1 (C) Effective July 1, 2020, the balance of the appropriation provided
2 in Item (C) of Section 3 of Act 351 of 2019, for renovation of Mooney Hall,
3 in a sum not to exceed\$114,000.

4 (D) Effective July 1, 2020, the balance of the appropriation provided

7 (E) Effective July 1, 2020, the balance of the appropriation provided

16 AND ENHANCEMENT. There is hereby appropriated, to the Southern Arkansas
17 University, to be payable from the Development and Enhancement Fund, for the
18 Southern Arkansas University the following:

19 (A) Effective July 1, 2020, the balance of the appropriation provided
20 in Item (A) of Section 4 of Act 351 of 2019, for costs of HVAC replacement
21 and upgrades, in a sum not to exceed\$3,783,000.

22 (B) Effective July 1, 2020, the balance of the appropriation provided
23 in Item (B) of Section 4 of Act 351 of 2019, for technology infrastructure
24 improvements and upgrades, in a sum not to exceed\$3,000,000.

25 (C) Effective July 1, 2020, the balance of the appropriation provided
26 in Item (C) of Section 4 of Act 351 of 2019, for renovation of Childs Hall
27 and ADA upgrades to create the Science, Technology, Engineering and
28 Mathematics Training Center, in a sum not to exceed\$277,000.

13 Development and Enhancement Fund, for the University of Arkansas for Medical
14 Sciences the following:

15 (A) Effective July 1, 2020, the balance of the appropriation provided
16 in Item (A) of Section 5 of Act 351 of 2019, for information technology
17 infrastructure and cybersecurity with classroom technology upgrade, in a sum
18 not to exceed\$5,455,000.

19 (B) Effective July 1, 2020, the balance of the appropriation provided
20 in Item (B) of Section 5 of Act 351 of 2019, for costs of construction of
21 Pine and Cedar Street modification and enhancement, in a sum not to exceed
22\$2,745,000.

23 (C) Effective July 1, 2020, the balance of the appropriation provided
24 in Item (C) of Section 5 of Act 351 of 2019, for critical maintenance, in a
25 sum not to exceed\$6,710,000.

26 (D) Effective July 1, 2020, the balance of the appropriation provided

8 general operating expenses, construction, renovation, maintenance, critical
9 maintenance, equipment, security enhancements, technology upgrades/equipment

3 the University of Arkansas, to be payable from the Arkansas Natural and
4 Cultural Resources Grant and Trust Fund, for the University of Arkansas the
5 following:

6 (A) Effective July 1, 2020, the balance of the appropriation provided

22 SECTION 16. REAPPROPRIATION - UNIVERSITY OF ARKANSAS AT LITTLE ROCK -
23 DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the University
24 of Arkansas at Little Rock, to be payable from the Development and
25 Enhancement Fund, for the University of Arkansas at Little Rock the
26 following:

27 (A) Effective July 1, 2020, the balance of the appropriation provided
28 in Item (A) of Section 16 of Act 277 of 2019, for construction, renovation,
29 maintenance, critical maintenance, equipment, security enhancements,
30 technology upgrades/equipment and library resources, in a sum not to exceed
31\$1,263.

32 (B) Effective July 1, 2020, the balance of the appropriation provided
33 in Item (B) of Section 16 of Act 277 of 2019, for improvements to technology
34 infrastructure, in a sum not to exceed\$9,301.

35 (C) Effective July 1, 2020, the balance of the appropriation provided
36 in Item (A) of Section 7 of Act 351 of 2019, for costs of replacing building

1 infrastructure and performing critical maintenance, in a sum not to exceed
2\$1,000,000.

3 (D) Effective July 1, 2020, the balance of the appropriation provided
4 in Item (B) of Section 7 of Act 351 of 2019, for construction costs to
5 complete the Nanotechnology Center, in a sum not to exceed\$3,200,000.

6 (E) Effective July 1, 2020, the balance of the appropriation provided
7 in Item (C) of Section 7 of Act 351 of 2019, for improvements to technology
8 infrastructure, in a sum not to exceed\$4,000,000.

9 (F) Effective July 1, 2020, the balance of the appropriation provided

22 the University of Arkansas at Little Rock, to be payable from the Arkansas
23 Natural and Cultural Resources Grant and Trust Fund, for the University of
24 Arkansas at Little Rock the following:

25 (A) Effective July 1, 2020, the balance of the appropriation provided
26 in Section 25 of Act 902 of 2019, for the acquisition, management,
27 stewardship or preservation of state owned lands, historic sites, buildings,
28 structures or objects, in a sum not to exceed\$71,927.

29

30 SECTION 18. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO -
31 DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the University
32 of Arkansas at Monticello, to be payable from the Development and Enhancement
33 Fund, for the University of Arkansas at Monticello the following:

34 (A) Effective July 1, 2020, the balance of the appropriation provided
35 in Item (A) of Section 18 of Act 277 of 2019, for grants to cities, counties,
36 planning and development districts, and other eligible entities for land

1 acquisition, improvements, construction, renovation, major maintenance, and
2 purchase of equipment, industrial site development costs including
3 construction, renovation, and equipment acquisition, development of
4 intermodal facilities, including port and waterway projects, rail spur
5 construction and road and highway improvements, environmental mitigation
6 projects, and construction and improvement of water and sewer systems, in a
7 sum not to exceed\$20,500.

8 (B) Effective July 1, 2020, the balance of the appropriation provided
9 in Item (B) of Section 18 of Act 277 of 2019, for wireless access point and
10 controller expenses, in a sum not to exceed\$144,000.

11 (C) Effective July 1, 2020, the balance of the appropriation provided
12 in Item (A) of Section 8 of Act 351 of 2019, for costs of construction of a
13 Math and Science Center, in a sum not to exceed\$4,950,000.

14 (D) Effective July 1, 2020, the balance of the appropriation provided
15 in Item (B) of Section 8 of Act 351 of 2019, for renovation of the Fine Arts
16 Center, in a sum not to exceed\$500,000.

17 (E) Effective July 1, 2020, the balance of the appropriation provided

16 of Arkansas at Pine Bluff, to be payable from the Development and Enhancement
17 Fund, for the University of Arkansas at Pine Bluff the following:

18 (A) Effective July 1, 2020, the balance of the appropriation provided
19 in Item (A) of Section 19 of Act 277 of 2019, for matching funds for the 1890
20 Research and Extension Programs, in a sum not to exceed\$144,000.

21 (B) Effective July 1, 2020, the balance of the appropriation provided
22 in Item (B) of Section 19 of Act 277 of 2019, for matching funds for the 1890
23 Research and Extension Programs, in a sum not to exceed\$700,000.

24 (C) Effective July 1, 2020, the balance of the appropriation provided
25 in Item (A) of Section 9 of Act 351 of 2019, for costs of campus renovations
26 and repair, in a sum not to exceed\$3,000,000.

27 (D) Effective July 1, 2020, the balance of the appropriation provided
28 in Item (B) of Section 9 of Act 351 of 2019, for costs of construction of a
29 Nanotechnology/Biotechnology Center, in a sum not to exceed\$2,000,000.

30 (E) Effective July 1, 2020, the balance of the appropriation provided
31 in Item (C) of Section 9 of Act 351 of 2019, for costs of construction of a
32 Life Sciences facility, in a sum not to exceed\$1,200,000.

33 (F) Effective July 1, 2020, the balance of the appropriation provided

10 of Central Arkansas, to be payable from the Development and Enhancement Fund,
11 for the University of Central Arkansas the following:

12 (A) Effective July 1, 2020, the balance of the appropriation provided
13 in Item (A) of Section 11 of Act 351 of 2019, for costs of construction of a
14 College of Fine Arts and Communication building, in a sum not to exceed
15\$2,100,000.

16 (B) Effective July 1, 2020, the balance of the appropriation provided
17 in Item (B) of Section 11 of Act 351 of 2019, for costs of construction of a
18 Health Sciences building, in a sum not to exceed\$2,100,000.

19 (C) Effective July 1, 2020, the balance of the appropriation provided
20 in Item (C) of Section 11 of Act 351 of 2019, for costs of construction for
21 an addition to, renovation of, and equipment for the Lewis Science Center, in
22 a sum not to exceed\$4,000,000.

23 (D) Effective July 1, 2020, the balance of the appropriation provided
24 in Item (D) of Section 11 of Act 351 of 2019, for critical maintenance, in a
25 sum not to exceed\$1,000,000.

26 (E) Effective July 1, 2020, the balance of the appropriation provided
27 in Item (E) of Section 11 of Act 351 of 2019, for deferred maintenance, in a
28 sum not to exceed\$3,620,000.

29 (F) Effective July 1, 2020, the balance of the appropriation provided
30 in Item (F) of Section 11 of Act 351 of 2019, for the purchase, replacement,
31 and renewal of equipment and library holdings, in a sum not to exceed
32\$2,051,543.

33
34 SECTION 21. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
35 obligations otherwise incurred in relation to the project or projects
36 described herein in excess of the State Treasury funds actually available

1 therefor as provided by law. Provided, however, that institutions and
2 agencies listed herein shall have the authority to accept and use grants and
3 donations including Federal funds, and to use its unobligated cash income or
4 funds, or both available to it, for the purpose of supplementing the State
5 Treasury funds for financing the entire costs of the project or projects
6 enumerated herein. Provided further, that the appropriations and funds
7 otherwise provided by the General Assembly for Maintenance and General
8 Operations of the agency or institutions receiving appropriation herein shall
9 not be used for any of the purposes as appropriated in this act.

10 (B) The restrictions of any applicable provisions of the State
11 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
12 Revenue Stabilization Law and any other applicable fiscal control laws of
13 this State and regulations promulgated by the Department of Finance and
14 Administration, as authorized by law, shall be strictly complied with in
15 disbursement of any funds provided by this act unless specifically provided
16 otherwise by law.

17
18 SECTION 22. LEGISLATIVE INTENT. It is the intent of the General
19 Assembly that any funds disbursed under the authority of the appropriations
20 contained in this act shall be in compliance with the stated reasons for
21 which this act was adopted, as evidenced by the Agency Requests, Executive
22 Recommendations and Legislative Recommendations contained in the budget
23 manuals prepared by the Department of Finance and Administration, letters, or
24 summarized oral testimony in the official minutes of the Arkansas Legislative
25 Council or Joint Budget Committee which relate to its passage and adoption.

26
27 SECTION 23. EMERGENCY CLAUSE. It is found and determined by the
28 General Assembly, that the Constitution of the State of Arkansas prohibits
29 the appropriation of funds for more than a one (1) year period; that the
30 effectiveness of this Act on July 1, 2020 is essential to the operation of
31 the agency for which the appropriations in this Act are provided, and that in
32 the event of an extension of the legislative session, the delay in the
33 effective date of this Act beyond July 1, 2020 could work irreparable harm
34 upon the proper administration and provision of essential governmental
35 programs. Therefore, an emergency is hereby declared to exist and this Act
36 being necessary for the immediate preservation of the public peace, health

and safety shall be in full force and effect from and after July 1, 2020.
