18 TO ALLOW THE SECRETARY OF THE DEPARTMENT
19 OF FINANCE AND ADMINISTRATION TO APPOINT
20 THE DIRECTOR OF THE ASSESSMENT

26 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

28 SECTION 1. Arkansas Code § 25-28-101(b), concerning the creation of
29 the Assessment Coordination Division and the appointment of the Director of
30 the Assessment Coordination Division and other personnel, is amended to read
31 as follows:

32 (b)(1) The executive head of the Assessment Coordination Division
33 ~~shall be~~ is the Director of the Assessment Coordination Division.

34 (2) The director shall be appointed by the Governor, ~~subject to~~
35 ~~confirmation by the Senate, and shall serve at the pleasure of the Governor.~~

36 ~~(3) The director shall report to the Secretary of the Department~~



1 of Finance and Administration and shall report to the secretary.

3 SECTION 2. Arkansas Code § 25-28-107 is amended to read as follows:
4 25-28-107. Requirements of Director of the Assessment Coordination
5 Division.

6 (a) The Director of the Assessment Coordination Division shall meet
7 the qualifications required for certification or licensure as a Level 4
8 Appraiser in Arkansas, provided that the formal course work was or is
9 satisfactorily completed in another state.

10 (b) At the time of appointing the director, the ~~Governor~~ Secretary of
11 the Department of Finance and Administration shall include in the appointment
12 document a statement that the appointee meets the qualifications prescribed
13 by law.
