SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD — ELECTION EXPENSES. At the close of the fiscal year ending June 30, 2021 2022, any unexpended balance of monies provided for Election Expenses, shall be transferred forward and made available for the same purpose for the

SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 3 4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 5 OF FUNDS. If the State Board of Election Commissioners is required to pay the 6 expenses for any state supported preferential primary election, general 7 primary election, nonpartisan general election, statewide special election or 8 special primary election and funds are not available to pay for such 9 elections, the Director of the State Board of Election Commissioners shall 10 certify to the Chief Fiscal Officer of the State the amount needed to pay the 11 expenses of the election(s). Upon the approval of the Chief Fiscal Officer of 12 the State, the amount certified shall be transferred from the Budget 13 Stabilization Trust Fund to the Miscellaneous Agencies Fund Account of the 14 State Board of Election Commissioners. All unused funds transferred under 15 this provision shall be transferred back to the Budget Stabilization Trust 16 Fund at the end of each fiscal year. The Chief Fiscal Officer of the State 17 shall initiate the necessary transfer documents to reflect all such transfers 18 upon the fiscal records of the State Auditor, the State Treasurer and the 19 Chief Fiscal Officer of the State. 20 The provisions of this section shall be in effect from July 1, 2020 2021

SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive

Ţ	Recommendations and Legislative Recommendations contained in the budget
2	manuals prepared by the Department of Finance and Administration, letters, or
3	summarized oral testimony in the official minutes of the Arkansas Legislative
4	Council or Joint Budget Committee which relate to its passage and adoption.
5	
6	SECTION 10. EMERGENCY CLAUSE. It is found and determined by the
7	General Assembly, that the Constitution of the State of Arkansas prohibits
8	the appropriation of funds for more than a one (1) year period; that the
9	effectiveness of this Act on July 1, 2021 is essential to the operation of
10	the agency for which the appropriations in this Act are provided, and that in
11	the event of an extension of the legislative session, the delay in the
12	effective date of this Act beyond July 1, 2021 could work irreparable harm
13	upon the proper administration and provision of essential governmental
14	programs. Therefore, an emergency is hereby declared to exist and this Act
15	being necessary for the immediate preservation of the public peace, health
16	and safety shall be in full force and effect from and after July 1, 2021.
