26	SECTION 2. DO N	OT CODIFY. <u>Legislative findings.</u>		
27	The General Assembly finds that:			
28	<u>(1) This</u>	act would benefit many public school	employees in this

31	covered by the Arkansas Teacher Retirement System may benefit from provisions

33	<u>(3) The p</u>	ossibility of a member of the 93rd G	eneral Assembly

5	SECTION 3. DO NOT CODIFY. <u>Arkansas Teacher Retirement System —</u>
6	Voluntary retirement — Active members employed by a covered employer during
7	the 2020-2021 school year.
8	(a) Except as provided under § 24-7-701(a)(2), an active member of the
9	Arkansas Teacher Retirement System may voluntarily retire upon written
10	application filed with the system if the member:
11	(1) Has twenty-seven (27) years of credited service in the
12	system regardless of the member's age; and
13	(2) Was employed by a covered employer during the 2020-2021
14	school year.
15	(b) Subsection (a) of this section shall not apply to a member of the
16	93rd General Assembly.
