27 BOARD OF BARBER EXAMINERS - APPLICANT PROXIMITY TO EXISTING BARBER COLLEGES.
28 Notwithstanding any other provisions under Arkansas Law, the State Board of
29 Barber Examiners shall not deny any application for the establishment of a
30 new barber college on the basis of geographic proximity to an existing barber
31 college.

32 The provisions of this section shall be in effect only from July 1, ~~2020~~
33 2021 through June 30, ~~2021~~ 2022.

34

35 SECTION 56. SPECIAL LANGUAGE - CODE AMENDMENT. Arkansas Code § 17-24-
36 305(b), concerning licensing fees and the disposition of licensing fees by

1 the State Board of Collection Agencies, is amended to read as follows:

2 (b)(1) All income from fees imposed under this section shall be distributed
3 in the form of one (1) annual payment that is a percentage of the total funds
4 available up to the maximum authorized under this subsection.

5 (2) However, if less than one hundred percent (100%) of the total
6 allocation is available for distribution, all allocations listed in
7 subdivisions (b)(3)(A)-~~(H)~~ (I) of this section shall be funded at a prorated
8 percentage consistent with the available funds, not to exceed the maximum
9 amounts listed in subdivisions (b)(3)(A)-~~(H)~~ (I) of this section.

10 (3) Beginning July 1, 2013, and each fiscal year thereafter, the board
11 shall remit to:

12 (A) The Treasurer of State for the Division of Medical Services
13 of the Department of Human Services, an amount not to exceed one hundred
14 fifteen thousand dollars (\$115,000) for deposit into a paying account as
15 determined by the Chief Fiscal Officer of the State to be used in accordance
16 with § 20-10-705;

17 (B) The University of Arkansas for Medical Sciences, an amount
18 not to exceed six hundred thousand dollars (\$600,000) for deposit into a
19 financial institution in accordance with the policies of the University of
20 Arkansas for Medical Sciences to be expended for the College of Pharmacy of
21 the University of Arkansas for Medical Sciences and the College of Nursing of
22 the University of Arkansas for Medical Sciences in accordance with § 6-64-
23 417;

24 (C) Arkansas State University-Mountain Home, an amount not to
25 exceed two hundred fifty thousand dollars (\$250,000) for deposit into the
26 Arkansas State University-Mountain Home Fund to be expended exclusively for
27 the Arkansas State University-Mountain Home Practical Nursing Program;

28 (D) The University of Central Arkansas, an amount not to exceed
29 one hundred thousand dollars (\$100,000) for deposit into the University of
30 Central Arkansas Fund to be expended exclusively for the University of
31 Central Arkansas School of Nursing;

32 (E) Southern Arkansas University, an amount not to exceed one
33 hundred thousand dollars (\$100,000) for deposit into the Southern Arkansas
34 University Fund to be expended exclusively for personal services and
35 operating expenses of the Southern Arkansas University system;

36 (F) Henderson State University, an amount not to exceed one

1 hundred thousand dollars (\$100,000) for deposit into the Henderson State
2 University Fund;

3 (G) Arkansas Tech University, an amount not to exceed one hundred
4 thousand dollars (\$100,000) for deposit into the Arkansas Tech University
5 Fund exclusively for nursing programs;~~and~~

6 (H) Northwest Arkansas Community College, an amount not to exceed
7 fifty thousand dollars (\$50,000) for deposit into the Northwest Arkansas
8 Community College Fund exclusively for nursing programs; and

9 (I) Arkansas Northeastern College, an amount not to exceed
10 twenty-five thousand dollars (\$25,000) for deposit into the Arkansas
11 Northeastern College Fund to be expended exclusively for nursing progra

12 (4) Funds remaining after the distributions listed in subdivisions
13 (b)(3)(A)~~-(H)~~ (I) of this section shall be deposited into a bank authorized
14 to do business within this state and placed into the account of the board.

15

16 SECTION 57. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
17 authorized by this act shall be limited to the appropriation for such agency
18 and funds made available by law for the support of such appropriations; and
19 the restrictions of the State Procurement Law, the General Accounting and
20 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
21 Procedures and Restrictions Act, or their successors, and other fiscal
22 control laws of this State, where applicable, and regulations promulgated by
23 the Department of Finance and Administration, as authorized by law, shall be
24 strictly complied with in disbursement of said funds.

25

26 SECTION 58. LEGISLATIVE INTENT. It is the intent of the General
27 Assembly that any funds disbursed under the authority of the appropriations
28 contained in this act shall be in compliance with the stated reasons for
29 which this act was adopted, as evidenced by the Agency Requests, Executive
30 Recommendations and Legislative Recommendations contained in the budget
31 manuals prepared by the Department of Finance and Administration, letters, or
32 summarized oral testimony in the official minutes of the Arkansas Legislative
33 Council or Joint Budget Committee which relate to its passage and adoption.

34

35 SECTION 59. EMERGENCY CLAUSE. It is found and determined by the
36 General Assembly, that the Constitution of the State of Arkansas prohibits

1 the appropriation of funds for more than a one (1) year period; that the
2 effectiveness of this Act on July 1, 2021 is essential to the operation of
3 the agency for which the appropriations in this Act are provided, and that in
4 the event of an extension of the legislative session, the delay in the
5 effective date of this Act beyond July 1, 2021 could work irreparable harm
6 upon the proper administration and provision of essential governmental
7 programs. Therefore, an emergency is hereby declared to exist and this Act
8 being necessary for the immediate preservation of the public peace, health
9 and safety shall be in full force and effect from and after July 1, 2021.
