8	in the State of Arkansas by the Arkansas State Medical Board.		
9	(b) The athletic trainer may practice athletic training in a hospital		
10	or outpatient clinic under the direct supervision of a physical therapist and		
11	upon the referral of a physician licensed in the State of Arkansas <u>or of a</u>		
12	physician licensed by the board.
