5	SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of	funds	
6	authorized by this act shall be limited to the appropriation	for such agency	
7	and funds made available by law for the support of such appropriations; and		
8	the restrictions of the State Procurement Law, the General Accounting and		
9	Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary		
10	Procedures and Restrictions Act, or their successors, and oth	er fiscal	
11	control laws of this State, where applicable, and regulations promulgated by		
12	the Department of Finance and Administration, as authorized by law, shall be		
13	strictly complied with in disbursement of said funds.		
14			
15	SECTION 3. LEGISLATIVE INTENT. It is the intent of the	General	
16	Assembly that any funds disbursed under the authority of the	appropriations	
17	contained in this act shall be in compliance with the stated	reasons for	
18	which this act was adopted, as evidenced by the Agency Reques	ts, Executive	
19	Recommendations and Legislative Recommendations contained in	the budget	
20	manuals prepared by the Department of Finance and Administrat	ion, letters, or	
21	summarized oral testimony in the official minutes of the Arka	nsas Legislative	
22	Council or Joint Budget Committee which relate to its passage	and adoption.	
23			
24	SECTION 4. EMERGENCY CLAUSE. It is found and determine	d by the General	
25	Assembly, that funds provided by the General Assembly for the	operations of	
26	the Henderson State University are, due to unforeseen circums	tances,	
27	insufficient for the Henderson State University to continue t	<u>o provide</u>	
28	essential governmental services; that the provisions of this	act will provide	
29	the necessary monies for the Henderson State University to co	ntinue such	
30	services; and that a delay in the effective date of this Act	could work	
31	irreparable harm upon the proper administration and provision	of essential	
32	governmental programs. Therefore, an emergency is hereby decl	ared to exist	
33	and this Act being necessary for the immediate preservation of the public		
34	peace, health and safety shall be in full force and effect fr	om and after the	
35	date of its passage and approval.		
36	If the bill is neither approved nor vetoed by the Gover	nor, it shall	

1	become effective on the expiration of the period of time during which the
2	Governor may veto the bill. If the bill is vetoed by the Governor and the
3	veto is overridden, it shall become effective on the date the last house
4	overrides the veto.
