19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code Title 28, Chapter 70, is repealed.

25 ~~28-70-101.—Short title.~~

26 ~~This chapter may be cited as the “Uniform Principal and Income Act.”~~

27  
28 ~~28-70-102.—Definitions.~~

29 ~~In this chapter:~~

30 ~~(1) “Accounting period” means a calendar year unless another 12-~~  
31 ~~month period is selected by a fiduciary. The term includes a portion of a~~  
32 ~~calendar year or other 12-month period that begins when an income interest~~  
33 ~~begins or ends when an income interest ends.~~

34 ~~(2) “Beneficiary” includes, in the case of a decedent’s estate,~~  
35 ~~an heir, legatee, and devisee and, in the case of a trust, an income~~  
36 ~~beneficiary and a remainder beneficiary.~~



1           ~~(3) “Fiduciary” means a personal representative or a trustee.~~  
2     ~~The term includes an executor, administrator, successor personal~~  
3     ~~representative, special administrator, and a person performing substantially~~  
4     ~~the same function.~~

5           ~~(4) “Income” means money or property that a fiduciary receives~~  
6     ~~as current return from a principal asset. The term includes a portion of~~  
7     ~~receipts from a sale, exchange, or liquidation of a principal asset, to the~~  
8     ~~extent provided in § 28-70-401 et seq.~~

9           ~~(5) “Income beneficiary” means a person to whom net income of a~~  
10    ~~trust is or may be payable.~~

11          ~~(6) “Income interest” means the right of an income beneficiary~~  
12    ~~to receive all or part of net income, whether the terms of the trust require~~  
13    ~~it to be distributed or authorize it to be distributed in the trustee’s~~  
14    ~~discretion.~~

15          ~~(7) “Mandatory income interest” means the right of an income~~  
16    ~~beneficiary to receive net income that the terms of the trust require the~~  
17    ~~fiduciary to distribute.~~

18          ~~(8) “Net income” means the total receipts allocated to income~~  
19    ~~during an accounting period minus the disbursements made from income during~~  
20    ~~the period, plus or minus transfers under this chapter to or from income~~  
21    ~~during the period.~~

22          ~~(9) “Person” means an individual, corporation, business trust,~~  
23    ~~estate, trust, partnership, limited liability company, association, joint~~  
24    ~~venture, government; governmental subdivision, agency, or instrumentality;~~  
25    ~~public corporation; or any other legal or commercial entity.~~

26          ~~(10) “Principal” means property held in trust for distribution~~  
27    ~~to a remainder beneficiary when the trust terminates.~~

28          ~~(11) “Remainder beneficiary” means a person entitled to receive~~  
29    ~~principal when an income interest ends.~~

30          ~~(12) “Terms of a trust” means the manifestation of the intent of~~  
31    ~~a settlor or decedent with respect to the trust, expressed in a manner that~~  
32    ~~admits of its proof in a judicial proceeding, whether by written or spoken~~  
33    ~~words or by conduct.~~

34          ~~(13) “Trustee” includes an original, additional, or successor~~  
35    ~~trustee, whether or not appointed or confirmed by a court.~~

1           ~~28-70-103. Fiduciary duties—General principles.~~

2           ~~(a) In allocating receipts and disbursements to or between principal~~  
 3 ~~and income, and with respect to any matter within the scope of § 28-70-201 et~~  
 4 ~~seq. and § 28-70-301 et seq., a fiduciary:~~

5                   ~~(1) shall administer a trust or estate in accordance with the~~  
 6 ~~terms of the trust or the will, even if there is a different provision in~~  
 7 ~~this chapter;~~

8                   ~~(2) may administer a trust or estate by the exercise of a~~  
 9 ~~discretionary power of administration given to the fiduciary by the terms of~~  
 10 ~~the trust or the will, even if the exercise of the power produces a result~~  
 11 ~~different from a result required or permitted by this chapter;~~

12                   ~~(3) shall administer a trust or estate in accordance with this~~  
 13 ~~chapter if the terms of the trust or the will do not contain a different~~  
 14 ~~provision or do not give the fiduciary a discretionary power of~~  
 15 ~~administration; and~~

16                   ~~(4) shall add a receipt or charge a disbursement to principal to~~  
 17 ~~the extent that the terms of the trust and this chapter do not provide a rule~~  
 18 ~~for allocating the receipt or disbursement to or between principal and~~  
 19 ~~income.~~

20           ~~(b) In exercising the power to adjust under § 28-70-104(a) or a~~  
 21 ~~discretionary power of administration regarding a matter within the scope of~~  
 22 ~~this chapter, whether granted by the terms of a trust, a will, or this~~  
 23 ~~chapter, a fiduciary shall administer a trust or estate impartially, based on~~  
 24 ~~what is fair and reasonable to all of the beneficiaries, except to the extent~~  
 25 ~~that the terms of the trust or the will clearly manifest an intention that~~  
 26 ~~the fiduciary shall or may favor one or more of the beneficiaries. A~~  
 27 ~~determination in accordance with this chapter is presumed to be fair and~~  
 28 ~~reasonable to all of the beneficiaries.~~

 30           ~~28-70-104. Trustee's power to adjust.~~

31           ~~(a) A trustee may adjust between principal and income to the extent~~  
 32 ~~the trustee considers necessary if the trustee invests and manages trust~~  
 33 ~~assets as a prudent investor, the terms of the trust describe the amount that~~  
 34 ~~may or must be distributed to a beneficiary by referring to the trust's~~  
 35 ~~income, and the trustee determines, after applying the rules in § 28-70-~~  
 36 ~~103(a), that the trustee is unable to comply with § 28-70-103(b).~~

1           ~~(b) In deciding whether and to what extent to exercise the power~~  
2 ~~conferred by subsection (a), a trustee shall consider all factors relevant to~~  
3 ~~the trust and its beneficiaries, including the following factors to the~~  
4 ~~extent they are relevant:~~

5                     ~~(1) the nature, purpose, and expected duration of the trust;~~

6                     ~~(2) the intent of the settlor;~~

7                     ~~(3) the identity and circumstances of the beneficiaries;~~

8                     ~~(4) the needs for liquidity, regularity of income, and~~  
9 ~~preservation and appreciation of capital;~~

10                    ~~(5) the assets held in the trust; the extent to which they~~  
11 ~~consist of financial assets, interests in closely held enterprises, tangible~~  
12 ~~and intangible personal property, or real property; the extent to which an~~  
13 ~~asset is used by a beneficiary; and whether an asset was purchased by the~~  
14 ~~trustee or received from the settlor;~~

15                    ~~(6) the net amount allocated to income under the other sections~~  
16 ~~of this chapter and the increase or decrease in the value of the principal~~  
17 ~~assets, which the trustee may estimate as to assets for which market values~~  
18 ~~are not readily available;~~

19                    ~~(7) whether and to what extent the terms of the trust give the~~  
20 ~~trustee the power to invade principal or accumulate income or prohibit the~~  
21 ~~trustee from invading principal or accumulating income, and the extent to~~  
22 ~~which the trustee has exercised a power from time to time to invade principal~~  
23 ~~or accumulate income;~~

24                    ~~(8) the actual and anticipated effect of economic conditions on~~  
25 ~~principal and income and effects of inflation and deflation; and~~

26                    ~~(9) the anticipated tax consequences of an adjustment.~~

27           ~~(c) A trustee may not make an adjustment:~~

28                    ~~(1) that diminishes the income interest in a trust that requires~~  
29 ~~all of the income to be paid at least annually to a surviving spouse and for~~  
30 ~~which an estate tax or gift tax marital deduction would be allowed, in whole~~  
31 ~~or in part, if the trustee did not have the power to make the adjustment;~~

32                    ~~(2) that reduces the actuarial value of the income interest in a~~  
33 ~~trust to which a person transfers property with the intent to qualify for a~~  
34 ~~gift tax exclusion;~~

35                    ~~(3) that changes the amount payable to a beneficiary as a fixed~~  
36 ~~annuity or a fixed fraction of the value of the trust assets;~~

1           ~~(4) from any amount that is permanently set aside for charitable~~  
2 ~~purposes under a will or the terms of a trust unless both income and~~  
3 ~~principal are so set aside;~~

4           ~~(5) if possessing or exercising the power to make an adjustment~~  
5 ~~causes an individual to be treated as the owner of all or part of the trust~~  
6 ~~for income tax purposes, and the individual would not be treated as the owner~~  
7 ~~if the trustee did not possess the power to make an adjustment;~~

8           ~~(6) if possessing or exercising the power to make an adjustment~~  
9 ~~causes all or part of the trust assets to be included for estate tax purposes~~  
10 ~~in the estate of an individual who has the power to remove a trustee or~~  
11 ~~appoint a trustee, or both, and the assets would not be included in the~~  
12 ~~estate of the individual if the trustee did not possess the power to make an~~  
13 ~~adjustment;~~

14           ~~(7) if the trustee is a beneficiary of the trust; or~~

15           ~~(8) if the trustee is not a beneficiary, but the adjustment~~  
16 ~~would benefit the trustee directly or indirectly.~~

17           ~~(d) If subsection (c)(5), (6), (7), or (8) applies to a trustee and~~  
18 ~~there is more than one trustee, a cotrustee to whom the provision does not~~  
19 ~~apply may make the adjustment unless the exercise of the power by the~~  
20 ~~remaining trustee or trustees is not permitted by the terms of the trust.~~

21           ~~(e) A trustee may release the entire power conferred by subsection (a)~~  
22 ~~or may release only the power to adjust from income to principal or the power~~  
23 ~~to adjust from principal to income if the trustee is uncertain about whether~~  
24 ~~possessing or exercising the power will cause a result described in~~  
25 ~~subsection (c)(1) through (6) or (c)(8) or if the trustee determines that~~  
26 ~~possessing or exercising the power will or may deprive the trust of a tax~~  
27 ~~benefit or impose a tax burden not described in subsection (c). The release~~  
28 ~~may be permanent or for a specified period, including a period measured by~~  
29 ~~the life of an individual.~~

30           ~~(f) Terms of a trust that limit the power of a trustee to make an~~  
31 ~~adjustment between principal and income do not affect the application of this~~  
32 ~~section unless it is clear from the terms of the trust that the terms are~~  
33 ~~intended to deny the trustee the power of adjustment conferred by subsection~~  
34 ~~(a).~~

~~—Decedent’s Estate or Terminating Income Interest~~

~~28-70-201. Determination and distribution of net income.~~

~~After a decedent dies, in the case of an estate, or after an income interest in a trust ends, the following rules apply:~~

~~(1) A fiduciary of an estate or of a terminating income interest shall determine the amount of net income and net principal receipts received from property specifically given to a beneficiary under the rules in § 28-70-301 et seq., § 28-70-401 et seq., and § 28-70-501 et seq. which apply to trustees and the rules in paragraph (5). The fiduciary shall distribute the net income and net principal receipts to the beneficiary who is to receive the specific property.~~

~~(2) A fiduciary shall determine the remaining net income of a decedent’s estate or a terminating income interest under the rules in § 28-70-301 et seq., § 28-70-401 et seq., and § 28-70-501 et seq. which apply to trustees and by:~~

~~(A) including in net income all income from property used to discharge liabilities;~~

~~(B) paying from income or principal, in the fiduciary’s discretion, fees of attorneys, accountants, and fiduciaries; court costs and other expenses of administration; and interest on death taxes, but the fiduciary may pay those expenses from income of property passing to a trust for which the fiduciary claims an estate tax marital or charitable deduction only to the extent that the payment of those expenses from income will not cause the reduction or loss of the deduction; and~~

~~(C) paying from principal all other disbursements made or incurred in connection with the settlement of a decedent’s estate or the winding up of a terminating income interest, including debts, funeral expenses, disposition of remains, family allowances, and death taxes and related penalties that are apportioned to the estate or terminating income interest by the will, the terms of the trust, or applicable law.~~

~~(3) A fiduciary shall distribute to a beneficiary who receives a pecuniary amount outright the interest or any other amount provided by the will, the terms of the trust, or applicable law from net income determined under paragraph (2) or from principal to the extent that net income is insufficient. If a beneficiary is to receive a pecuniary amount outright from~~

1 ~~a trust after an income interest ends and no interest or other amount is~~  
2 ~~provided for by the terms of the trust or applicable law, the fiduciary shall~~  
3 ~~distribute the interest or other amount to which the beneficiary would be~~  
4 ~~entitled under applicable law if the pecuniary amount were required to be~~  
5 ~~paid under a will.~~

6 ~~(4) A fiduciary shall distribute the net income remaining after~~  
7 ~~distributions required by paragraph (3) in the manner described in § 28-70-~~  
8 ~~202 to all other beneficiaries, including a beneficiary who receives a~~  
9 ~~pecuniary amount in trust, even if the beneficiary holds an unqualified power~~  
10 ~~to withdraw assets from the trust or other presently exercisable general~~  
11 ~~power of appointment over the trust.~~

12 ~~(5) A fiduciary may not reduce principal or income receipts from~~  
13 ~~property described in paragraph (1) because of a payment described in § 28-~~  
14 ~~70-501 or § 28-70-502 to the extent that the will, the terms of the trust, or~~  
15 ~~applicable law requires the fiduciary to make the payment from assets other~~  
16 ~~than the property or to the extent that the fiduciary recovers or expects to~~  
17 ~~recover the payment from a third party. The net income and principal receipts~~  
18 ~~from the property are determined by including all of the amounts the~~  
19 ~~fiduciary receives or pays with respect to the property, whether those~~  
20 ~~amounts accrued or became due before, on, or after the date of a decedent's~~  
21 ~~death or an income interest's terminating event, and by making a reasonable~~  
22 ~~provision for amounts that the fiduciary believes the estate or terminating~~  
23 ~~income interest may become obligated to pay after the property is~~  
24 ~~distributed.~~

25  
26 ~~28-70-202. Distribution to residuary and remainder beneficiaries.~~

27 ~~(a) Each beneficiary described in § 28-70-201(4) is entitled to~~  
28 ~~receive a portion of the net income equal to the beneficiary's fractional~~  
29 ~~interest in undistributed principal assets, using values as of the~~  
30 ~~distribution date. If a fiduciary makes more than one distribution of assets~~  
31 ~~to beneficiaries to whom this section applies, each beneficiary, including~~  
32 ~~one who does not receive part of the distribution, is entitled, as of each~~  
33 ~~distribution date, to the net income the fiduciary has received after the~~  
34 ~~date of death or terminating event or earlier distribution date but has not~~  
35 ~~distributed as of the current distribution date.~~

36 ~~(b) In determining a beneficiary's share of net income, the following~~

1 ~~rules apply:~~

2 ~~(1) The beneficiary is entitled to receive a portion of the net~~  
 3 ~~income equal to the beneficiary's fractional interest in the undistributed~~  
 4 ~~principal assets immediately before the distribution date, including assets~~  
 5 ~~that later may be sold to meet principal obligations.~~

6 ~~(2) The beneficiary's fractional interest in the undistributed~~  
 7 ~~principal assets must be calculated without regard to property specifically~~  
 8 ~~given to a beneficiary and property required to pay pecuniary amounts not in~~  
 9 ~~trust.~~

10 ~~(3) The beneficiary's fractional interest in the undistributed~~  
 11 ~~principal assets must be calculated on the basis of the aggregate value of~~  
 12 ~~those assets as of the distribution date without reducing the value by any~~  
 13 ~~unpaid principal obligation.~~

14 ~~(4) The distribution date for purposes of this section may be~~  
 15 ~~the date as of which the fiduciary calculates the value of the assets if that~~  
 16 ~~date is reasonably near the date on which assets are actually distributed.~~

17 ~~(c) If a fiduciary does not distribute all of the collected but~~  
 18 ~~undistributed net income to each person as of a distribution date, the~~  
 19 ~~fiduciary shall maintain appropriate records showing the interest of each~~  
 20 ~~beneficiary in that net income.~~

21 ~~(d) A trustee may apply the rules in this section, to the extent that~~  
 22 ~~the trustee considers it appropriate, to net gain or loss realized after the~~  
 23 ~~date of death or terminating event or earlier distribution date from the~~  
 24 ~~disposition of a principal asset if this section applies to the income from~~  
 25 ~~the asset.~~

 27 ~~Subchapter 3~~

28 ~~—Apportionment at Beginning and End of Income Interest~~

29  
 30 ~~28-70-301. When right to income begins and ends.~~

31 ~~(a) An income beneficiary is entitled to net income from the date on~~  
 32 ~~which the income interest begins. An income interest begins on the date~~  
 33 ~~specified in the terms of the trust or, if no date is specified, on the date~~  
 34 ~~an asset becomes subject to a trust or successive income interest.~~

35 ~~(b) An asset becomes subject to a trust:~~

36 ~~(1) on the date it is transferred to the trust in the case of an~~



1 ~~asset that is transferred to a trust during the transferor's life;~~

2 ~~(2) on the date of a testator's death in the case of an asset~~  
 3 ~~that becomes subject to a trust by reason of a will, even if there is an~~  
 4 ~~intervening period of administration of the testator's estate; or~~

5 ~~(3) on the date of an individual's death in the case of an asset~~  
 6 ~~that is transferred to a fiduciary by a third party because of the~~  
 7 ~~individual's death.~~

8 ~~(c) An asset becomes subject to a successive income interest on the~~  
 9 ~~day after the preceding income interest ends, as determined under subsection~~  
 10 ~~(d), even if there is an intervening period of administration to wind up the~~  
 11 ~~preceding income interest.~~

12 ~~(d) An income interest ends on the day before an income beneficiary~~  
 13 ~~dies or another terminating event occurs, or on the last day of a period~~  
 14 ~~during which there is no beneficiary to whom a trustee may distribute income.~~

15  
 16 ~~28-70-302. Apportionment of receipts and disbursements when decedent~~  
 17 ~~dies or income interest begins.~~

18 ~~(a) A trustee shall allocate an income receipt or disbursement other~~  
 19 ~~than one to which § 28-70-201(1) applies to principal if its due date occurs~~  
 20 ~~before a decedent dies in the case of an estate or before an income interest~~  
 21 ~~begins in the case of a trust or successive income interest.~~

22 ~~(b) A trustee shall allocate an income receipt or disbursement to~~  
 23 ~~income if its due date occurs on or after the date on which a decedent dies~~  
 24 ~~or an income interest begins and it is a periodic due date. An income receipt~~  
 25 ~~or disbursement must be treated as accruing from day to day if its due date~~  
 26 ~~is not periodic or it has no due date. The portion of the receipt or~~  
 27 ~~disbursement accruing before the date on which a decedent dies or an income~~  
 28 ~~interest begins must be allocated to principal, and the balance must be~~  
 29 ~~allocated to income.~~

30 ~~(c) An item of income or an obligation is due on the date the payer is~~  
 31 ~~required to make a payment. If a payment date is not stated, there is no due~~  
 32 ~~date for the purposes of this chapter. Distributions to shareholders or other~~  
 33 ~~owners from an entity to which § 28-70-401 applies are deemed to be due on~~  
 34 ~~the date fixed by the entity for determining who is entitled to receive the~~  
 35 ~~distribution or, if no date is fixed, on the declaration date for the~~  
 36 ~~distribution. A due date is periodic for receipts or disbursements that must~~

1 ~~be paid at regular intervals under a lease or an obligation to pay interest~~  
 2 ~~or if an entity customarily makes distributions at regular intervals.~~

3  
 4 ~~28-70-303. Apportionment when income interest ends.~~

5 ~~(a) In this section, "undistributed income" means net income received~~  
 6 ~~before the date on which an income interest ends. The term does not include~~  
 7 ~~an item of income or expense that is due or accrued or net income that has~~  
 8 ~~been added or is required to be added to principal under the terms of the~~  
 9 ~~trust.~~

10 ~~(b) When a mandatory income interest ends, the trustee shall pay to a~~  
 11 ~~mandatory income beneficiary who survives that date, or the estate of a~~  
 12 ~~deceased mandatory income beneficiary whose death causes the interest to end,~~  
 13 ~~the beneficiary's share of the undistributed income that is not disposed of~~  
 14 ~~under the terms of the trust unless the beneficiary has an unqualified power~~  
 15 ~~to revoke more than 5 percent of the trust immediately before the income~~  
 16 ~~interest ends. In the latter case, the undistributed income from the portion~~  
 17 ~~of the trust that may be revoked must be added to principal.~~

18 ~~(c) When a trustee's obligation to pay a fixed annuity or a fixed~~  
 19 ~~fraction of the value of the trust's assets ends, the trustee shall prorate~~  
 20 ~~the final payment if and to the extent required by applicable law to~~  
 21 ~~accomplish a purpose of the trust or its settlor relating to income, gift,~~  
 22 ~~estate, or other tax requirements.~~

29  
 30 ~~28-70-401. Character of receipts.~~

31 ~~(a) In this section, "entity" means a corporation, partnership,~~  
 32 ~~limited liability company, regulated investment company, real estate~~  
 33 ~~investment trust, common trust fund, or any other organization in which a~~  
 34 ~~trustee has an interest other than a trust or estate to which § 28-70-402~~  
 35 ~~applies, a business or activity to which § 28-70-403 applies, or an asset-~~  
 36 ~~backed security to which § 28-70-415 applies.~~

1           ~~(b) Except as otherwise provided in this section, a trustee shall~~  
2     ~~allocate to income money received from an entity.~~

3           ~~(c) A trustee shall allocate the following receipts from an entity to~~  
4     ~~principal:~~

5                 ~~(1) property other than money;~~

6                 ~~(2) money received in one distribution or a series of related~~  
7     ~~distributions in exchange for part or all of a trust's interest in the~~  
8     ~~entity;~~

9                 ~~(3) money received in total or partial liquidation of the~~  
10    ~~entity; and~~

11                ~~(4) money received from an entity that is a regulated investment~~  
12    ~~company or a real estate investment trust if the money distributed is a~~  
13    ~~capital gain dividend for federal income tax purposes.~~

14           ~~(d) Money is received in partial liquidation:~~

15                 ~~(1) to the extent that the entity, at or near the time of a~~  
16    ~~distribution, indicates that it is a distribution in partial liquidation; or~~

17                 ~~(2) if the total amount of money and property received in a~~  
18    ~~distribution or series of related distributions is greater than 20 percent of~~  
19    ~~the entity's gross assets, as shown by the entity's year-end financial~~  
20    ~~statements immediately preceding the initial receipt.~~

21           ~~(e) Money is not received in partial liquidation, nor may it be taken~~  
22    ~~into account under subsection (d)(2), to the extent that it does not exceed~~  
23    ~~the amount of income tax that a trustee or beneficiary must pay on taxable~~  
24    ~~income of the entity that distributes the money.~~

25           ~~(f) A trustee may rely upon a statement made by an entity about the~~  
26    ~~source or character of a distribution if the statement is made at or near the~~  
27    ~~time of distribution by the entity's board of directors or other person or~~  
28    ~~group of persons authorized to exercise powers to pay money or transfer~~  
29    ~~property comparable to those of a corporation's board of directors.~~

30  
31           ~~28-70-402. Distribution from trust or estate.~~

32           ~~A trustee shall allocate to income an amount received as a distribution~~  
33    ~~of income from a trust or an estate in which the trust has an interest other~~  
34    ~~than a purchased interest and shall allocate to principal an amount received~~  
35    ~~as a distribution of principal from such a trust or estate. If a trustee~~  
36    ~~purchases an interest in a trust that is an investment entity, or a decedent~~

1 ~~or donor transfers an interest in such a trust to a trustee, § 28-70-401 or §~~  
 2 ~~28-70-415 applies to a receipt from the trust.~~

3  
 4 ~~28-70-403. Business and other activities conducted by trustee.~~

5 ~~(a) If a trustee who conducts a business or other activity determines~~

Subchapter 1 – General Provisions

28-77-101. Short title.

This chapter may be cited as the "Uniform Fiduciary Income and Principal Act".

28-77-102. Definitions.

In this chapter:

(1) "Accounting period" means a calendar year, unless a fiduciary selects another period of 12 calendar months or approximately 12 calendar months. The term includes a part of a calendar year or another period of 12 calendar months or approximately 12 calendar months which begins when an income interest begins or ends when an income interest ends.

(2) "Asset-backed security" means a security that is serviced

1 primarily by the cash flows of a discrete pool of fixed or revolving  
2 receivables or other financial assets that by their terms convert into cash  
3 within a finite time. The term includes rights or other assets that ensure  
4 the servicing or timely distribution of proceeds to the holder of the asset-  
5 backed security. The term does not include an asset to which § 28-77-401, §  
6 28-77-409, or § 28-77-414 applies.

7 (3) "Beneficiary" includes:

8 (A) for a trust:

9 (i) a current beneficiary, including a current  
10 income beneficiary and a beneficiary that may receive only principal;

11 (ii) a remainder beneficiary; and

12 (iii) any other successor beneficiary;

13 (B) for an estate, an heir, legatee, and devisee; and

14 (C) for a life estate or term interest, a person that

18 (5) "Current income beneficiary" means a beneficiary to which a

27 exercise of the power which produces a result different from a result  
28 required or permitted by this chapter does not create an inference that the  
29 fiduciary abused the fiduciary's discretion.

30 (c) A fiduciary shall:

31 (1) add a receipt to principal, to the extent neither the terms  
32 of the trust nor this chapter allocates the receipt between income and  
33 principal; and

34 (2) charge a disbursement to principal, to the extent neither  
35 the terms of the trust nor this chapter allocates the disbursement between  
36 income and principal.

1       (d) A fiduciary may exercise the power to adjust under § 28-77-203,  
2 convert an income trust to a unitrust under § 28-77-303(a)(1), change the  
3 percentage or method used to calculate a unitrust amount under § 28-77-  
4 303(a)(2), or convert a unitrust to an income trust under § 28-77-303(a)(3),  
5 if the fiduciary determines the exercise of the power will assist the  
6 fiduciary to administer the trust or estate impartially.

7       (e) Factors the fiduciary must consider in making the determination  
8 under subsection (d) of this section include:

9               (1) the terms of the trust;

10              (2) the nature, distribution standards, and expected duration of  
11 the trust;

12              (3) the effect of the allocation rules, including specific  
13 adjustments between income and principal, under § 28-77-401 et seq. through §  
14 28-77-701 et seq.;

15              (4) the desirability of liquidity and regularity of income;

16              (5) the desirability of the preservation and appreciation of  
17 principal;

18              (6) the extent to which an asset is used or may be used by a  
19 beneficiary;

20              (7) the increase or decrease in the value of principal assets,  
21 reasonably determined by the fiduciary;

22              (8) whether and to what extent the terms of the trust give the  
23 fiduciary power to accumulate income or invade principal or prohibit the  
24 fiduciary from accumulating income or invading principal;

25              (9) the extent to which the fiduciary has accumulated income or  
26 invaded principal in preceding accounting periods;

27              (10) the effect of current and reasonably expected economic  
28 conditions; and

29              (11) the reasonably expected tax consequences of the exercise of  
30 the power.

32       28-77-202. Judicial review of exercise of discretionary power.

33       (a) In this section, "fiduciary decision" means:

34              (1) a fiduciary's allocation between income and principal or  
35 other determination regarding income and principal required or authorized by  
36 the terms of the trust or this chapter;



1           (2) the fiduciary's exercise or nonexercise of a discretionary  
2 power regarding income and principal granted by the terms of the trust or  
3 this chapter, including the power to adjust under § 28-77-203, convert an  
4 income trust to a unitrust under § 28-77-303(a)(1), change the percentage or  
5 method used to calculate a unitrust amount under § 28-77-303(a)(2), or

25           (4) a beneficiary to return some or all of a distribution; or

28           (d) On petition by a fiduciary for instruction, the court may  
29 determine whether a proposed fiduciary decision will result in an abuse of  
30 the fiduciary's discretion. If the petition describes the proposed decision,

32 making the proposed decision and the facts on which the fiduciary relies, and  
33 explains how the beneficiary will be affected by the proposed decision, a

2       (a) Except as otherwise provided in the terms of a trust or this  
3 section, a fiduciary, in a record, without court approval, may adjust between  
4 income and principal if the fiduciary determines the exercise of the power to  
5 adjust will assist the fiduciary to administer the trust or estate  
6 impartially.

7       (b) This section does not create a duty to exercise or consider the  
8 power to adjust under subsection (a) of this section or to inform a  
9 beneficiary about the applicability of this section.

13 this section does not apply may exercise the power to adjust, unless the  
14 exercise of the power by the remaining co-fiduciary or co-fiduciaries is not

19 (k) A description of the exercise of the power to adjust under

21 (1) included in a report, if any, sent to beneficiaries under §

4 (4) "Net fair market value of a trust" means the fair market  
5 value of the assets of the trust, less the noncontingent liabilities of the  
6 trust.

7 (5) "Unitrust" means a trust for which net income is a unitrust  
8 amount. The term includes an express unitrust.

9 (6) "Unitrust amount" means an amount computed by multiplying a  
10 determined value of a trust by a determined percentage. For a unitrust  
11 administered under a unitrust policy, the term means the applicable value,  
12 multiplied by the unitrust rate.

13 (7) "Unitrust policy" means a policy described in § 28-77-305  
14 through § 28-77-309 and adopted under § 28-77-303.

15 (8) "Unitrust rate" means the rate used to compute the unitrust  
16 amount under subdivision (6) of this section for a unitrust administered  
17 under a unitrust policy.

18  
19 28-77-302. Application – Duties and remedies.

20 (a) Except as otherwise provided in subsection (b) of this section,  
21 this subchapter applies to:

22 (1) an income trust, unless the terms of the trust expressly  
23 prohibit use of this subchapter by a specific reference to this subchapter or  
24 an explicit expression of intent that net income not be calculated as a  
25 unitrust amount; and

26 (2) an express unitrust, except to the extent the terms of the  
27 trust explicitly:

28 (A) prohibit use of this subchapter by a specific  
29 reference to this subchapter;

30 (B) prohibit conversion to an income trust; or

31 (C) limit changes to the method of calculating the  
32 unitrust amount.

33 (b) This subchapter does not apply to a trust described in Section  
34 170(f)(2)(B), 642(c)(5), 664(d), 2702(a)(3)(A)(ii) or (iii), or 2702(b) of  
35 the Internal Revenue Code of 1986, as amended, 26 U.S.C. Section  
36 170(f)(2)(B), 642(c)(5), 664(d), 2702(a)(3)(A)(ii) or (iii), or 2702(b), as

1 amended.

2 (c) An income trust to which this subchapter applies under subdivision  
3 (a)(1) of this section may be converted to a unitrust under this subchapter  
4 regardless of the terms of the trust concerning distributions. Conversion to  
5 a unitrust under this subchapter does not affect other terms of the trust  
6 concerning distributions of income or principal.

7 (d) This subchapter applies to an estate only to the extent a trust is  
8 a beneficiary of the estate. To the extent of the trust's interest in the  
9 estate, the estate may be administered as a unitrust, the administration of  
10 the estate as a unitrust may be discontinued, or the percentage or method  
11 used to calculate the unitrust amount may be changed, in the same manner as  
12 for a trust under this subchapter.

13 (e) This subchapter does not create a duty to take or consider action  
14 under this subchapter or to inform a beneficiary about the applicability of  
15 this subchapter.

16 (f) A fiduciary that in good faith takes or fails to take an action  
17 under this subchapter is not liable to a person affected by the action or  
18 inaction.

19  
20 28-77-303. Authority of fiduciary.

21 (a) A fiduciary, without court approval, by complying with subsections  
22 (b) and (f) of this section, may:

23 (1) convert an income trust to a unitrust if the fiduciary  
24 adopts in a record a unitrust policy for the trust providing:

25 (A) that in administering the trust the net income of the  
26 trust will be a unitrust amount rather than net income determined without  
27 regard to this subchapter; and

28 (B) the percentage and method used to calculate the  
29 unitrust amount;

30 (2) change the percentage or method used to calculate a unitrust  
31 amount for a unitrust if the fiduciary adopts in a record a unitrust policy  
32 or an amendment or replacement of a unitrust policy providing changes in the  
33 percentage or method used to calculate the unitrust amount; or

34 (3) convert a unitrust to an income trust if the fiduciary  
35 adopts in a record a determination that, in administering the trust, the net  
36 income of the trust will be net income determined without regard to this

1 subchapter rather than a unitrust amount.

2 (b) A fiduciary may take an action under subsection (a) of this  
3 section if:

4 (1) the fiduciary determines that the action will assist the  
5 fiduciary to administer a trust impartially;

6 (2) the fiduciary sends a notice in a record, in the manner  
7 required by § 28-77-304, describing and proposing to take the action;

8 (3) the fiduciary sends a copy of the notice under subdivision  
9 (b)(2) of this section to each settlor of the trust which is:

10 (A) if an individual, living; or

11 (B) if not an individual, in existence;

12 (4) at least one member of each class of the qualified  
13 beneficiaries determined under § 28-73-103(14), other than the Attorney  
14 General, receiving the notice under subdivision (b)(2) of this section is:

15 (A) if an individual, legally competent;

16 (B) if not an individual, in existence; or

17 (C) represented in the manner provided in § 28-77-304(b);

18 and

19 (5) the fiduciary does not receive, by the date specified in the  
20 notice under § 28-77-304(d)(5), an objection in a record to the action  
21 proposed under subdivision (b)(2) of this section from a person to which the  
22 notice under subdivision (b)(2) of this section is sent.

23 (c) If a fiduciary receives, not later than the date stated in the  
24 notice under § 28-77-304(d)(5), an objection in a record described in Section  
25 § 28-77-304(d)(4) to a proposed action, the fiduciary or a beneficiary may  
26 request the court to have the proposed action taken as proposed, taken with  
27 modifications, or prevented. A person described in § 28-77-304(a) may oppose  
28 the proposed action in the proceeding under this subsection, whether or not  
29 the person:

30 (1) consented under § 28-77-304(c); or

31 (2) objected under § 28-77-304(d)(4).

32 (d) If, after sending a notice under subdivision (b)(2) of this  
33 section, a fiduciary decides not to take the action proposed in the notice,  
34 the fiduciary shall notify in a record each person described in § 28-77-  
35 304(a) of the decision not to take the action and the reasons for the  
36 decision.

1       (e) If a beneficiary requests in a record that a fiduciary take an  
2 action described in subsection (a) of this section and the fiduciary declines  
3 to act or does not act within 90 days after receiving the request, the  
4 beneficiary may request the court to direct the fiduciary to take the action  
5 requested.

6       (f) In deciding whether and how to take an action authorized by  
7 subsection (a) of this section, or whether and how to respond to a request by  
8 a beneficiary under subsection (e) of this section, a fiduciary shall  
9 consider all factors relevant to the trust and the beneficiaries, including  
10 relevant factors in § 28-77-201(e).

11       (g) A fiduciary may release or delegate the power to convert an income  
12 trust to a unitrust under subdivision (a)(1) of this section, change the  
13 percentage or method used to calculate a unitrust amount under subdivision  
14 (a)(2) of this section, or convert a unitrust to an income trust under  
15 subdivision (a)(3) of this section, for a reason described in § 28-77-203(g)  
16 and in the manner described in § 28-77-203(h).

17  
18       28-77-304. Notice.

19       (a) A notice required by § 28-77-303(b)(2) must be sent in a manner  
20 authorized under § 28-73-109 to:

21           (1) the qualified beneficiaries determined under § 28-73-  
22 103(14), other than the Attorney General; and

23           (2) each person acting as trust director of the trust under the  
24 Uniform Directed Trust Act, § 28-76-101 et seq.

25       (b) The representation provisions of §§ 28-73-301 – 28-73-305 apply to  
26 notice under this section.

27       (c) A person may consent in a record at any time to action proposed  
28 under § 28-77-303(b)(2). A notice required by § 28-77-303(b)(2) need not be  
29 sent to a person that consents under this subsection.

30       (d) A notice required by § 28-77-303(b)(2) must include:

31           (1) the action proposed under § 28-77-303(b)(2);

32           (2) for a conversion of an income trust to a unitrust, a copy of  
33 the unitrust policy adopted under § 28-77-303(a)(1);

34           (3) for a change in the percentage or method used to calculate  
35 the unitrust amount, a copy of the unitrust policy or amendment or  
36 replacement of the unitrust policy adopted under § 28-77-303(a)(2);



1           (4) a statement that the person to which the notice is sent may  
2 object to the proposed action by stating in a record the basis for the  
3 objection and sending or delivering the record to the fiduciary;

4           (5) the date by which an objection under subdivision (d)(4) of  
5 this section must be received by the fiduciary, which must be at least 30  
6 days after the date the notice is sent;

7           (6) the date on which the action is proposed to be taken and the  
8 date on which the action is proposed to take effect;

9           (7) the name and contact information of the fiduciary; and

10           (8) the name and contact information of a person that may be  
11 contacted for additional information.

12  
13           28-77-305. Unitrust policy.

14           (a) In administering a unitrust under this subchapter, a fiduciary  
15 shall follow a unitrust policy adopted under § 28-77-303(a)(1) or (2) or  
16 amended or replaced under § 28-77-303(a)(2).

17           (b) A unitrust policy must provide:

18           (1) the unitrust rate or the method for determining the unitrust  
19 rate under § 28-77-306;

20           (2) the method for determining the applicable value under § 28-  
21 77-307; and

22           (3) the rules described in § 28-77-306 through § 28-77-309 which  
23 apply in the administration of the unitrust, whether the rules are:

24           (A) mandatory, as provided in § 28-77-307(a) and § 28-77-  
25 308(a); or

26           (B) optional, as provided in § 28-77-306, § 28-77-307(b),  
27 § 28-77-308(b), and § 28-77-309(a), to the extent the fiduciary elects to  
28 adopt those rules.

29  
30           28-77-306. Unitrust rate.

31           (a) Except as otherwise provided in § 28-77-309(b)(1), a unitrust rate  
32 may be:

33           (1) a fixed unitrust rate; or

34           (2) a unitrust rate that is determined for each period using:

35           (A) a market index or other published data; or

36           (B) a mathematical blend of market indices or other

1 published data over a stated number of preceding periods.

2 (b) Except as otherwise provided in § 28-77-309(b)(1), a unitrust  
3 policy may provide:

4 (1) a limit on how high the unitrust rate determined under  
5 subdivision (a)(2) of this section may rise;

6 (2) a limit on how low the unitrust rate determined under  
7 subdivision (a)(2) of this section may fall;

8 (3) a limit on how much the unitrust rate determined under  
9 subdivision (a)(2) of this section may increase over the unitrust rate for  
10 the preceding period or a mathematical blend of unitrust rates over a stated  
11 number of preceding periods;

12 (4) a limit on how much the unitrust rate determined under  
13 subdivision (a)(2) of this section may decrease below the unitrust rate for  
14 the preceding period or a mathematical blend of unitrust rates over a stated  
15 number of preceding periods; or

16 (5) a mathematical blend of any of the unitrust rates determined  
17 under subdivision (a)(2) of this section and subdivisions (b)(1) through (4)  
18 of this section.

19  
20 28-77-307. Applicable value.

21 (a) A unitrust policy must provide the method for determining the fair  
22 market value of an asset for the purpose of determining the unitrust amount,  
23 including:

24 (1) the frequency of valuing the asset, which need not require a  
25 valuation in every period; and

26 (2) the date for valuing the asset in each period in which the  
27 asset is valued.

28 (b) Except as otherwise provided in § 28-77-309(b)(2), a unitrust  
29 policy may provide methods for determining the amount of the net fair market  
30 value of the trust to take into account in determining the applicable value,  
31 including:

32 (1) obtaining an appraisal of an asset for which fair market  
33 value is not readily available;

34 (2) exclusion of specific assets or groups or types of assets;

35 (3) other exceptions or modifications of the treatment of  
36 specific assets or groups or types of assets;

1           (4) identification and treatment of cash or property held for  
2 distribution;

3           (5) use of:

4                 (A) an average of fair market values over a stated number  
5 of preceding periods; or

6                 (B) another mathematical blend of fair market values over  
7 a stated number of preceding periods;

8           (6) a limit on how much the applicable value of all assets,  
9 groups of assets, or individual assets may increase over:

10                 (A) the corresponding applicable value for the preceding  
11 period; or

12                 (B) a mathematical blend of applicable values over a  
13 stated number of preceding periods;

14           (7) a limit on how much the applicable value of all assets,  
15 groups of assets, or individual assets may decrease below:

16                 (A) the corresponding applicable value for the preceding  
17 period; or

18                 (B) a mathematical blend of applicable values over a  
19 stated number of preceding periods;

20           (8) the treatment of accrued income and other features of an  
21 asset which affect value; and

22           (9) determining the liabilities of the trust, including  
23 treatment of liabilities to conform with the treatment of assets under  
24 subdivisions (b)(1) through (8) of this section.

25  
26           28-77-308. Period.

27           (a) A unitrust policy must provide the period used under § 28-77-306  
28 and § 28-77-307. Except as otherwise provided in § 28-77-309(b)(3), the  
29 period may be:

30                 (1) a calendar year;

31                 (2) a 12-month period other than a calendar year;

32                 (3) a calendar quarter;

33                 (4) a three-month period other than a calendar quarter; or

34                 (5) another period.

35           (b) Except as otherwise provided in § 28-77-309(b), a unitrust policy  
36 may provide standards for:

1           (1) using fewer preceding periods under § 28-77-306(a)(2)(B) or  
 2 § 28-77-306(b)(3) or § 28-77-306(b)(4) if:

3           (A) the trust was not in existence in a preceding period;  
 4 or

5           (B) market indices or other published data are not  
 6 available for a preceding period;

7           (2) using fewer preceding periods under § 28-77-307(b)(5)(A) or  
 8 § 28-77-307(b)(5)(B), § 28-77-307(b)(6)(B), or § 28-77-307(b)(7)(B) if:

9           (A) the trust was not in existence in a preceding period;  
 10 or

11           (B) fair market values are not available for a preceding  
 12 period; and

13           (3) prorating the unitrust amount on a daily basis for a part of  
 14 a period in which the trust or the administration of the trust as a unitrust  
 15 or the interest of any beneficiary commences or terminates.

16  
 17       28-77-309. Special tax benefits – Other rules.

18       (a) A unitrust policy may:

19           (1) provide methods and standards for:

20           (A) determining the timing of distributions;

21           (B) making distributions in cash or in kind or partly in  
 22 cash and partly in kind; or

23           (C) correcting an underpayment or overpayment to a  
 24 beneficiary based on the unitrust amount if there is an error in calculating  
 25 the unitrust amount;

26           (2) specify sources and the order of sources, including  
 27 categories of income for federal income tax purposes, from which  
 28 distributions of a unitrust amount are paid; or

29           (3) provide other standards and rules the fiduciary determines  
 30 serve the interests of the beneficiaries.

31       (b) If a trust qualifies for a special tax benefit or a fiduciary is  
 32 not an independent person:

33           (1) the unitrust rate established under § 28-77-306 may not be  
 34 less than three percent or more than five percent;

35           (2) the only provisions of § 28-77-307 which apply are § 28-77-  
 36 307(a) and § 28-77-307(b)(1), § 28-77-307(b)(4), § 28-77-307(b)(5)(A), and §

1 28-77-307(b)(9);

2 (3) the only period that may be used under Section 308 is a  
3 calendar year under § 28-77-308(a)(1); and

4 (4) the only other provisions of § 28-77-308 which apply are §  
5 28-77-308(b)(2)(A) and § 28-77-308(b)(3).

7 Subchapter 4 – Allocation of Receipts

8 Part 1 – Receipts From Entity

9  
10 28-77-401. Character of receipts from entity.

11 (a) In this section:

12 (1) “Capital distribution” means an entity distribution of money  
13 which is a:

14 (A) return of capital; or

15 (B) distribution in total or partial liquidation of the  
16 entity.

17 (2) “Entity”:

18 (A) means a corporation, partnership, limited liability  
19 company, regulated investment company, real estate investment trust, common  
20 trust fund, or any other organization or arrangement in which a fiduciary  
21 owns or holds an interest, whether or not the entity is a taxpayer for  
22 federal income tax purposes; and

23 (B) does not include:

24 (i) a trust or estate to which § 28-77-402 applies;

25 (ii) a business or other activity to which § 28-77-  
26 403 applies which is not conducted by an entity described in subdivision

27 (a)(2)(A) of this section;

28 (iii) an asset-backed security; or

29 (iv) an instrument or arrangement to which § 28-77-  
30 416 applies.

31 (3) “Entity distribution” means a payment or transfer by an  
32 entity made to a person in the person’s capacity as an owner or holder of an  
33 interest in the entity.

34 (b) In this section, an attribute or action of an entity includes an  
35 attribute or action of any other entity in which the entity owns or holds an  
36 interest, including an interest owned or held indirectly through another

1 entity.

2 (c) Except as otherwise provided in subdivisions (d)(2) through (4) of  
3 this section, a fiduciary shall allocate to income:

4 (1) money received in an entity distribution; and

5 (2) tangible personal property of nominal value received from  
6 the entity.

7 (d) A fiduciary shall allocate to principal:

8 (1) property received in an entity distribution which is not:

9 (A) money; or

10 (B) tangible personal property of nominal value;

11 (2) money received in an entity distribution in an exchange for  
12 part or all of the fiduciary's interest in the entity, to the extent the  
13 entity distribution reduces the fiduciary's interest in the entity relative  
14 to the interests of other persons that own or hold interests in the entity;

15 (3) money received in an entity distribution that the fiduciary  
16 determines or estimates is a capital distribution; and

17 (4) money received in an entity distribution from an entity that  
18 is:

19 (A) a regulated investment company or real estate  
20 investment trust if the money received is a capital gain dividend for federal  
21 income tax purposes; or

22 (B) treated for federal income tax purposes comparably to  
23 the treatment described in subdivision (d)(4)(A) of this section.

24 (e) A fiduciary may determine or estimate that money received in an  
25 entity distribution is a capital distribution:

26 (1) by relying without inquiry or investigation on a  
27 characterization of the entity distribution provided by or on behalf of the  
28 entity, unless the fiduciary:

29 (A) determines, on the basis of information known to the  
30 fiduciary, that the characterization is or may be incorrect; or

31 (B) owns or holds more than 50 percent of the voting  
32 interest in the entity;

33 (2) by determining or estimating, on the basis of information  
34 known to the fiduciary or provided to the fiduciary by or on behalf of the  
35 entity, that the total amount of money and property received by the fiduciary  
36 in the entity distribution or a series of related entity distributions is or

1 will be greater than 20 percent of the fair market value of the fiduciary's  
2 interest in the entity; or

3 (3) if neither subdivision (e)(1) nor subdivision (e)(2) of this  
4 section applies, by considering the factors in subsection (f) of this section  
5 and the information known to the fiduciary or provided to the fiduciary by or  
6 on behalf of the entity.

7 (f) In making a determination or estimate under subdivision (e)(3) of  
8 this section, a fiduciary may consider:

9 (1) a characterization of an entity distribution provided by or  
10 on behalf of the entity;

11 (2) the amount of money or property received in:

12 (A) the entity distribution; or

13 (B) what the fiduciary determines is or will be a series  
14 of related entity distributions;

15 (3) the amount described in subdivision (f)(2) of this section  
16 compared to the amount the fiduciary determines or estimates is, during the  
17 current or preceding accounting periods:

18 (A) the entity's operating income;

19 (B) the proceeds of the entity's sale or other disposition  
20 of:

21 (i) all or part of the business or other activity  
22 conducted by the entity;

23 (ii) one or more business assets that are not sold  
24 to customers in the ordinary course of the business or other activity  
25 conducted by the entity; or

26 (iii) one or more assets other than business assets,  
27 unless the entity's primary activity is to invest in assets to realize gain  
28 on the disposition of all or some of the assets;

29 (C) if the entity's primary activity is to invest in  
30 assets to realize gain on the disposition of all or some of the assets, the  
31 gain realized on the disposition;

32 (D) the entity's regular, periodic entity distributions;

33 (E) the amount of money the entity has accumulated;

34 (F) the amount of money the entity has borrowed;

35 (G) the amount of money the entity has received from the  
36 sources described in § 28-77-407, § 28-77-410, § 28-77-411, and § 29-77-412;

1 and

2 (H) the amount of money the entity has received from a  
3 source not otherwise described in this subdivision (f)(3)(H); and

4 (4) any other factor the fiduciary determines is relevant.

5 (g) If, after applying subsections (c) through (f) of this section, a  
6 fiduciary determines that a part of an entity distribution is a capital  
7 distribution but is in doubt about the amount of the entity distribution  
8 which is a capital distribution, the fiduciary shall allocate to principal  
9 the amount of the entity distribution which is in doubt.

10 (h) If a fiduciary receives additional information about the  
11 application of this section to an entity distribution before the fiduciary  
12 has paid part of the entity distribution to a beneficiary, the fiduciary may  
13 consider the additional information before making the payment to the  
14 beneficiary and may change a decision to make the payment to the beneficiary.

15 (i) If a fiduciary receives additional information about the  
16 application of this section to an entity distribution after the fiduciary has  
17 paid part of the entity distribution to a beneficiary, the fiduciary is not  
18 required to change or recover the payment to the beneficiary but may consider  
19 that information in determining whether to exercise the power to adjust under  
20 § 28-77-203.

21  
22 28-77-402. Distribution from trust or estate.

23 A fiduciary shall allocate to income an amount received as a  
24 distribution of income, including a unitrust distribution under § 28-77-301  
25 et seq., from a trust or estate in which the fiduciary has an interest, other  
26 than an interest the fiduciary purchased in a trust that is an investment  
27 entity, and shall allocate to principal an amount received as a distribution  
28 of principal from the trust or estate. If a fiduciary purchases, or receives  
29 from a settlor, an interest in a trust that is an investment entity, § 28-77-  
30 401, § 28-77-415, or § 28-77-416 applies to a receipt from the trust.

31  
32 28-77-403. Business or other activity conducted by fiduciary.

33 (a) This section applies to a business or other activity conducted by  
34 a fiduciary if the fiduciary determines that it is in the interests of the  
35 beneficiaries to account separately for the business or other activity  
36 instead of:



1           (1) accounting for the business or other activity as part of the  
 2 fiduciary's general accounting records; or

3           (2) conducting the business or other activity through an entity  
 4 described in § 28-77-401(a)(2)(A).

5           (b) A fiduciary may account separately under this section for the  
 6 transactions of a business or other activity, whether or not assets of the  
 7 business or other activity are segregated from other assets held by the  
 8 fiduciary.

9           (c) A fiduciary that accounts separately under this section for a  
 10 business or other activity:

11           (1) may determine:

12                   (A) the extent to which the net cash receipts of the  
 13 business or other activity must be retained for:

14                           (i) working capital;

15                           (ii) the acquisition or replacement of fixed assets;

16 and

17                           (iii) other reasonably foreseeable needs of the  
 18 business or other activity; and

19                   (B) the extent to which the remaining net cash receipts  
 20 are accounted for as principal or income in the fiduciary's general  
 21 accounting records for the trust;

22           (2) may make a determination under subdivision (c)(1) of this  
 23 section separately and differently from the fiduciary's decisions concerning  
 24 distributions of income or principal; and

25           (3) shall account for the net amount received from the sale of  
 26 an asset of the business or other activity, other than a sale in the ordinary  
 27 course of the business or other activity, as principal in the fiduciary's  
 28 general accounting records for the trust, to the extent the fiduciary  
 29 determines that the net amount received is no longer required in the conduct  
 30 of the business or other activity.

31           (d) Activities for which a fiduciary may account separately under this  
 32 section include:

33                   (1) retail, manufacturing, service, and other traditional  
 34 business activities;

35                   (2) farming;

36                   (3) raising and selling livestock and other animals;

- 1           (4) managing rental properties;
- 2           (5) extracting minerals, water, and other natural resources;
- 3           (6) growing and cutting timber;
- 4           (7) an activity to which § 28-77-414, § 28-77-415, or § 28-77-
- 5 416 applies; and
- 6           (8) any other business conducted by the fiduciary.

7

8                           Part 2 – Receipts Not Normally Apportioned

9

10           28-77-404. Principal receipts.

11           A fiduciary shall allocate to principal:

12                   (1) to the extent not allocated to income under this chapter, an  
 13 asset received from:

- 14                           (A) an individual during the individual’s lifetime;
- 15                           (B) an estate;
- 16                           (C) a trust on termination of an income interest; or
- 17                           (D) a payor under a contract naming the fiduciary as  
 18 beneficiary;

19                   (2) except as otherwise provided in this subchapter, money or  
 20 other property received from the sale, exchange, liquidation, or change in  
 21 form of a principal asset;

22                   (3) an amount recovered from a third party to reimburse the  
 23 fiduciary because of a disbursement described in § 28-77-502(a) or for  
 24 another reason to the extent not based on loss of income;

25                   (4) proceeds of property taken by eminent domain, except that  
 26 proceeds awarded for loss of income in an accounting period are income if a  
 27 current income beneficiary had a mandatory income interest during the period;

28                   (5) net income received in an accounting period during which  
 29 there is no beneficiary to which a fiduciary may or must distribute income;  
 30 and

31                   (6) other receipts as provided in Part 3.

32

33           28-77-405. Rental property.

34           To the extent a fiduciary does not account for the management of rental  
 35 property as a business under § 28-77-403, the fiduciary shall allocate to  
 36 income an amount received as rent of real or personal property, including an

1 amount received for cancellation or renewal of a lease. An amount received as  
2 a refundable deposit, including a security deposit or a deposit that is to be  
3 applied as rent for future periods:

4 (1) must be added to principal and held subject to the terms of  
5 the lease, except as otherwise provided by law other than this chapter; and

6 (2) is not allocated to income or available for distribution to  
7 a beneficiary until the fiduciary's contractual obligations have been  
8 satisfied with respect to that amount.

9  
10 28-77-406. Receipt on obligation to be paid in money.

11 (a) This section does not apply to an obligation to which § 28-77-409,  
12 § 28-77-410, § 28-77-411, § 28-77-412, § 28-77-414, § 28-77-415, or § 28-77-  
13 416 applies.

14 (b) A fiduciary shall allocate to income, without provision for  
15 amortization of premium, an amount received as interest on an obligation to  
16 pay money to the fiduciary, including an amount received as consideration for  
17 prepaying principal.

18 (c) A fiduciary shall allocate to principal an amount received from  
19 the sale, redemption, or other disposition of an obligation to pay money to  
20 the fiduciary. A fiduciary shall allocate to income the increment in value of  
21 a bond or other obligation for the payment of money bearing no stated  
22 interest but payable or redeemable, at maturity or another future time, in an  
23 amount that exceeds the amount in consideration of which it was issued.

24  
25 28-77-407. Insurance policy or contract.

26 (a) This section does not apply to a contract to which § 28-77-409  
27 applies.

28 (b) Except as otherwise provided in subsection (c) of this section, a  
29 fiduciary shall allocate to principal the proceeds of a life insurance policy  
30 or other contract received by the fiduciary as beneficiary, including a  
31 contract that insures against damage to, destruction of, or loss of title to  
32 an asset. The fiduciary shall allocate dividends on an insurance policy to  
33 income to the extent premiums on the policy are paid from income and to  
34 principal to the extent premiums on the policy are paid from principal.

35 (c) A fiduciary shall allocate to income proceeds of a contract that  
36 insures the fiduciary against loss of:

- 1           (1) occupancy or other use by a current income beneficiary;
- 2           (2) income; or
- 3           (3) subject to § 28-77-403, profits from a business.

4

5                           Part 3 – Receipts Normally Apportioned

6

7           28-77-408. Insubstantial allocation not required.

8           (a) If a fiduciary determines that an allocation between income and  
 9 principal required by § 28-77-409, § 28-77-410, § 28-77-411, § 28-77-412, or  
 10 § 28-77-415 is insubstantial, the fiduciary may allocate the entire amount to  
 11 principal, unless § 28-77-203(e) applies to the allocation.

12           (b) A fiduciary may presume an allocation is insubstantial under  
 13 subsection (a) of this section if:

14                   (1) the amount of the allocation would increase or decrease net  
 15 income in an accounting period, as determined before the allocation, by less  
 16 than 10 percent; and

17                   (2) the asset producing the receipt to be allocated has a fair  
 18 market value less than 10 percent of the total fair market value of the  
 19 assets owned or held by the fiduciary at the beginning of the accounting  
 20 period.

21           (c) The power to make a determination under subsection (a) of this  
 22 section may be:

23                   (1) exercised by a co-fiduciary in the manner described in § 28-  
 24 77-203(f); or

25                   (2) released or delegated for a reason described in § 28-77-  
 26 203(g) and in the manner described in § 28-77-203(h).

27

28           28-77-409. Deferred compensation, annuity, or similar payment.

29           (a) In this section:

30                   (1) “Internal income of a separate fund” means the amount  
 31 determined under subsection (b) of this section.

32                   (2) “Marital trust” means a trust:

33                           (A) of which the settlor’s surviving spouse is the only  
 34 current income beneficiary and is entitled to a distribution of all the  
 35 current net income of the trust; and

36                           (B) that qualifies for a marital deduction with respect to

1 the settlor's estate under Section 2056 of the Internal Revenue Code of 1986,  
2 as amended, 26 U.S.C. Section 2056, as amended, because:

3 (i) an election to qualify for a marital deduction  
4 under Section 2056(b)(7) of the Internal Revenue Code of 1986, as amended, 26  
5 U.S.C. Section 2056(b)(7), as amended, has been made; or

6 (ii) the trust qualifies for a marital deduction  
7 under Section 2056(b)(5) of the Internal Revenue Code of 1986, as amended, 26  
8 U.S.C. Section 2056(b)(5), as amended.

9 (3) "Payment" means an amount a fiduciary may receive over a  
10 fixed number of years or during the life of one or more individuals because  
11 of services rendered or property transferred to the payor in exchange for  
12 future amounts the fiduciary may receive. The term includes an amount  
13 received in money or property from the payor's general assets or from a  
14 separate fund created by the payor.

15 (4) "Separate fund" includes a private or commercial annuity, an  
16 individual retirement account, and a pension, profit-sharing, stock-bonus, or  
17 stock-ownership plan.

18 (b) For each accounting period, the following rules apply to a  
19 separate fund:

20 (1) The fiduciary shall determine the internal income of the  
21 separate fund as if the separate fund were a trust subject to this chapter.

22 (2) If the fiduciary cannot determine the internal income of the  
23 separate fund under subdivision (b)(1) of this section, the internal income  
24 of the separate fund is deemed to equal three percent of the value of the  
25 separate fund, according to the most recent statement of value preceding the  
26 beginning of the accounting period.

27 (3) If the fiduciary cannot determine the value of the separate  
28 fund under subdivision (b)(2) of this section, the value of the separate fund  
29 is deemed to equal the present value of the expected future payments, as  
30 determined under Section 7520 of the Internal Revenue Code of 1986, as  
31 amended, 26 U.S.C. Section 7520, as amended, for the month preceding the  
32 beginning of the accounting period for which the computation is made.

33 (c) A fiduciary shall allocate a payment received from a separate fund  
34 during an accounting period to income, to the extent of the internal income  
35 of the separate fund during the period, and the balance to principal.

36 (d) The fiduciary of a marital trust shall:

1           (1) withdraw from a separate fund the amount the current income  
2 beneficiary of the trust requests the fiduciary to withdraw, not greater than  
3 the amount by which the internal income of the separate fund during the  
4 accounting period exceeds the amount the fiduciary otherwise receives from  
5 the separate fund during the period;

6           (2) transfer from principal to income the amount the current  
7 income beneficiary requests the fiduciary to transfer, not greater than the  
8 amount by which the internal income of the separate fund during the period  
9 exceeds the amount the fiduciary receives from the separate fund during the  
10 period after the application of subdivision (d)(1) of this section; and

11           (3) distribute to the current income beneficiary as income:

12           (A) the amount of the internal income of the separate fund  
13 received or withdrawn during the period; and

14           (B) the amount transferred from principal to income under  
15 subdivision (d)(2) of this section.

16           (e) For a trust, other than a marital trust, of which one or more  
17 current income beneficiaries are entitled to a distribution of all the  
18 current net income, the fiduciary shall transfer from principal to income the  
19 amount by which the internal income of a separate fund during the accounting  
20 period exceeds the amount the fiduciary receives from the separate fund  
21 during the period.

22  
23           28-77-410. Liquidating asset.

24           (a) In this section, "liquidating asset" means an asset whose value  
25 will diminish or terminate because the asset is expected to produce receipts  
26 for a limited time. The term includes a leasehold, patent, copyright, royalty  
27 right, and right to receive payments during a period of more than one year  
28 under an arrangement that does not provide for the payment of interest on the  
29 unpaid balance.

30           (b) This section does not apply to a receipt subject to § 28-77-401, §  
31 28-77-409, § 28-77-411, § 28-77-412, § 28-77-414, § 28-77-415, § 28-77-416,  
32 or § 28-77-503.

33           (c) A fiduciary shall allocate:

34           (1) to income:

35           (A) a receipt produced by a liquidating asset, to the  
36 extent the receipt does not exceed five percent of the value of the asset; or

1                   (B) if the fiduciary cannot determine the value of the  
2 asset, 10 percent of the receipt; and

3                   (2) to principal, the balance of the receipt.

4  
5                   28-77-411. Minerals, water, and other natural resources.

6                   (a) To the extent that a trustee accounts for receipts from an  
7 interest in minerals or other natural resources pursuant to this section, the  
8 trustee shall allocate them as follows:

9                   (1) If received as nominal delay rental or nominal annual rent  
10 on a lease, a receipt must be allocated to income.

11                   (2) If received from a production payment, a receipt must be  
12 allocated to income if and to the extent that the agreement creating the  
13 production payment provides a factor for interest or its equivalent. The  
14 balance must be allocated to principal.

15                   (3) If an amount received as a royalty, shut-in-well payment,  
16 take-or-pay payment, bonus, or delay rental is more than nominal, 90 percent  
17 must be allocated to principal and the balance to income.

18                   (4) If an amount is received from a working interest or any  
19 other interest not provided for in paragraph (1), (2), or (3), 90 percent of  
20 the net amount received must be allocated to principal and the balance to  
21 income.

22                   (b) An amount received on account of an interest in water that is  
23 renewable must be allocated to income. If the water is not renewable, 90  
24 percent of the amount must be allocated to principal and the balance to  
25 income.

26                   (c) This chapter applies whether or not a decedent or donor was  
27 extracting minerals, water, or other natural resources before the interest  
28 became subject to the trust.

29                   (d) If a trust owns an interest in minerals, water, or other natural  
30 resources on January 1, 2000, the trustee may allocate receipts from the  
31 interest as provided in this chapter or in the manner used by the trustee  
32 before January 1, 2000. If the trust acquires an interest in minerals, water,  
33 or other natural resources after January 1, 2000, the trustee shall allocate  
34 receipts from the interest as provided in this chapter.

35  
36                   28-77-412. Timber.

1       (a) To the extent a fiduciary does not account for receipts from the  
2 sale of timber and related products as a business under § 28-77-403, the  
3 fiduciary shall allocate the net receipts:

4           (1) to income, to the extent the amount of timber cut from the  
5 land does not exceed the rate of growth of the timber;

6           (2) to principal, to the extent the amount of timber cut from  
7 the land exceeds the rate of growth of the timber or the net receipts are  
8 from the sale of standing timber;

9           (3) between income and principal if the net receipts are from  
10 the lease of land used for growing and cutting timber or from a contract to  
11 cut timber from land, by determining the amount of timber cut from the land  
12 under the lease or contract and applying the rules in subdivision (a)(1) and  
13 (2) of this section; or

14           (4) to principal, to the extent advance payments, bonuses, and  
15 other payments are not allocated under subdivisions (a)(1), (2), or (3) of  
16 this section.

17       (b) In determining net receipts to be allocated under subsection (a)  
18 of this section, a fiduciary shall deduct and transfer to principal a  
19 reasonable amount for depletion.

20       (c) This section applies to land owned or held by a fiduciary whether  
21 or not a settlor was cutting timber from the land before the fiduciary owned  
22 or held the property.

23       (d) If a fiduciary owns or holds an interest in land used for growing  
24 and cutting timber before the effective date of this chapter, the fiduciary  
25 may allocate net receipts from the sale of timber and related products as  
26 provided in this section or in the manner used by the fiduciary before the  
27 effective date of this chapter. If the fiduciary acquires an interest in land  
28 used for growing and cutting timber on or after the effective date of this  
29 chapter, the fiduciary shall allocate net receipts from the sale of timber  
30 and related products as provided in this section.

31  
32       28-77-413. Marital deduction property not productive of income.

33       (a) If a trust received property for which a gift or estate tax  
34 marital deduction was allowed and the settlor's spouse holds a mandatory  
35 income interest in the trust, the spouse may require the trustee, to the  
36 extent the trust assets otherwise do not provide the spouse with sufficient



1 income from or use of the trust assets to qualify for the deduction, to:

2 (1) make property productive of income;

3 (2) convert property to property productive of income within a  
4 reasonable time; or

5 (3) exercise the power to adjust under § 28-77-203.

6 (b) The trustee may decide which action or combination of actions in  
7 subsection (a) of this section to take.

8  
9 28-77-414. Derivative or option.

10 (a) In this section, "derivative" means a contract, instrument, other  
11 arrangement, or combination of contracts, instruments, or other arrangements,  
12 the value, rights, and obligations of which are, in whole or in part,  
13 dependent on or derived from an underlying tangible or intangible asset,  
14 group of tangible or intangible assets, index, or occurrence of an event. The  
15 term includes stocks, fixed income securities, and financial instruments and  
16 arrangements based on indices, commodities, interest rates, weather-related  
17 events, and credit-default events.

18 (b) To the extent a fiduciary does not account for a transaction in  
19 derivatives as a business under § 28-77-403, the fiduciary shall allocate 10  
20 percent of receipts from the transaction and 10 percent of disbursements made  
21 in connection with the transaction to income and the balance to principal.

22 (c) Subsection (d) of this section applies if:

23 (1) a fiduciary:

24 (A) grants an option to buy property from a trust, whether  
25 or not the trust owns the property when the option is granted;

26 (B) grants an option that permits another person to sell  
27 property to the trust; or

28 (C) acquires an option to buy property for the trust or an  
29 option to sell an asset owned by the trust; and

30 (2) the fiduciary or other owner of the asset is required to  
31 deliver the asset if the option is exercised.

32 (d) If this subsection applies, the fiduciary shall allocate 10  
33 percent to income and the balance to principal of the following amounts:

34 (1) an amount received for granting the option;

35 (2) an amount paid to acquire the option; and

36 (3) gain or loss realized on the exercise, exchange, settlement,

1 offset, closing, or expiration of the option.

2  
3 28-77-415. Asset-backed security.

4 (a) Except as otherwise provided in subsection (b) of this section, a  
5 fiduciary shall allocate to income a receipt from or related to an asset-  
6 backed security, to the extent the payor identifies the payment as being from  
7 interest or other current return, and to principal the balance of the  
8 receipt.

9 (b) If a fiduciary receives one or more payments in exchange for part  
10 or all of the fiduciary's interest in an asset-backed security, including a  
11 liquidation or redemption of the fiduciary's interest in the security, the  
12 fiduciary shall allocate to income 10 percent of receipts from the  
13 transaction and 10 percent of disbursements made in connection with the  
14 transaction, and to principal the balance of the receipts and disbursements.

15  
16 28-77-416. Other financial instrument or arrangement.

17 A fiduciary shall allocate receipts from or related to a financial  
18 instrument or arrangement not otherwise addressed by this chapter. The  
19 allocation must be consistent with § 28-77-414 and § 28-77-415.

20  
21 Subchapter 5 – Allocation of Disbursements

22  
23 28-77-501. Disbursement from income.

24 Subject to § 28-77-504, and except as otherwise provided in § 28-77-  
25 601(c)(2) or (3), a fiduciary shall disburse from income:

26 (1) one-half of:

27 (A) the regular compensation of the fiduciary and any  
28 person providing investment advisory, custodial, or other services to the  
29 fiduciary, to the extent income is sufficient; and

30 (B) an expense for an accounting, judicial or nonjudicial  
31 proceeding, or other matter that involves both income and successive  
32 interests, to the extent income is sufficient;

33 (2) the balance of the disbursements described in subdivision  
34 (1) of this section, to the extent a fiduciary that is an independent person  
35 determines that making those disbursements from income would be in the  
36 interests of the beneficiaries;

1           (3) another ordinary expense incurred in connection with  
2 administration, management, or preservation of property and distribution of  
3 income, including interest, an ordinary repair, regularly recurring tax  
4 assessed against principal, and an expense of an accounting, judicial or  
5 nonjudicial proceeding, or other matter that involves primarily an income  
6 interest, to the extent income is sufficient; and

7           (4) a premium on insurance covering loss of a principal asset or  
8 income from or use of the asset.

9  
10         28-77-502. Disbursement from principal.

11         (a) Subject to § 28-77-505, and except as otherwise provided in § 28-  
12 77-601(c)(2), a fiduciary shall disburse from principal:

13           (1) the balance of the disbursements described in § 28-77-501(1)  
14 and (3), after application of § 28-77-501(2);

15           (2) the fiduciary's compensation calculated on principal as a  
16 fee for acceptance, distribution, or termination;

17           (3) a payment of an expense to prepare for or execute a sale or  
18 other disposition of property;

19           (4) a payment on the principal of a trust debt;

20           (5) a payment of an expense of an accounting, judicial or  
21 nonjudicial proceeding, or other matter that involves primarily principal,  
22 including a proceeding to construe the terms of the trust or protect  
23 property;

24           (6) a payment of a premium for insurance, including title  
25 insurance, not described in § 28-77-501(4), of which the fiduciary is the  
26 owner and beneficiary;

27           (7) a payment of an estate or inheritance tax or other tax  
28 imposed because of the death of a decedent, including penalties, apportioned  
29 to the trust; and

30           (8) a payment:

31                 (A) related to environmental matters, including:

32                         (i) reclamation;

33                         (ii) assessing environmental conditions;

34                         (iii) remedying and removing environmental  
35 contamination;

36                         (iv) monitoring remedial activities and the release

1 of substances;

2 (v) preventing future releases of substances;

3 (vi) collecting amounts from persons liable or  
 4 potentially liable for the costs of activities described in

5 subdivisions(a)(8)(A)(i) through (v) of this section;

6 (vii) penalties imposed under environmental laws or  
 7 regulations;

8 (viii) other actions to comply with environmental  
 9 laws or regulations;

10 (ix) statutory or common law claims by third  
 11 parties; and

12 (x) defending claims based on environmental matters;  
 13 and

14 (B) for a premium for insurance for matters described in  
 15 subdivision (a)(8)(A) of this section.

16 (b) If a principal asset is encumbered with an obligation that  
 17 requires income from the asset to be paid directly to a creditor, the  
 18 fiduciary shall transfer from principal to income an amount equal to the  
 19 income paid to the creditor in reduction of the principal balance of the  
 20 obligation.

21  
 22 28-77-503. Transfer from income to principal for depreciation.

23 (a) In this section, "depreciation" means a reduction in value due to  
 24 wear, tear, decay, corrosion, or gradual obsolescence of a tangible asset  
 25 having a useful life of more than one year.

26 (b) A fiduciary may transfer to principal a reasonable amount of the  
 27 net cash receipts from a principal asset that is subject to depreciation, but  
 28 may not transfer any amount for depreciation:

29 (1) of the part of real property used or available for use by a  
 30 beneficiary as a residence;

31 (2) of tangible personal property held or made available for the  
 32 personal use or enjoyment of a beneficiary; or

33 (3) under this section, to the extent the fiduciary accounts:

34 (A) under § 28-77-410 for the asset; or

35 (B) under § 28-77-403 for the business or other activity  
 36 in which the asset is used.

1       (c) An amount transferred to principal under this section need not be  
2 separately held.

3  
4       28-77-504. Reimbursement of income from principal.

5       (a) If a fiduciary makes or expects to make an income disbursement  
6 described in subsection (b) of this section, the fiduciary may transfer an  
7 appropriate amount from principal to income in one or more accounting periods  
8 to reimburse income.

9       (b) To the extent the fiduciary has not been and does not expect to be  
10 reimbursed by a third party, income disbursements to which subsection (a) of  
11 this section applies include:

12           (1) an amount chargeable to principal but paid from income  
13 because principal is illiquid;

14           (2) a disbursement made to prepare property for sale, including  
15 improvements and commissions; and

16           (3) a disbursement described in § 28-77-502(a).

17       (c) If an asset whose ownership gives rise to an income disbursement  
18 becomes subject to a successive interest after an income interest ends, the  
19 fiduciary may continue to make transfers under subsection (a) of this  
20 section.

21  
22       28-77-505. Reimbursement of principal from income.

23       (a) If a fiduciary makes or expects to make a principal disbursement  
24 described in subsection (b) of this section, the fiduciary may transfer an  
25 appropriate amount from income to principal in one or more accounting periods  
26 to reimburse principal or provide a reserve for future principal  
27 disbursements.

28       (b) To the extent a fiduciary has not been and does not expect to be  
29 reimbursed by a third party, principal disbursements to which subsection (a)  
30 of this section applies include:

31           (1) an amount chargeable to income but paid from principal  
32 because income is not sufficient;

33           (2) the cost of an improvement to principal, whether a change to  
34 an existing asset or the construction of a new asset, including a special  
35 assessment;

36           (3) a disbursement made to prepare property for rental,

1 including tenant allowances, leasehold improvements, and commissions;

2 (4) a periodic payment on an obligation secured by a principal  
3 asset, to the extent the amount transferred from income to principal for  
4 depreciation is less than the periodic payment; and

5 (5) a disbursement described in § 28-77-502(a).

6 (c) If an asset whose ownership gives rise to a principal disbursement  
7 becomes subject to a successive interest after an income interest ends, the  
8 fiduciary may continue to make transfers under subsection (a) of this  
9 section.

10  
11 28-77-506. Income taxes.

12 (a) A tax required to be paid by a fiduciary which is based on  
13 receipts allocated to income must be paid from income.

14 (b) A tax required to be paid by a fiduciary which is based on  
15 receipts allocated to principal must be paid from principal, even if the tax  
16 is called an income tax by the taxing authority.

17 (c) Subject to subsection (d) of this section and § 28-77-504, § 28-  
18 77-505, and § 28-77-507, a tax required to be paid by a fiduciary on a share  
19 of an entity's taxable income in an accounting period must be paid from:

20 (1) income and principal proportionately to the allocation  
21 between income and principal of receipts from the entity in the period; and

22 (2) principal to the extent the tax exceeds the receipts from  
23 the entity in the period.

24 (d) After applying subsections (a) through (c) of this section, a  
25 fiduciary shall adjust income or principal receipts, to the extent the taxes  
26 the fiduciary pays are reduced because of a deduction for a payment made to a  
27 beneficiary.

28  
29 28-77-507. Adjustment between income and principal because of taxes.

30 (a) A fiduciary may make an adjustment between income and principal to  
31 offset the shifting of economic interests or tax benefits between current  
32 income beneficiaries and successor beneficiaries which arises from:

33 (1) an election or decision the fiduciary makes regarding a tax  
34 matter, other than a decision to claim an income tax deduction to which  
35 subsection (b) of this section applies;

36 (2) an income tax or other tax imposed on the fiduciary or a

1 beneficiary as a result of a transaction involving the fiduciary or a  
2 distribution by the fiduciary; or

3 (3) ownership by the fiduciary of an interest in an entity a  
4 part of whose taxable income, whether or not distributed, is includable in  
5 the taxable income of the fiduciary or a beneficiary.

6 (b) If the amount of an estate tax marital or charitable deduction is  
7 reduced because a fiduciary deducts an amount paid from principal for income  
8 tax purposes instead of deducting it for estate tax purposes and, as a  
9 result, estate taxes paid from principal are increased and income taxes paid  
10 by the fiduciary or a beneficiary are decreased, the fiduciary shall charge  
11 each beneficiary that benefits from the decrease in income tax to reimburse  
12 the principal from which the increase in estate tax is paid. The total  
13 reimbursement must equal the increase in the estate tax, to the extent the  
14 principal used to pay the increase would have qualified for a marital or  
15 charitable deduction but for the payment. The share of the reimbursement for  
16 each fiduciary or beneficiary whose income taxes are reduced must be the same  
17 as its share of the total decrease in income tax.

18 (c) A fiduciary that charges a beneficiary under subsection (b) of  
19 this section may offset the charge by obtaining payment from the beneficiary,  
20 withholding an amount from future distributions to the beneficiary, or  
21 adopting another method or combination of methods.

22  
23 Subchapter 6 – Death of Individual or Termination of Income Interest

24  
25 28-77-601. Determination and distribution of net income.

26 (a) This section applies when:

27 (1) the death of an individual results in the creation of an  
28 estate or trust; or

29 (2) an income interest in a trust terminates, whether the trust  
30 continues or is distributed.

31 (b) A fiduciary of an estate or trust with an income interest that  
32 terminates shall determine, under subsection (e) of this section and § 28-77-  
33 401 et seq., § 28-77-501 et seq., and § 28-77-701 et seq., the amount of net  
34 income and net principal receipts received from property specifically given  
35 to a beneficiary. The fiduciary shall distribute the net income and net  
36 principal receipts to the beneficiary that is to receive the specific

1 property.

2 (c) A fiduciary shall determine the income and net income of an estate  
3 or income interest in a trust which terminates, other than the amount of net  
4 income determined under subsection (b) of this section, under subchapters §  
5 28-77-401 et seq., § 28-77-501 et seq., and § 28-77-701 et seq. and by:

6 (1) including in net income all income from property used or  
7 sold to discharge liabilities;

8 (2) paying from income or principal, in the fiduciary's  
9 discretion, fees of attorneys, accountants, and fiduciaries, court costs and  
10 other expenses of administration, and interest on estate and inheritance  
11 taxes and other taxes imposed because of the decedent's death, but the  
12 fiduciary may pay the expenses from income of property passing to a trust for  
13 which the fiduciary claims a federal estate tax marital or charitable  
14 deduction only to the extent:

15 (A) the payment of the expenses from income will not cause  
16 the reduction or loss of the deduction; or

17 (B) the fiduciary makes an adjustment under § 28-77-  
18 507(b); and

19 (3) paying from principal other disbursements made or incurred  
20 in connection with the settlement of the estate or the winding up of an  
21 income interest that terminates, including:

22 (A) to the extent authorized by the decedent's will, the  
23 terms of the trust, or applicable law, debts, funeral expenses, disposition  
24 of remains, family allowances, estate and inheritance taxes, and other taxes  
25 imposed because of the decedent's death; and

26 (B) related penalties that are apportioned, by the  
27 decedent's will, the terms of the trust, or applicable law, to the estate or  
28 income interest that terminates.

29 (d) A fiduciary shall distribute net income in the manner described in  
30 § 28-77-602 to all other beneficiaries, including a beneficiary that receives  
31 a pecuniary amount in trust, even if the beneficiary holds an unqualified  
32 power to withdraw assets from the trust or other presently exercisable  
33 general power of appointment over the trust.

34 (e) A fiduciary may not reduce principal or income receipts from  
35 property described in subsection (b) of this section because of a payment  
36 described in § 28-77-501 or § 28-77-502, to the extent the decedent's will,



1 the terms of the trust, or applicable law requires the fiduciary to make the  
2 payment from assets other than the property or to the extent the fiduciary  
3 recovers or expects to recover the payment from a third party. The net income  
4 and principal receipts from the property must be determined by including the  
5 amount the fiduciary receives or pays regarding the property, whether the  
6 amount accrued or became due before, on, or after the date of the decedent's  
7 death or an income interest's terminating event, and making a reasonable  
8 provision for an amount the estate or income interest may become obligated to  
9 pay after the property is distributed.

10  
11 28-77-602. Distribution to successor beneficiary.

12 (a) Except to the extent § 28-77-301 et seq. applies for a beneficiary  
13 that is a trust, each beneficiary described in § 28-77-601(d) is entitled to  
14 receive a share of the net income equal to the beneficiary's fractional  
15 interest in undistributed principal assets, using values as of the  
16 distribution date. If a fiduciary makes more than one distribution of assets  
17 to beneficiaries to which this section applies, each beneficiary, including a  
18 beneficiary that does not receive part of the distribution, is entitled, as  
19 of each distribution date, to a share of the net income the fiduciary  
20 received after the decedent's death, an income interest's other terminating  
21 event, or the preceding distribution by the fiduciary.

22 (b) In determining a beneficiary's share of net income under  
23 subsection (a) of this section, the following rules apply:

24 (1) The beneficiary is entitled to receive a share of the net  
25 income equal to the beneficiary's fractional interest in the undistributed  
26 principal assets immediately before the distribution date.

27 (2) The beneficiary's fractional interest under subdivision  
28 (b)(1) of this section must be calculated:

29 (A) on the aggregate value of the assets as of the  
30 distribution date without reducing the value by any unpaid principal  
31 obligation; and

32 (B) without regard to:

33 (i) property specifically given to a beneficiary  
34 under the decedent's will or the terms of the trust; and

35 (ii) property required to pay pecuniary amounts not  
36 in trust.

1           (3) The distribution date under subdivision (b)(1) of this  
2 section may be the date as of which the fiduciary calculates the value of the  
3 assets if that date is reasonably near the date on which the assets are  
4 distributed.

5           (c) To the extent a fiduciary does not distribute under this section  
6 all the collected but undistributed net income to each beneficiary as of a  
7 distribution date, the fiduciary shall maintain records showing the interest  
8 of each beneficiary in the net income.

9           (d) If this section applies to income from an asset, a fiduciary may  
10 apply the rules in this section to net gain or loss realized from the  
11 disposition of the asset after the decedent's death, an income interest's  
12 terminating event, or the preceding distribution by the fiduciary.

13  
14           Subchapter 7 – Apportionment at Beginning and End of Income Interest

15  
16           28-77-701. When right to income begins and ends.

17           (a) An income beneficiary is entitled to net income in accordance with  
18 the terms of the trust from the date an income interest begins. The income  
19 interest begins on the date specified in the terms of the trust or, if no  
20 date is specified, on the date an asset becomes subject to:

21                   (1) the trust for the current income beneficiary; or

22                   (2) a successive interest for a successor beneficiary.

23           (b) An asset becomes subject to a trust under subdivision (a)(1) of  
24 this section:

25                   (1) for an asset that is transferred to the trust during the  
26 settlor's life, on the date the asset is transferred;

27                   (2) for an asset that becomes subject to the trust because of a  
28 decedent's death, on the date of the decedent's death, even if there is an  
29 intervening period of administration of the decedent's estate; or

30                   (3) for an asset that is transferred to a fiduciary by a third  
31 party because of a decedent's death, on the date of the decedent's death.

32           (c) An asset becomes subject to a successive interest under  
33 subdivision (a)(2) of this section on the day after the preceding income  
34 interest ends, as determined under subsection (d) of this section, even if  
35 there is an intervening period of administration to wind up the preceding  
36 income interest.

1       (d) An income interest ends on the day before an income beneficiary  
2 dies or another terminating event occurs or on the last day of a period  
3 during which there is no beneficiary to which a fiduciary may or must  
4 distribute income.

5  
6       28-77-702. Apportionment of receipts and disbursements when decedent  
7 dies or income interest begins.

8       (a) A fiduciary shall allocate an income receipt or disbursement,  
9 other than a receipt to which § 28-77-601(b) applies, to principal if its due  
10 date occurs before the date on which:

11           (1) for an estate, the decedent died; or

12           (2) for a trust or successive interest, an income interest  
13 begins.

14       (b) If the due date of a periodic income receipt or disbursement  
15 occurs on or after the date on which a decedent died or an income interest  
16 begins, a fiduciary shall allocate the receipt or disbursement to income.

17       (c) If an income receipt or disbursement is not periodic or has no due  
18 date, a fiduciary shall treat the receipt or disbursement under this section  
19 as accruing from day to day. The fiduciary shall allocate to principal the  
20 portion of the receipt or disbursement accruing before the date on which a  
21 decedent died or an income interest begins, and to income the balance.

22       (d) A receipt or disbursement is periodic under subsections (b) and  
23 (c) of this section if:

24           (1) the receipt or disbursement must be paid at regular  
25 intervals under an obligation to make payments; or

26           (2) the payor customarily makes payments at regular intervals.

27       (e) An item of income or obligation is due under this section on the  
28 date the payor is required to make a payment. If a payment date is not  
29 stated, there is no due date.

30       (f) Distributions to shareholders or other owners from an entity to  
31 which § 28-77-401 applies are due:

32           (1) on the date fixed by or on behalf of the entity for  
33 determining the persons entitled to receive the distribution;

34           (2) if no date is fixed, on the date of the decision by or on  
35 behalf of the entity to make the distribution; or

36           (3) if no date is fixed and the fiduciary does not know the date

1 of the decision by or on behalf of the entity to make the distribution, on  
2 the date the fiduciary learns of the decision.

3  
4 28-77-703. Apportionment when income interest ends.

5 (a) In this section, "undistributed income" means net income received  
6 on or before the date on which an income interest ends. The term does not  
7 include an item of income or expense which is due or accrued or net income  
8 that has been added or is required to be added to principal under the terms  
9 of the trust.

10 (b) Except as otherwise provided in subsection (c) of this section,  
11 when a mandatory income interest of a beneficiary ends, the fiduciary shall  
12 pay the beneficiary's share of the undistributed income that is not disposed  
13 of under the terms of the trust to the beneficiary or, if the beneficiary  
14 does not survive the date the interest ends, to the beneficiary's estate.

15 (c) If a beneficiary has an unqualified power to withdraw more than  
16 five percent of the value of a trust immediately before an income interest  
17 ends:

18 (1) the fiduciary shall allocate to principal the undistributed  
19 income from the portion of the trust which may be withdrawn; and

20 (2) subsection (b) of this section applies only to the balance  
21 of the undistributed income.

22 (d) When a fiduciary's obligation to pay a fixed annuity or a fixed  
23 fraction of the value of assets ends, the fiduciary shall prorate the final  
24 payment as required to preserve an income tax, gift tax, estate tax, or other  
25 tax benefit.

26  
27 Subchapter 8 – Miscellaneous Provisions

28  
29 28-77-801. Uniformity of application and construction.

30 In applying and construing this uniform act, consideration must be  
31 given to the need to promote uniformity of the law with respect to its  
32 subject matter among states that enact it.

33  
34 28-77-802. Relation to Electronic Signatures in Global and National  
35 Commerce Act.

36 This chapter modifies, limits, or supersedes the Electronic Signatures

1 in Global and National Commerce Act, 15 U.S.C. Section 7001 et seq., but does  
2 not modify, limit, or supersede Section 101(c) of that act, 15 U.S.C. Section  
3 7001(c), or authorize electronic delivery of any of the notices described in  
4 Section 103(b) of that act, 15 U.S.C. Section 7003(b).

5  
6 28-77-803. Application to trust or estate.

7 This chapter applies to a trust or estate existing or created on or  
8 after the effective date of this chapter, except as otherwise expressly  
9 provided in the terms of the trust or this chapter.

10  
11 SECTION 3. DO NOT CODIFY. Effective date.

12 This act takes effect on January 1, 2022.
