29	SECTION 1. Arkansas Code § 26-18-303(b), concerning the exceptions to

3	(i) The total number of holders of a gross receipts		
4	tax permit that remitted gross receipts or compensating use tax in the city

6	(ii) The amount of tax revenue generated by		
7	reference to the North American Industry Classification System four-digit		
8	code; and		
9	(iii) The total number of holders of a gross		
10	receipts tax permit for each four-digit code number.		
11	(C) A request made by a city or county for the report		
12	under subdivision (b)(26)(A) of this section:		
13	(i) May be made at any time; and		
14	(ii) Shall be submitted electronically by an		
15	official of the city or county.		
16	(D) In order to receive a report under subdivision		
17	(b)(26)(A) of this section, the city or county making the request shall		
18	register for an account with the Arkansas Taxpayer Access Point or its		
19	successor.		
20	(E) The department shall not discuss any details of the		
21	information within an electronic report provided under this subdivision
