27 SECTION 53. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BOARD OF
29 EXAMINERS IN SPEECH-LANGUAGE PATHOLOGY AND AUDIOLOGY - INVESTIGATOR. The
30 Board of Examiners in Speech-Language Pathology and Audiology shall contract
31 with an outside investigator, as needed, to perform investigations and
32 conduct inspections of alleged wrongdoing. The duties of the investigator
33 hired shall include, but not be limited to, investigation and inspection of
34 all complaints as determined by the Board, to determine whether or not any
35 persons have

36 (1) Practiced their profession in such a way as to endanger the general

1 health and welfare of the public; or
2 (2) Otherwise violated the practice act or rules and regulations of the
3 Speech-Language Pathology and Audiology Board.

4 The provisions of this section shall be in effect only from July 1, ~~2020~~

7 SECTION 54. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS
9 SPINAL CORD COMMISSION - LINE ITEM TRANSFER. Any savings made in the State
10 Appropriation may, after receiving advice and approval of the Department of
11 Finance and Administration, be transferred to the Spinal Treatment Program.

12 The provisions of this section shall be in effect only from July 1, ~~2020~~
13 2021 through June 30, ~~2021~~ 2022.

14
15 SECTION 55. SPECIAL LANGUAGE. CODE AMENDMENT. Arkansas Code § 6-81-1405
16 is amended to read as follows:

17 6-81-1405. Amount of loans - Maximum.

18 (a) The Arkansas State Board of Nursing may make a loan to any
19 applicant in an amount calculated to pay the applicant's tuition,
20 maintenance, and other education expenses while he or she is enrolled in a
21 program of nursing education as described in this subchapter.

22 (b) The total of the loans made to any one (1) student under this
23 subchapter shall not exceed ~~twenty~~ forty thousand dollars ~~(\$20,000)~~
24 (\$40,000).

25
26 SECTION 56. SPECIAL LANGUAGE - CODE AMENDMENT. Arkansas Code Title 17,
27 Chapter 87, Subchapter 3, is amended to add additional sections to read as
28 follows:

29 17-87-315. Fees and disposition of fees related to Full Independent
30 Practice Credentialing Committee.

31 (a) The Full Independent Practice Credentialing Committee shall
32 establish fees relating to application, certification, endorsement,
33 certification for prescriptive authority, certification renewal, and other
34 reasonable services as determined by the committee.

35 (b) The committee may promulgate rules as necessary to administer the
36 fees, rates, or charges for application, certification, endorsement,

1 certification for prescriptive authority, certification renewal, and other
2 reasonable services.

3 (c)(1) Revenue collected under § 17-87-314 shall be deposited into the
4 State Treasury as cash funds to be known as the Full Independent Practice
5 Credentialing Committee Fund to be used as set out in § 17-87-314.

6 (2) The cash fund established in this section shall be maintained
7 and administered by the committee and shall be used for the payment of
8 personal services, operating expenses and for the payment of mileage and per
9 diem of committee members for attendance at meetings, briefings and hearings.

10
11 SECTION 57. SPECIAL LANGUAGE - CODE AMENDMENT. Arkansas Code § 25-16-
12 903, concerning stipend authorization of sixty dollars (\$60) for state
13 boards, is amended to add an additional subdivision to read as follows:

14 (70) The Full Independent Practice Credentialing Committee.

15
16 SECTION 58. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
17 authorized by this act shall be limited to the appropriation for such agency
18 and funds made available by law for the support of such appropriations; and
19 the restrictions of the State Procurement Law, the General Accounting and
20 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
21 Procedures and Restrictions Act, or their successors, and other fiscal
22 control laws of this State, where applicable, and regulations promulgated by
23 the Department of Finance and Administration, as authorized by law, shall be
24 strictly complied with in disbursement of said funds.

25
26 SECTION 59. LEGISLATIVE INTENT. It is the intent of the General
27 Assembly that any funds disbursed under the authority of the appropriations
28 contained in this act shall be in compliance with the stated reasons for
29 which this act was adopted, as evidenced by the Agency Requests, Executive
30 Recommendations and Legislative Recommendations contained in the budget
31 manuals prepared by the Department of Finance and Administration, letters, or
32 summarized oral testimony in the official minutes of the Arkansas Legislative
33 Council or Joint Budget Committee which relate to its passage and adoption.

34
35 SECTION 60. EMERGENCY CLAUSE. It is found and determined by the
36 General Assembly, that the Constitution of the State of Arkansas prohibits

1 the appropriation of funds for more than a one (1) year period; that the
2 effectiveness of this Act on July 1, 2021 is essential to the operation of
3 the agency for which the appropriations in this Act are provided, and that in
4 the event of an extension of the legislative session, the delay in the
5 effective date of this Act beyond July 1, 2021 could work irreparable harm
6 upon the proper administration and provision of essential governmental
7 programs. Therefore, an emergency is hereby declared to exist and this Act
8 being necessary for the immediate preservation of the public peace, health
9 and safety shall be in full force and effect from and after July 1, 2021.
