| 17 | SECTION 2. EMERGENCY CLAUSE. It is found and determined by the |
| 18 | General Assembly of the State of Arkansas that citizen participation in the |
| 19 | democratic process is crucial to a representative form of government; that it |
| 20 | is paramount for the State of Arkansas to ensure qualified electors have |
| 21 | adequate access to polling sites and alternative methods of casting a ballot |
| 22 | in federal and state elections during an emergency declaration under the |
| 23 | Arkansas Emergency Services Act of 1973, § 12-75-101 et seq.; that the |
| 24 | process used by election officials to begin the processing and canvassing of |
| 25 | absentee ballots is impacted by an emergency declaration; and that this act |
| 26 | is immediately necessary to ensure the right of all qualified electors to |
| 27 | have adequate access to polling sites and alternative methods of casting a |
| 28 | ballot in an election and for election officials to process and canvass |
| 29 | absentee ballots during an emergency declaration under the Arkansas Emergency |
| 30 | Services Act of 1973, § 12-75-101 et seq. Therefore, an emergency is |
| 31 | declared to exist, and this act being immediately necessary for the |
| 32 | preservation of the public peace, health, and safety shall become effective |
