SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 5 6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GRANTS TO 7 SCHOOL DISTRICTS. For the purposes of distributing the Grants To School 8 Districts appropriation in the Grants and Aid to Local School Districts and 9 Special Programs section of this Act, "school district" means a school 10 district which contracts with a school district in an adjoining state for the 11 education of some of the pupils within the Arkansas school district because 12 the portion of the school district wherein such pupils live is completely 13 separated from the remainder of the school district by a reservoir covering 14 at least 12,000 acres at normal water level, and where to attend school in 15 their own district, the pupils of said portion would be required to travel or 16 to be transported a distance (measured by the nearest highway or road route) 17 of more than 35 miles round trip and pass through another school district or 18 districts. The Department of Education shall distribute the monies 19 appropriated for Grants to School Districts in the Grants and Aid to Local 20 School Districts and Special Programs section of this Act to such school 21 districts as reimbursement for expenses incurred in educating the pupils 22 residing in the separated portion of the school district. The payments are to 23 be limited to the amount of available appropriation. Any appropriation titled "ENHANCED 17 STUDENT ACHIEVEMENT FUNDING" or abbreviated as "ESA" as named by SB605 of 18 2019 may also be known as "NATIONAL SCHOOL LUNCH" funding or abbreviated as 19 "NSL" and shall be used for the same purposes as set out in law.

20 The provisions of this section shall be in effect only from July 1, <del>2020</del> 21 <u>2021</u> through June 30, <del>2021</del> <u>2022.</u>

23 SECTION 33. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 24 authorized by this act shall be limited to the appropriation for such agency 25 and funds made available by law for the support of such appropriations; and 26 the restrictions of the State Procurement Law, the General Accounting and 27 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 28 Procedures and Restrictions Act, or their successors, and other fiscal 29 control laws of this State, where applicable, and regulations promulgated by 30 the Department of Finance and Administration, as authorized by law, shall be 31 strictly complied with in disbursement of said funds.

33 SECTION 34. LEGISLATIVE INTENT. It is the intent of the General 34 Assembly that any funds disbursed under the authority of the appropriations 35 contained in this act shall be in compliance with the stated reasons for 36 which this act was adopted, as evidenced by the Agency Requests, Executive

1	Recommendations and Legislative Recommendations contained in the budget
2	manuals prepared by the Department of Finance and Administration, letters, or
3	summarized oral testimony in the official minutes of the Arkansas Legislative
4	Council or Joint Budget Committee which relate to its passage and adoption.
5	
6	SECTION 35. EMERGENCY CLAUSE. It is found and determined by the
7	General Assembly, that the Constitution of the State of Arkansas prohibits
8	the appropriation of funds for more than a one (1) year period; that the
9	effectiveness of this Act on July 1, 2021 is essential to the operation of
10	the agency for which the appropriations in this Act are provided, and that in
11	the event of an extension of the legislative session, the delay in the
12	effective date of this Act beyond July 1, 2021 could work irreparable harm
13	upon the proper administration and provision of essential governmental
14	programs. Therefore, an emergency is hereby declared to exist and this Act
15	being necessary for the immediate preservation of the public peace, health
16	and safety shall be in full force and effect from and after July 1, 2021.
