Rules. 13 The Secretary of State may promulgate rules to administer this 14 subchapter. 15 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the 16 17 General Assembly of the State of Arkansas that the risk of exposure to 18 coronavirus 2019 (COVID-19) or to severe acute respiratory syndrome 19 coronavirus 2 (SARS-CoV-2) or any of its mutations is causing delays in 20 conducting business and satisfying requirements for notarization and signing of certain documents due to the inability to hold in-person meetings; that a 21 22 need exists to allow for remote witnessing of certain documents; and that 23 this act is immediately necessary because businesses in Arkansas will suffer, the question as to the legal effectiveness of signatures during a disaster 24 25 emergency can result in confusion and uncertainty, and it is the intent of the General Assembly that this act be retroactive to prevent further harm to 26 27 businesses and citizens. Therefore, an emergency is declared to exist, and 28 this act being immediately necessary for the preservation of the public 29 peace, health, and safety shall become effective on: 30 (1) The date of its approval by the Governor; 31 (2) If the bill is neither approved nor vetoed by the Governor, the expiration of the period of time during which the Governor may veto the 32 33 bill; or (3) If the bill is vetoed by the Governor and the veto is 34 35 overridden, the date the last house overrides the veto.
