18 ~~(6) “Limited liability company” or “domestic limited liability~~
 19 ~~company” means an organization formed under this chapter;~~

20 ~~(7) “Limited liability company interest” or “interest in the~~
 21 ~~limited liability company” means the interest that can be assigned under § 4-~~
 22 ~~32-704 and charged under § 4-32-705;~~

23 ~~(8) “Limited partnership” means a limited partnership formed~~
 24 ~~under the laws of any state or foreign country;~~

25 ~~(9) “Manager” or “managers” means, with respect to a limited~~
 26 ~~liability company that has set forth in its articles of organization that it~~
 27 ~~is to be managed by managers, the person or persons designated in accordance~~
 28 ~~with § 4-32-401;~~

29 ~~(10) “Member” or “members” means a person or persons who have~~
 30 ~~been admitted to membership in a limited liability company as provided in §~~
 31 ~~4-32-801 and who have not ceased to be members as provided in § 4-32-802;~~

32 ~~(11) “Operating agreement” means the written agreement which~~
 33 ~~shall be entered into among all of the members as to the conduct of the~~
 34 ~~business and affairs of a limited liability company;~~

35 ~~(12)(A) “Person” means an individual, a general partnership, a~~
 36 ~~limited partnership, a domestic or foreign limited liability company, a~~

1 trust, an estate, an association, a corporation, a custodian, a nominee and
2 other individual entity in its own or representative capacity, or any other
3 legal entity.

4 (B) "Person" includes a protected series;

5 (13) "Professional service" means any type of professional
6 service which may be legally performed only pursuant to a license or other
7 legally mandated personal authorization. For example: the personal service
8 rendered by certified public accountants, architects, engineers, dentists,
9 doctors, and attorneys at law; and

10 (14) "State" means a state, territory, or possession of the
11 United States, the District of Columbia, or the Commonwealth of Puerto Rico.

13 4-32-103. Name.

14 (a) The name of each limited liability company as set forth in its
15 articles of organization must contain the words "Limited Liability Company"
16 or "Limited Company" or the abbreviations "L.L.C.", "L.C.", "LLC", or "LC".
17 The word "Limited" may be abbreviated as "Ltd." and the word "Company" may be
18 abbreviated as "Co.".

19 (b) A limited liability company name must be distinguishable upon the
20 records of the Secretary of State from:

21 (1) The name of any limited liability company, limited
22 partnership, or corporation existing under the laws of this state or
23 authorized to transact business in this state; or

24 (2) Any name reserved under § 4-32-104.

25 (c) The provisions of subsection (b) of this section shall not apply
26 if the applicant files with the Secretary of State a certified copy of a
27 final decree of a court of competent jurisdiction establishing the prior
28 right of the applicant to the use of the name in this state.

29 (d) The name of a limited liability company which performs
30 professional service shall in addition contain the words "Professional
31 Limited Liability Company" or "Professional Limited Company" or the
32 abbreviations "P.L.L.C.", "P.L.C.", "PLLC", "PLC", and the words "Limited"
33 and "Company" may be abbreviated as "Ltd." or "Co." and may not contain the
34 name of any person who is not a member, except that the name of a former
35 member or member of a predecessor organization may continue to be included in
36 the name.

3 ~~(a) The exclusive right to use a name may be reserved by:~~

4 ~~(1) Any person intending to organize a limited liability company~~
5 ~~and to adopt that name;~~

6 ~~(2) Any limited liability company or any foreign limited~~
7 ~~liability company registered in this state that intends to adopt that name;~~

8 ~~(3) Any foreign limited liability company intending to register~~
9 ~~in this state and to adopt that name; or~~

10 ~~(4) Any person intending to organize a foreign limited liability~~
11 ~~company and to have it registered in this state and to adopt that name.~~

12 ~~(b) The reservation shall be made by filing with the Secretary of~~
13 ~~State an application, executed by the applicant, to reserve a specified name.~~
14 ~~If the Secretary of State finds that the name is available for use by a~~
15 ~~domestic or foreign limited liability company, the Secretary of State shall~~
16 ~~reserve the name of the exclusive use of the applicant for a period of one~~
17 ~~hundred twenty (120) days from and after the date the application is filed~~

19 ~~(c) The holder of a reserved limited liability company name may renew~~

32 ~~(a) A limited liability company may be organized under this chapter~~
33 ~~for any lawful purpose, including the performance of professional services~~
34 ~~and related activities. If the purpose for which a limited liability company~~
35 ~~is organized or its activities make it subject to a special provision of law,~~
36 ~~the limited liability company shall also comply with that provision.~~

1 ~~(b) A limited liability company shall possess and may exercise all~~
2 ~~powers and privileges granted by this chapter or by any other law or by its~~
3 ~~operating agreement, together with any powers incidental thereto, so far as~~
4 ~~such powers and privileges are necessary or convenient to the conduct,~~
5 ~~promotion, or attainment of the business, purposes, or activities of the~~
6 ~~limited liability company.~~

11 ~~(a) No limited liability company, domestic or foreign, shall conduct~~
12 ~~any business in this state under a fictitious name unless it first files with~~
13 ~~the Secretary of State a form supplied or approved by the Secretary of State~~
14 ~~giving the following information:~~

15 ~~(1) The fictitious name under which business is being or will be~~
16 ~~conducted by the applicant limited liability company;~~

17 ~~(2) A brief statement of the character of business to be~~
18 ~~conducted under the fictitious name; and~~

19 ~~(3) The name of the limited liability company, the state of~~
20 ~~organization, and location, giving the city and street address, of the~~
21 ~~registered office in the state of the applicant limited liability company.~~

22 ~~(b) Each such form shall be executed, without verification, in~~
23 ~~duplicate and filed with the Secretary of State. The Secretary of State shall~~
24 ~~retain one (1) counterpart; and the other counterpart, bearing the file marks~~
25 ~~of the Secretary of State, shall be returned to the limited liability~~
26 ~~company. However, the Secretary of State shall not accept such filing if the~~

4 ~~business in Arkansas under the specified fictitious name, such limited~~
5 ~~liability company shall be obligated to file with the Secretary of State a~~

13 ~~the obligations imposed upon the limited liability company under said~~

27 ~~bar any aggrieved party in such a situation from applying for equitable~~

31 ~~(a) A foreign limited liability company may register its name, if the~~
32 ~~name is distinguishable upon the records of the Secretary of State from the~~
33 ~~names of any limited liability company, limited partnership, partnership, or~~
34 ~~corporation existing under the laws of this state or authorized to transact~~
35 ~~business in this state.~~

36 ~~(b) A foreign limited liability company registers its name by~~

1 ~~delivering it to the Secretary of State for filing an application;~~

2 ~~(1) Setting forth its name, or its name with any addition~~
3 ~~required by § 4-32-103, the state or country and date of its formation, and a~~
4 ~~brief description of the nature of the business in which it is engaged; and~~

5 ~~(2) Accompanied by a certificate of existence or a document of~~
6 ~~similar import from the state or country in which it was formed.~~

7 ~~(c) The name is registered for the applicant's exclusive use upon the~~
8 ~~effective date of the application.~~

9 ~~(d)(1) A foreign limited liability company whose registration is~~
10 ~~effective may renew the registration for successive years by delivering to~~
11 ~~the Secretary of State for filing a renewal application, which complies with~~
12 ~~the requirements of subsection (b) of this section, between October 1 and~~
13 ~~December 31 of the preceding year.~~

14 ~~(2) The renewal application when filed renews the registration~~
15 ~~for the following calendar year.~~

16 ~~(e)(1) A foreign limited liability company whose registration is~~
17 ~~effective may thereafter qualify as a foreign limited liability company under~~
18 ~~the registered name or consent in writing to the use of that name by a~~
19 ~~limited liability company thereafter incorporated under this chapter, or by~~
20 ~~another foreign limited liability company thereafter authorized to transact~~

27 ~~4-32-201. Formation.~~

28
29 ~~One (1) or more persons may form a limited liability company by signing~~
30 ~~or causing to be signed articles of organization and delivering the signed~~
31 ~~articles to the Secretary of State for filing. The person or persons who sign~~
32 ~~the articles of organization causing the formation of a limited liability~~
33 ~~company need not be members of the limited liability company at the time of~~
34 ~~formation or after formation has occurred.~~

2 ~~The articles of organization shall set forth:~~

3 ~~(1) A name for the limited liability company that satisfies the~~
4 ~~requirements of § 4-32-103;~~

5 ~~(2) The information required by § 4-20-105(a); and~~

6 ~~(3) If management of the limited liability company is vested in~~
7 ~~a manager or managers, a statement to that effect.~~

8
9 ~~4-32-203. Amendment of articles of organization—Restatement.~~

10 ~~(a) The articles of organization of a limited liability company may be~~
11 ~~amended by filing articles of amendment with the Secretary of State. The~~
12 ~~articles of amendment shall set forth:~~

13 ~~(1) The name of the limited liability company;~~

14 ~~(2) The date the articles of organization were filed; and~~

15 ~~(3) The amendment to the articles of organization.~~

16 ~~(b) The articles of organization may be amended in any respects as may~~
17 ~~be desired, so long as the articles of organization as amended contain only~~
18 ~~provisions that may be lawfully contained in articles of organization at the~~
19 ~~time of making the amendment.~~

20 ~~(c) Articles of organization may be restated at any time. Restated~~
21 ~~articles of organization shall be filed with the Secretary of State and shall~~

28 ~~(a) Unless otherwise provided in any other section of this chapter,~~
29 ~~any document required by this chapter to be filed with the Secretary of State~~
30 ~~shall be executed:~~

31 ~~(1) By any manager if management of the limited liability~~
32 ~~company is vested in one (1) or more managers;~~

33 ~~(2) By any member if management of the limited liability company~~
34 ~~is reserved to the members;~~

35 ~~(3) If the limited liability company has not been formed, by the~~

11 ~~(a) The original signed copy, together with a duplicate copy that may~~
12 ~~be either a signed, photocopied, or conformed copy of the articles of~~
13 ~~organization or any other document required to be filed pursuant to this~~
14 ~~chapter, shall be delivered to the Secretary of State. If the Secretary of~~
15 ~~State determines that the documents conform to the filing provisions of this~~

4 ~~(a) Unless a delayed effective date is recited in the articles of~~
5 ~~organization, a limited liability company is formed when the articles of~~
6 ~~organization are delivered to the Secretary of State for filing, even if the~~
7 ~~Secretary of State is unable at the time of delivery to make the~~
8 ~~determination required for filing by § 4-32-1308. If the articles of~~
9 ~~organization, as delivered to the Secretary of State, do not conform to the~~
10 ~~filing provisions of this chapter and are not brought into conformance within~~
11 ~~the time period prescribed by § 4-32-1308, the existence of the limited~~
12 ~~liability company terminates at the end of such time period.~~

13 ~~(b) Each copy of the articles of organization stamped "filed" and~~
14 ~~marked with the filing date is conclusive evidence that all conditions~~

19 ~~Subchapter 3—Relations of Members and Managers to Persons Dealing with the~~
20 ~~Limited Liability Company~~

22 ~~4-32-301. Agency power of members and managers.~~

23 ~~(a) Except as provided in subsection (b) of this section, every member~~
24 ~~is an agent of the limited liability company for the purpose of its business~~
25 ~~or affairs, and the act of any member, including, but not limited to, the~~
26 ~~execution in the name of the limited liability company of any instrument, for~~
27 ~~apparently carrying on in the usual way the business or affairs of the~~
28 ~~limited liability company of which he or she is a member, binds the limited~~
29 ~~liability company, unless the member so acting has, in fact, no authority to~~
30 ~~act for the limited liability company in the particular matter, and the~~
31 ~~person with whom the member is dealing has knowledge of the fact that the~~
32 ~~member has no such authority.~~

33 ~~(b) If the articles of organization provide that management of the~~
34 ~~limited liability company is vested in a manager or managers:~~

35 ~~(1) No member solely by reason of being a member is an agent of~~
36 ~~the limited liability company; and~~

1 ~~(2) Every manager is an agent of the limited liability company~~
2 ~~for the purpose of its business or affairs, and the act of any manager,~~
3 ~~including, but not limited to, the execution in the name of the limited~~
4 ~~liability company of any instrument, for apparently carrying on in the usual~~
5 ~~way the business or affairs of the limited liability company of which he or~~
6 ~~she is a manager binds the limited liability company, unless the manager so~~
7 ~~acting has, in fact, no authority to act for the limited liability company in~~
8 ~~the particular matter, and the person with whom the manager is dealing has~~
9 ~~knowledge of the fact that the manager has no such authority.~~

10 ~~(c) An act of a manager or a member which is not apparently for the~~
11 ~~carrying on in the usual way the business or affairs of the limited liability~~
12 ~~company does not bind the limited liability company unless authorized in~~
13 ~~accordance with an operating agreement, at the time of the transaction or at~~
14 ~~any other time.~~

15 ~~(d) No act of a manager or member in contravention of a restriction on~~
16 ~~authority shall bind the limited liability company to persons having~~
17 ~~knowledge of the restriction.~~

19 ~~4-32-302. Admissions by members and managers.~~

20 ~~(a) Except as provided in subsection (b) of this section, an admission~~
21 ~~or representation made by any member concerning the business or affairs of a~~
22 ~~limited liability company within the scope of his or her authority as~~
23 ~~provided for by this chapter is evidence against the limited liability~~
24 ~~company.~~

25 ~~(b) If the articles of organization provide that management of the~~
26 ~~limited liability company is vested in a manager or managers:~~

27 ~~(1) An admission or representation made by a manager concerning~~
28 ~~the business or affairs of a limited liability company within the scope of~~
29 ~~the manager's authority as provided for by this chapter is evidence against~~
30 ~~the limited liability company; and~~

31 ~~(2) The admission or representation of any member, acting solely~~
32 ~~in the capacity of a member, shall not constitute evidence against the~~
33 ~~limited liability company.~~

34
35 ~~4-32-303. Limited liability company charged with knowledge of or~~
36 ~~notice to member or manager.~~

1 ~~(a) Except as provided in subsection (b) of this section, notice to~~
2 ~~any member of any matter relating to the business or affairs of the limited~~
3 ~~liability company, and the knowledge of the member acting in the particular~~
4 ~~matter, acquired while a member or known at the time of becoming a member,~~
5 ~~and the knowledge of any other member who reasonably could and should have~~
6 ~~communicated the knowledge to the acting member, operate as notice to or~~
7 ~~knowledge of the limited liability company, except in the case of a fraud on~~
8 ~~the limited liability company committed by or with the consent of that~~
9 ~~member.~~

10 ~~(b) If the articles of organization provide that management of the~~
11 ~~limited liability company is vested in a manager or managers:~~

12 ~~(1) Notice to any manager of any matter relating to the business~~
13 ~~or affairs of the limited liability company, and the knowledge of the manager~~
14 ~~acting in the particular matter, acquired while a manager or known at the~~
15 ~~time of becoming a manager, and the knowledge of any other manager who~~
16 ~~reasonably could and should have communicated the knowledge to the acting~~
17 ~~manager, operate as notice to or knowledge of the limited liability company,~~
18 ~~except in the case of a fraud on the limited liability company committed by~~

25 ~~Except for the personal liability for acts or omissions of those~~
26 ~~providing professional service as set forth in § 4-32-308, a person who is a~~
27 ~~member, manager, agent, or employee of a limited liability company is not~~
28 ~~liable for a debt, obligation, or liability of the limited liability company,~~
29 ~~whether arising in contract, tort, or otherwise or for the acts or omissions~~
30 ~~of any other member, manager, agent, or employee of the limited liability~~
31 ~~company.~~

32
33 ~~4-32-305. Parties to actions.~~

34 ~~A member of a limited liability company is not a proper party to a~~
35 ~~proceeding by or against a limited liability company, by reason of being a~~
36 ~~member of the limited liability company, except where the object of the~~

1 ~~proceeding is to enforce a member's right against or liability to the limited~~
2 ~~liability company or as otherwise provided in an operating agreement.~~

4 ~~4-32-306. Limited liability company may render professional service—~~
5 ~~Nonprofessional employees and agents—Members and managers need not be~~
6 ~~employees, etc.~~

7 ~~No limited liability company organized under this chapter may render~~
8 ~~professional service within this state except through its members, employees~~

24 a limited liability company or foreign limited liability company, whether or
25 not the office is located in this state.

26 (17) "Property" means all property, whether real, personal, or
27 mixed or tangible or intangible, or any right or interest therein.

28 (18) "Record", used as a noun, means information that is
29 inscribed on a tangible medium or that is stored in an electronic or other
30 medium and is retrievable in perceivable form.

31 (19)(A) "Registered agent" means an agent of a limited liability
32 company or foreign limited liability company which is authorized to receive
33 service of any process, notice, or demand required or permitted by law to be
34 served on the company.

35 (B) "Registered agent" means a commercial registered agent
36 or a noncommercial registered agent under the Model Registered Agents Act, §

1 4-20-101 et seq.

2 (20) "Registered foreign limited liability company" means a
3 foreign limited liability company that is registered to do business in this
4 state pursuant to a statement of registration filed by the Secretary of
5 State.

6 (21) "Sign" means, with present intent to authenticate or adopt
7 a record:

8 (A) to execute or adopt a tangible symbol; or

9 (B) to attach to or logically associate with the record an
10 electronic symbol, sound, or process.

11 (22) "State" means a state of the United States, the District of
12 Columbia, Puerto Rico, the United States Virgin Islands, or any territory or
13 insular possession subject to the jurisdiction of the United States.

14 (23) "Transfer" includes:

15 (A) an assignment;

16 (B) a conveyance;

17 (C) a sale;

18 (D) a lease;

19 (E) an encumbrance, including a mortgage or security
20 interest;

21 (F) a gift; and

22 (G) a transfer by operation of law.

23 (24) "Transferable interest" means the right, as initially owned
24 by a person in the person's capacity as a member, to receive distributions
25 from a limited liability company, whether or not the person remains a member
26 or continues to own any part of the right. The term applies to any fraction
27 of the interest, by whomever owned.

28 (25) "Transferee" means a person to which all or part of a
29 transferable interest has been transferred, whether or not the transferor is
30 a member. The term includes a person that owns a transferable interest under
31 § 4-38-603(a)(3).

32
33 4-38-103. Knowledge – Notice.

34 (a) A person knows a fact if the person:

35 (1) has actual knowledge of it; or

36 (2) is deemed to know it under subsection (d)(1) or law other

1 than this chapter.

2 (b) A person has notice of a fact if the person:

3 (1) has reason to know the fact from all the facts known to the
4 person at the time in question; or

5 (2) is deemed to have notice of the fact under subsection
6 (d)(2).

7 (c) Subject to § 4-38-210(f), a person notifies another person of a
8 fact by taking steps reasonably required to inform the other person in
9 ordinary course, whether or not those steps cause the other person to know
10 the fact.

11 (d) A person not a member is deemed:

12 (1) to know of a limitation on authority to transfer real
13 property as provided in § 4-38-302(g); and

14 (2) to have notice of a limited liability company's:

15 (A) dissolution 90 days after a statement of dissolution
16 under § 4-38-702(b)(2)(A) becomes effective;

17 (B) termination 90 days after a statement of termination
18 under § 4-38-702(b)(2)(F) becomes effective; and

19 (C) participation in a merger, interest exchange,
20 conversion, or domestication, 90 days after articles of merger, interest
21 exchange, conversion, or domestication under § 4-38-1001 et seq. become
22 effective.

23
24 4-38-104. Governing law.

25 The law of this state governs:

26 (1) the internal affairs of a limited liability company; and

27 (2) the liability of a member as member and a manager as manager
28 for a debt, obligation, or other liability of a limited liability company.

29
30 4-38-105. Operating agreement – Scope, function, and limitations.

31 (a) Except as otherwise provided in subsections (c) and (d), the
32 operating agreement governs:

33 (1) relations among the members as members and between the
34 members and the limited liability company;

35 (2) the rights and duties under this chapter of a person in the
36 capacity of manager;

1 (3) the activities and affairs of the company and the conduct of
2 those activities and affairs; and

3 (4) the means and conditions for amending the operating
4 agreement.

5 (b) To the extent the operating agreement does not provide for a
6 matter described in subsection (a), this chapter governs the matter.

7 (c) An operating agreement may not:

8 (1) vary the law applicable under § 4-38-104;

9 (2) vary a limited liability company's capacity under § 4-38-109
10 to sue and be sued in its own name;

11 (3) vary any requirement, procedure, or other provision of this
12 chapter pertaining to:

13 (A) registered agents under the Model Registered Agents
14 Act, § 4-20-101 et seq.; or

15 (B) the Secretary of State, including provisions
16 pertaining to records authorized or required to be delivered to the Secretary
17 of State for filing under this chapter;

18 (4) vary the provisions of § 4-38-204;

19 (5) alter or eliminate the duty of loyalty or the duty of care,
20 except as otherwise provided in subsection (d);

21 (6) eliminate the contractual obligation of good faith and fair
22 dealing under § 4-38-409(d), but the operating agreement may prescribe the
23 standards, if not manifestly unreasonable, by which the performance of the
24 obligation is to be measured;

25 (7) relieve or exonerate a person from liability for conduct
26 involving bad faith, willful or intentional misconduct, or knowing violation
27 of law;

28 (8) unreasonably restrict the duties and rights under § 4-38-
29 410, but the operating agreement may impose reasonable restrictions on the
30 availability and use of information obtained under that section and may
31 define appropriate remedies, including liquidated damages, for a breach of
32 any reasonable restriction on use;

33 (9) vary the causes of dissolution specified in § 4-38-
34 701(a)(4);

35 (10) vary the requirement to wind up the company's activities
36 and affairs as specified in § 4-38-702(a), (b)(1), and (e);

1 (11) unreasonably restrict the right of a member to maintain an
2 action under § 4-38-801 et seq.;

3 (12) vary the provisions of § 4-38-805, but the operating
4 agreement may provide that the company may not have a special litigation
5 committee;

6 (13) vary the right of a member to approve a merger, interest
7 exchange, conversion, or domestication under § 4-38-1023(a)(2), § 4-38-
8 1033(a)(2), § 4-38-1043(a)(2), or § 4-38-1053(a)(2);

9 (14) vary the required contents of a plan of merger under § 4-
10 38-1022(a), plan of interest exchange under § 4-38-1032(a), plan of
11 conversion under § 4-38-1042(a), or plan of domestication under § 4-38-
12 1052(a); or

13 (15) except as otherwise provided in § 4-38-106 and § 4-38-
14 107(b), restrict the rights under this chapter of a person other than a
15 member or manager.

16 (d) Subject to subsection (c)(7), without limiting other terms that
17 may be included in an operating agreement, the following rules apply:

18 (1) The operating agreement may:

19 (A) specify the method by which a specific act or
20 transaction that would otherwise violate the duty of loyalty may be
21 authorized or ratified by one or more disinterested and independent persons
22 after full disclosure of all material facts; and

23 (B) alter the prohibition in § 4-38-405(a)(2) so that the
24 prohibition requires only that the company's total assets not be less than
25 the sum of its total liabilities.

26 (2) To the extent the operating agreement of a member-managed
27 limited liability company expressly relieves a member of a responsibility
28 that the member otherwise would have under this chapter and imposes the
29 responsibility on one or more other members, the agreement also may eliminate
30 or limit any fiduciary duty of the member relieved of the responsibility
31 which would have pertained to the responsibility.

32 (3) If not manifestly unreasonable, the operating agreement may:

33 (A) alter or eliminate the aspects of the duty of loyalty
34 stated in § 4-38-409(b) and (i);

35 (B) identify specific types or categories of activities
36 that do not violate the duty of loyalty;

1 (C) alter the duty of care, but may not authorize conduct
2 involving bad faith, willful or intentional misconduct, or knowing violation
3 of law; and

4 (D) alter or eliminate any other fiduciary duty.

5 (e) The court shall decide as a matter of law whether a term of an
6 operating agreement is manifestly unreasonable under subsections (c)(6) or
7 (d)(3). The court:

8 (1) shall make its determination as of the time the challenged
9 term became part of the operating agreement and by considering only
10 circumstances existing at that time; and

11 (2) may invalidate the term only if, in light of the purposes,
12 activities, and affairs of the limited liability company, it is readily
13 apparent that:

14 (A) the objective of the term is unreasonable; or

15 (B) the term is an unreasonable means to achieve the
16 term's objective.

17
18 4-38-106. Operating agreement – Effect on limited liability company
19 and person becoming member – Preformation agreements.

20 (a) A limited liability company is bound by and may enforce the
21 operating agreement, whether or not the company has itself manifested assent
22 to the operating agreement.

23 (b) A person that becomes a member is deemed to assent to the
24 operating agreement.

25 (c) Two or more persons intending to become the initial members of a
26 limited liability company may make an agreement providing that upon the
27 formation of the company the agreement will become the operating agreement.
28 One person intending to become the initial member of a limited liability
29 company may assent to terms providing that upon the formation of the company
30 the terms will become the operating agreement.

31
32 4-38-107. Operating agreement – Effect on third parties and
33 relationship to records effective on behalf of limited liability company.

34 (a) An operating agreement may specify that its amendment requires the
35 approval of a person that is not a party to the agreement or the satisfaction
36 of a condition. An amendment is ineffective if its adoption does not include

1 the required approval or satisfy the specified condition.

2 (b) The obligations of a limited liability company and its members to
3 a person in the person's capacity as a transferee or a person dissociated as
4 a member are governed by the operating agreement. Subject only to a court
5 order issued under § 4-38-503(b)(2) to effectuate a charging order, an
6 amendment to the operating agreement made after a person becomes a transferee
7 or is dissociated as a member:

8 (1) is effective with regard to any debt, obligation, or other
9 liability of the limited liability company or its members to the person in
10 the person's capacity as a transferee or person dissociated as a member; and

11 (2) is not effective to the extent the amendment imposes a new
12 debt, obligation, or other liability on the transferee or person dissociated
13 as a member.

14 (c) If a record delivered by a limited liability company to the
15 Secretary of State for filing becomes effective and contains a provision that
16 would be ineffective under § 4-38-105(c) or § 4-38-105(d)(3) if contained in
17 the operating agreement, the provision is ineffective in the record.

18 (d) Subject to subsection (c), if a record delivered by a limited
19 liability company to the Secretary of State for filing becomes effective and
20 conflicts with a provision of the operating agreement:

21 (1) the agreement prevails as to members, persons dissociated as
22 members, transferees, and managers; and

23 (2) the record prevails as to other persons to the extent they
24 reasonably rely on the record.

25
26 4-38-108. Nature, purpose, and duration of limited liability company.

27 (a) A limited liability company is an entity distinct from its member
28 or members.

29 (b) A limited liability company may have any lawful purpose,
30 regardless of whether for profit.

31 (c) A limited liability company has perpetual duration.

32
33 4-38-109. Powers.

34 A limited liability company has the capacity to sue and be sued in its
35 own name and the power to do all things necessary or convenient to carry on
36 its activities and affairs.

1
2 4-38-110. Application to existing relationships.

3 (a) Before September 1, 2021, this chapter governs only:

4 (1) a limited liability company formed on or after September 1,
5 2021; and

6 (2) except as otherwise provided in subsection (c), a limited
7 liability company formed before September 1, 2021, which elects, in the
8 manner provided in its operating agreement or by law for amending the
9 operating agreement, to be subject to this chapter.

10 (b) Except as otherwise provided in subsection (c), on and after
11 September 1, 2021, this chapter governs all limited liability companies.

12 (c) For purposes of applying this chapter to a limited liability
13 company formed before September 1, 2021:

14 (1) the company's articles of organization are deemed to be the
15 company's certificate of organization; and

16 (2) for purposes of applying § 4-38-102(10) and subject to § 4-
17 38-107(d), language in the company's articles of organization designating the
18 company's management structure operates as if that language were in the
19 operating agreement.

20
21 4-38-111. Supplemental principles of law.

22 Unless displaced by particular provisions of this chapter, the
23 principles of law and equity supplement this chapter.

24
25 4-38-112. Permitted names.

26 (a) The name of a limited liability company must contain the phrase
27 "limited liability company" or "limited company" or the abbreviation
28 "L.L.C.", "LLC", "L.C.", or "LC". "Limited" may be abbreviated as "Ltd.", and
29 "company" may be abbreviated as "Co."

30 (b) Except as otherwise provided in subsection (d), the name of a
31 limited liability company, and the name under which a foreign limited
32 liability company may register to do business in this state, must be
33 distinguishable on the records of the Secretary of State from any:

34 (1) name of an existing person whose formation required the
35 filing of a record by the Secretary of State and which is not at the time
36 administratively dissolved;

1 (2) name of a limited liability partnership whose statement of
2 qualification is in effect;

3 (3) name under which a person is registered to do business in
4 this state by the filing of a record by the Secretary of State;

5 (4) name reserved under § 4-38-113 or other law of this state
6 providing for the reservation of a name by the filing of a record by the
7 Secretary of State;

8 (5) name registered under § 4-38-114 or other law of this state
9 providing for the registration of a name by the filing of a record by the
10 Secretary of State; and

11 (6) name registered under § 4-26-405, § 4-27-404, § 4-38-122,
12 and § 4-42-707.

13 (c) If a person consents in a record to the use of its name and
14 submits an undertaking in a form satisfactory to the Secretary of State to
15 change its name to a name that is distinguishable on the records of the
16 Secretary of State from any name in any category of names in subsection (b),
17 the name of the consenting person may be used by the person to which the
18 consent was given.

19 (d) Except as otherwise provided in subsection (e), in determining
20 whether a name is the same as or not distinguishable on the records of the
21 Secretary of State from the name of another person, words, phrases, or
22 abbreviations indicating a type of person, such as “corporation”, “corp.”,
23 “incorporated”, “Inc.”, “professional corporation”, “P.C.”, “PC”,
24 “professional association”, “P.A.”, “PA”, “Limited”, “Ltd.”, “limited
25 partnership”, “L.P.”, “LP”, “limited liability partnership”, “L.L.P.”, “LLP”,
26 “registered limited liability partnership”, “R.L.L.P.”, “RLLP”, “limited
27 liability limited partnership”, “L.L.L.P.”, “LLLp”, “registered limited
28 liability limited partnership”, “R.L.L.L.P.”, “RLLLLP”, “limited liability
29 company”, “L.L.C.”, “LLC”, “limited cooperative association”, “limited
30 cooperative”, or “L.C.A.”, or “LCA” may not be taken into account.

31 (e) A person may consent in a record to the use of a name that is not
32 distinguishable on the records of the Secretary of State from its name except
33 for the addition of a word, phrase, or abbreviation indicating the type of
34 person as provided in subsection (d). In such a case, the person need not
35 change its name pursuant to subsection (c).

36 (f) The name of a limited liability company or foreign limited

1 liability company may not contain the name of any person who is not a member,
2 except that the name of a former member or member of a predecessor
3 organization may continue to be included in the name.

4 (g) A limited liability company or foreign limited liability company
5 may use a name that is not distinguishable from a name described in
6 subsections (b)(1) through (6) if the company delivers to the Secretary of
7 State a certified copy of a final judgment of a court of competent
8 jurisdiction establishing the right of the company to use the name in this
9 state.

10
11 4-38-113. Reservation of name.

12 (a) A person may reserve the exclusive use of a name that complies
13 with § 4-38-112 by delivering an application to the Secretary of State for
14 filing. The application must state the name and address of the applicant and
15 the name to be reserved. If the Secretary of State finds that the name is
16 available, the Secretary of State shall reserve the name for the applicant's
17 exclusive use for 120 days.

18 (b) The owner of a reserved name may transfer the reservation to
19 another person by delivering to the Secretary of State a signed notice in a
20 record of the transfer which states the name and address of the person to
21 which the reservation is being transferred.

22
23 4-38-114. Registration of name.

24 (a) A foreign limited liability company not registered to do business
25 in this state under § 4-38-901 et seq. may register its name, or an alternate
26 name adopted pursuant to § 4-38-906, if the name is distinguishable on the
27 records of the Secretary of State from the names that are not available under
28 § 4-38-112.

29 (b) To register its name or an alternate name adopted pursuant to § 4-
30 38-906, a foreign limited liability company must deliver to the Secretary of
31 State for filing an application stating the company's name, the jurisdiction
32 and date of its formation, and any alternate name adopted pursuant to § 4-38-
33 906. If the Secretary of State finds that the name applied for is available,
34 the Secretary of State shall register the name for the applicant's exclusive
35 use.

36 (c) The registration of a name under this section is effective for one

1 year after the date of registration.

2 (d) A foreign limited liability company whose name registration is
3 effective may renew the registration for successive one-year periods by
4 delivering, not earlier than three months before the expiration of the
5 registration, to the Secretary of State for filing a renewal application that
6 complies with this section. When filed, the renewal application renews the
7 registration for a succeeding one-year period.

8 (e) A foreign limited liability company whose name registration is
9 effective may register as a foreign limited liability company under the
10 registered name or consent in a signed record to the use of that name by
11 another person that is not an individual.

12
13 4-38-115. Registered agent.

14 (a) Each limited liability company and each registered foreign limited
15 liability company shall designate and maintain a registered agent in this
16 state in compliance with the Model Registered Agents Act, § 4-20-101 et seq.

17 (b) The designation of a registered agent is an affirmation of fact by
18 the limited liability company or registered foreign limited liability company
19 that the agent has consented to serve.

20 (c) A registered agent for a limited liability company or registered
21 foreign limited liability company must have a place of business in this
22 state.

23 (d) The only duties under this chapter of a registered agent that has
24 complied with this chapter are as described in § 4-20-114.

25
26 4-38-116. Change of registered agent or address for registered agent
27 by limited liability company.

28 (a) A limited liability company or registered foreign limited
29 liability company may change its registered agent or the address of its
30 registered agent as provided under § 4-20-108.

31 (b) Any change by a noncommercial registered agent shall comply with §
32 4-20-109.

33 (c) Any change by a commercial registered agent shall comply with § 4-
34 20-110.

35
36 4-38-117. Resignation of registered agent.

1 (a) A registered agent may resign as an agent for a limited liability
2 company or registered foreign limited liability company as directed under §
3 4-20-111.

4 (b) A statement of resignation takes effect on the earlier of:

5 (1) the 31st day after the day on which it is filed by the
6 Secretary of State; or

7 (2) the designation of a new registered agent for the limited
8 liability company or registered foreign limited liability company.

9 (c) A registered agent promptly shall furnish to the limited liability
10 company or registered foreign limited liability company notice in a record of
11 the date on which a statement of resignation was filed.

12 (d) When a statement of resignation takes effect, the registered agent
13 ceases to have responsibility under this chapter for any matter thereafter
14 tendered to it as agent for the limited liability company or registered
15 foreign limited liability company. The resignation does not affect any
16 contractual rights the company or foreign company has against the agent or
17 that the agent has against the company or foreign company.

18 (e) A registered agent may resign with respect to a limited liability
19 company or registered foreign limited liability company whether or not the
20 company or foreign company is in good standing.

21
22 4-38-118. Change of name or address by a registered agent.

23 (a) If a noncommercial registered agent changes its name, its address
24 as currently in effect with respect to a represented entity pursuant to § 4-
25 20-105(a), the agent shall file with the Secretary of State, with respect to
26 each entity represented by the agent, a statement of change signed by or on
27 behalf of the agent which states:

28 (1) the name of the entity;

29 (2) the name and address of the agent as currently in effect
30 with respect to the entity;

31 (3) if the name of the agent has changed, its new name; and

32 (4) if the address of the agent has changed, the new address.

33 (b) If a commercial registered agent changes its name, its address as
34 currently listed under § 4-20-106(a), or its type or jurisdiction of
35 organization, the agent shall file with the Secretary of State a statement of
36 change signed by or on behalf of the agent which states:

1 (1) the name of the agent as currently listed under § 4-20-
2 106(a);

3 (2) if the name of the agent has changed, its new name;

4 (3) if the address of the agent has changed, the new address;

5 and

6 (4) if the type or jurisdiction of organization of the agent has
7 changed, the new type or jurisdiction of organization.

8 (c) The filing of a statement of change under subsection (b) is
9 effective to change the information regarding the commercial registered agent
10 with respect to each entity represented by the agent.

11 (d) A statement of change filed under this section takes effect on
12 filing.

13 (e) A commercial registered agent shall promptly furnish each entity
14 represented by it with notice in a record of the filing of a statement of
15 change relating to the name or address of the agent and the changes made by
16 the filing.

17 (f) If a commercial registered agent changes its address without
18 filing a statement of change as required by this section, the Secretary of
19 State may cancel the listing of the agent under § 4-20-106. A cancellation
20 under this subsection has the same effect as a termination under § 4-20-107.
21 Promptly after canceling the listing of an agent, the Secretary of State
22 shall serve notice in a record in the manner provided in § 4-20-113(b) or (c)
23 on:

24 (1) each entity represented by the agent, stating that the agent
25 has ceased to be an agent for service of process on the entity and that,
26 until the entity appoints a new registered agent, service of process may be
27 made on the entity as provided in § 4-20-113; and

28 (2) the agent, stating that the listing of the agent has been
29 cancelled under this section.

30 (g) The Secretary of State shall note the filing of the commercial
31 registered agent change statement in the index of filings maintained by the
32 Secretary of State for each entity represented by the registered agent at the
33 time of the filing.

34 (h) A noncommercial registered agent shall promptly furnish the
35 represented entity with notice in a record of the filing of a statement of
36 change and the changes made by the filing.

1
2 4-38-119. Service of process, notice, or demand.

3 (a) A limited liability company or registered foreign limited
4 liability company may be served with any process, notice, or demand required
5 or permitted by law by serving its registered agent.

6 (b) If a limited liability company or registered foreign limited
7 liability company ceases to have a registered agent, or if its registered
8 agent cannot with reasonable diligence be served, the company or foreign
9 company may be served by registered or certified mail, return receipt
10 requested, or by similar commercial delivery service, addressed to the
11 company or foreign company at its principal office. The address of the
12 principal office must be as shown on the company's or foreign company's most
13 recent annual report filed by the Secretary of State. Service is effected
14 under this subsection on the earliest of:

15 (1) the date the company or foreign company receives the mail or
16 delivery by the commercial delivery service;

17 (2) the date shown on the return receipt, if signed by the
18 company or foreign company; or

19 (3) five days after its deposit with the United States Postal
20 Service, or with the commercial delivery service, if correctly addressed and
21 with sufficient postage or payment.

22 (c) If process, notice, or demand cannot be served on a limited
23 liability company or registered foreign limited liability company pursuant to
24 subsection (a) or (b), service may be made by handing a copy to the
25 individual in charge of any regular place of business or activity of the
26 company or foreign company if the individual served is not a plaintiff in the
27 action.

28 (d) Service of process, notice, or demand on a registered agent must
29 be in a written record.

30 (e) Service of process, notice, or demand may be made by other means
31 under law other than this chapter.

32
33 4-38-120. Delivery of record.

34 (a) Except as otherwise provided in this chapter, permissible means of
35 delivery of a record include delivery by hand, mail, conventional commercial
36 practice, and electronic transmission.

1 (b) Delivery to the Secretary of State is effective only when a record
2 is received by the Secretary of State.

3
4 4-38-121. Reservation of power to amend or repeal.

5 The General Assembly has power to amend or repeal all or part of this
6 chapter at any time, and all limited liability companies and foreign limited
7 liability companies subject to this chapter are governed by the amendment or
8 repeal.

9
10 4-38-122. Use of fictitious names.

11 (a) A limited liability company, domestic or foreign, shall not
12 conduct any business in this state under a fictitious name unless it first
13 files with the Secretary of State a form supplied or approved by the
14 Secretary of State giving the following information:

15 (1) the fictitious name under which business is being or will be
16 conducted by the applicant limited liability company;

17 (2) a brief statement of the character of business to be
18 conducted under the fictitious name; and

19 (3) the name of the limited liability company, the state of
20 organization, and location, giving the city and street address, of the
21 registered office in the state of the applicant limited liability company.

22 (b)(1) Each form shall be executed, without verification, in duplicate
23 and filed with the Secretary of State.

24 (2) The Secretary of State shall retain one (1) counterpart of
25 the form described in subsection (a) of this section and the other
26 counterpart, bearing the file marks of the Secretary of State, shall be
27 returned to the limited liability company.

28 (c) The Secretary of State shall not accept a filing if the proposed
29 fictitious name is the same as, or confusingly similar to, the name of any
30 domestic corporation, limited liability company, limited partnership, limited
31 liability partnership or any other entity registered with the Secretary of
32 State, or any foreign entity authorized to do business in the state or any
33 name reserved or registered under §§ 4-27-402, 4-27-403, 4-38-113, or 4-47-
34 109.

35 (d) Copies of the filed forms, certified by the respective filing
36 officers, shall be admitted in evidence where the question of filing may be

1 material.

2 (e)(1) If, after a filing under this section, the applicant limited
3 liability company is dissolved, or, being a foreign limited liability
4 company, surrenders or forfeits its rights to do business in Arkansas or,
5 whether a domestic or foreign limited liability company, ceases to do
6 business in Arkansas under the specified fictitious name, the limited
7 liability company shall be obligated to file with the Secretary of State a
8 cancellation of its privilege hereunder.

9 (2) If the cancellation is not filed, the Secretary of State,
10 upon satisfactory evidence, may cancel the privilege.

11 (f) If a limited liability company that has not filed under this
12 section, but has or shall become a party to any contract, deed, conveyance,
13 assignment, or instrument of encumbrance in which the limited liability
14 company is referred to exclusively by a fictitious name, the obligations
15 imposed upon the limited liability company under the instrument and the right
16 sought to be conferred upon third parties thereunder may be enforced against
17 it, but the rights accruing to the limited liability company under the
18 instrument shall not be enforced by the limited liability company in the
19 courts of this state until it complies with this section and pays to the
20 Treasurer of State a civil penalty of three hundred dollars (\$300), and in
21 any suit by a limited liability company upon an instrument which identified
22 it exclusively by a fictitious name, the limited liability company shall be
23 required to allege compliance with this section.

24 (g) Compliance with this section does not give a limited liability
25 company an exclusive right to the use of the fictitious name, and the
26 registration of a fictitious name under this section will not bar the use of
27 the same name as the name of any domestic entity or any foreign entity
28 authorized to do business in this state, but this chapter is not intended to
29 bar any aggrieved party in such a situation from applying for equitable
30 relief under principles of fair trade law.

31
32 Subchapter 2 – Formation; Certificate of organization and other filings.

33
34 4-38-201. Formation of limited liability company; Certificate of
35 organization.

36 (a) One or more persons may act as organizers to form a limited

1 liability company by delivering to the Secretary of State for filing a
2 certificate of organization.

3 (b) A certificate of organization must state:

4 (1) the name of the limited liability company, which must comply
5 with § 4-38-112;

6 (2) the street and mailing addresses of the company's principal
7 office; and

8 (3) the name and street and mailing addresses in this state of
9 the company's registered agent.

10 (c) A certificate of organization may contain statements as to matters
11 other than those required by subsection (b), but may not vary or otherwise
12 affect the provisions specified in § 4-38-105(c) and (d) in a manner
13 inconsistent with that section. However, a statement in a certificate of
14 organization is not effective as a statement of authority.

15 (d) A limited liability company is formed when the certificate of
16 organization becomes effective and at least one person has become a member.

17
18 4-38-202. Amendment or restatement of certificate of organization.

19 (a) A certificate of organization may be amended or restated at any
20 time.

21 (b) To amend its certificate of organization, a limited liability
22 company must deliver to the Secretary of State for filing an amendment
23 stating:

24 (1) the name of the company;

25 (2) the date of filing of its initial certificate; and

26 (3) the text of the amendment.

27 (c) To restate its certificate of organization, a limited liability
28 company must deliver to the Secretary of State for filing a restatement,
29 designated as such in its heading.

30 (d) If a member of a member-managed limited liability company, or a
31 manager of a manager-managed limited liability company, knows that any
32 information in a filed certificate of organization was inaccurate when the
33 certificate was filed or has become inaccurate due to changed circumstances,
34 the member or manager shall promptly:

35 (1) cause the certificate to be amended; or

36 (2) if appropriate, deliver to the Secretary of State for filing

1 a statement of change under § 4-38-116 or a statement of correction under §
2 4-38-209.

3
4 4-38-203. Signing of records to be delivered for filing to Secretary
5 of State.

6 (a) A record delivered to the Secretary of State for filing pursuant
7 to this chapter must be signed as follows:

8 (1) Except as otherwise provided in paragraphs (2) and (3), a
9 record signed by a limited liability company must be signed by a person
10 authorized by the company.

11 (2) A company's initial certificate of organization must be
12 signed by at least one person acting as an organizer.

13 (3) A record delivered on behalf of a dissolved company that has
14 no member must be signed by the person winding up the company's activities
15 and affairs under § 4-38-702(c) or a person appointed under § 4-38-702(d) to
16 wind up the activities and affairs.

17 (4) A statement of denial by a person under § 4-38-303 must be
18 signed by that person.

19 (5) Any other record delivered on behalf of a person to the
20 Secretary of State for filing must be signed by that person.

21 (b) A record delivered for filing under this chapter may be signed by
22 an agent. Whenever this chapter requires a particular individual to sign a
23 record and the individual is deceased or incompetent, the record may be
24 signed by a legal representative of the individual.

25 (c) A person that signs a record as an agent or legal representative
26 affirms as a fact that the person is authorized to sign the record.

27
28 4-38-204. Signing and filing pursuant to judicial order.

29 (a) If a person required by this chapter to sign a record or deliver a
30 record to the Secretary of State for filing under this chapter does not do
31 so, any other person that is aggrieved may petition circuit court to order:

32 (1) the person to sign the record;

33 (2) the person to deliver the record to the Secretary of State
34 for filing; or

35 (3) the Secretary of State to file the record unsigned.

36 (b) If a petitioner under subsection (a) is not the limited liability

1 company or foreign limited liability company to which the record pertains,
2 the petitioner shall make the company or foreign company a party to the
3 action.

4 (c) A record filed under subsection (a)(3) is effective without being
5 signed.

6
7 4-38-205 Liability for inaccurate information in filed record.

8 (a) If a record delivered to the Secretary of State for filing under
9 this chapter and filed by the Secretary of State contains inaccurate
10 information, a person that suffers loss by reliance on the information may
11 recover damages for the loss from:

12 (1) a person that signed the record, or caused another to sign
13 it on the person's behalf, and knew the information to be inaccurate at the
14 time the record was signed; and

15 (2) subject to subsection (b), a member of a member-managed
16 limited liability company or a manager of a manager-managed limited liability
17 company if:

18 (A) the record was delivered for filing on behalf of the
19 company; and

20 (B) the member or manager knew or had notice of the
21 inaccuracy for a reasonably sufficient time before the information was relied
22 upon so that, before the reliance, the member or manager reasonably could
23 have:

24 (i) effected an amendment under § 4-38-202;

25 (ii) filed a petition under § 4-38-204; or

26 (iii) delivered to the Secretary of State for filing
27 a statement of change under § 4-38-116 or a statement of correction under §
28 4-38-209.

29 (b) To the extent the operating agreement of a member-managed limited
30 liability company expressly relieves a member of responsibility for
31 maintaining the accuracy of information contained in records delivered on
32 behalf of the company to the Secretary of State for filing under this chapter
33 and imposes that responsibility on one or more other members, the liability
34 stated in subsection (a)(2) applies to those other members and not to the
35 member that the operating agreement relieves of the responsibility.

36 (c) An individual who signs a record authorized or required to be

1 filed under this chapter affirms under penalty of perjury that the
2 information stated in the record is accurate.

3
4 4-38-206. Filing requirements.

5 (a) To be filed by the Secretary of State pursuant to this chapter, a
6 record must be received by the Secretary of State, comply with this chapter,
7 and satisfy the following:

8 (1) The filing of the record must be required or permitted by
9 this chapter.

10 (2) The record must be physically delivered in written form
11 unless and to the extent the Secretary of State permits electronic delivery
12 of records.

13 (3) The words in the record must be in English, and numbers must
14 be in Arabic or Roman numerals, but the name of an entity need not be in
15 English if written in English letters or Arabic or Roman numerals.

16 (4) The record must be signed by a person authorized or required
17 under this chapter to sign the record.

18 (5) The record must state the name and capacity, if any, of each
19 individual who signed it, either on behalf of the individual or the person
20 authorized or required to sign the record, but need not contain a seal,
21 attestation, acknowledgment, or verification.

22 (b) If law other than this chapter prohibits the disclosure by the
23 Secretary of State of information contained in a record delivered to the
24 Secretary of State for filing, the Secretary of State shall file the record
25 if the record otherwise complies with this chapter but may redact the
26 information.

27 (c) When a record is delivered to the Secretary of State for filing,
28 any fee required under this chapter and any fee, tax, interest, or penalty
29 required to be paid under this chapter or law other than this chapter must be
30 paid in a manner permitted by the Secretary of State or by that law.

31 (d) The Secretary of State may require that a record delivered in
32 written form be accompanied by an identical or conformed copy.

33 (e) The Secretary of State may provide forms for filings required or
34 permitted to be made by this chapter, but, except as otherwise provided in
35 subsection (f), their use is not required.

36 (f) The Secretary of State may require that a cover sheet for a filing

1 be on a form prescribed by the Secretary of State.

2
3 4-38-207. Effective date and time.

4 Except as otherwise provided in § 4-38-208 and subject to § 4-38-
5 209(d), a record filed under this chapter is effective:

6 (1) on the date and at the time of its filing by the Secretary
7 of State, as provided in § 4-38-210(b);

8 (2) on the date of filing and at the time specified in the
9 record as its effective time, if later than the time under paragraph (1);

10 (3) at a specified delayed effective date and time, which may
11 not be more than 90 days after the date of filing; or

12 (4) if a delayed effective date is specified, but no time is
13 specified, at 12:01 a.m. on the date specified, which may not be more than 90
14 days after the date of filing.

15
16 4-38-208. Withdrawal of filed record before effectiveness.

17 (a) Except as otherwise provided in §§ 4-38-1024, 4-38-1034, 4-38-
18 1044, and 4-38-1054, a record delivered to the Secretary of State for filing
19 may be withdrawn before it takes effect by delivering to the Secretary of
20 State for filing a statement of withdrawal.

21 (b) A statement of withdrawal must:

22 (1) be signed by each person that signed the record being
23 withdrawn, except as otherwise agreed by those persons;

24 (2) identify the record to be withdrawn; and

25 (3) if signed by fewer than all the persons that signed the
26 record being withdrawn, state that the record is withdrawn in accordance with
27 the agreement of all the persons that signed the record.

28 (c) On filing by the Secretary of State of a statement of withdrawal,
29 the action or transaction evidenced by the original record does not take
30 effect.

31
32 4-38-209. Correcting filed record.

33 (a) A person on whose behalf a filed record was delivered to the
34 Secretary of State for filing may correct the record if:

35 (1) the record at the time of filing was inaccurate;

36 (2) the record was defectively signed; or

1 (3) the electronic transmission of the record to the Secretary
2 of State was defective.

3 (b) To correct a filed record, a person on whose behalf the record was
4 delivered to the Secretary of State must deliver to the Secretary of State
5 for filing a statement of correction.

6 (c) A statement of correction:

7 (1) may not state a delayed effective date;

8 (2) must be signed by the person correcting the filed record;

9 (3) must identify the filed record to be corrected;

10 (4) must specify the inaccuracy or defect to be corrected;

11 (5) must correct the inaccuracy or defect; and

12 (6) may not correct original certificate of organization.

13 (d) A statement of correction is effective as of the effective date of
14 the filed record that it corrects except for purposes of § 4-38-103(d) and as
15 to persons relying on the uncorrected filed record and adversely affected by
16 the correction. For those purposes and as to those persons, the statement of
17 correction is effective when filed.

18
19 4-38-210. Duty of Secretary of State to file – Review of refusal to
20 file – Delivery of record by Secretary of State.

21 (a) The Secretary of State shall file a record delivered to the
22 Secretary of State for filing which satisfies this chapter. The duty of the
23 Secretary of State under this section is ministerial.

24 (b) When the Secretary of State files a record, the Secretary of State
25 shall record it as filed on the date and at the time of its delivery. After
26 filing a record, the Secretary of State shall deliver to the person that
27 submitted the record a copy of the record with an acknowledgment of the date
28 and time of filing and, in the case of a statement of denial, also to the
29 limited liability company to which the statement pertains.

30 (c) If the Secretary of State refuses to file a record, the Secretary
31 of State shall, not later than 15 business days after the record is
32 delivered:

33 (1) return the record or notify the person that submitted the
34 record of the refusal; and

35 (2) provide a brief explanation in a record of the reason for
36 the refusal.

1 (d) If the Secretary of State refuses to file a record, the person
2 that submitted the record may petition the circuit court to compel filing of
3 the record. The record and the explanation of the Secretary of State of the
4 refusal to file must be attached to the petition. The court may decide the
5 matter in a summary proceeding.

6 (e) The filing of or refusal to file a record does not:

7 (1) affect the validity or invalidity of the record in whole or
8 in part; or

9 (2) create a presumption that the information contained in the
10 record is correct or incorrect.

11 (f) Except as otherwise provided by 4-38-119 or by law other than this
12 chapter, the Secretary of State may deliver any record to a person by
13 delivering it:

14 (1) in person to the person that submitted it;

15 (2) to the address of the person's registered agent;

16 (3) to the principal office of the person; or

17 (4) to another address the person provides to the Secretary of
18 State for delivery.

19
20 4-38-211. Certificate of good standing or registration.

21 (a) On request of any person, the Secretary of State shall issue a
22 certificate of good standing for a limited liability company or a certificate
23 of registration for a registered foreign limited liability company.

24 (b) A certificate under subsection (a) must state:

25 (1) the limited liability company's name or the registered
26 foreign limited liability company's name used in this state;

27 (2) in the case of a limited liability company:

28 (A) that a certificate of organization has been filed and
29 has taken effect;

30 (B) the date the certificate became effective;

31 (C) the period of the company's duration if the records of
32 the Secretary of State reflect that its period of duration is less than
33 perpetual; and

34 (D) that:

35 (i) no statement of dissolution, statement of
36 administrative dissolution, or statement of termination has been filed;

1 (ii) the records of the Secretary to State do not
2 otherwise reflect that the company has been dissolved or terminated; and

3 (iii) a proceeding is not pending under § 4-38-708;

4 (3) in the case of a registered foreign limited liability
5 company, that it is registered to do business in this state;

6 (4) that all fees, taxes, interest, and penalties owed to this
7 state by the limited liability company or foreign limited liability company
8 and collected through the Secretary of State have been paid, if:

9 (A) payment is reflected in the records of the Secretary
10 of State; and

11 (B) nonpayment affects the good standing or registration
12 of the company or foreign company;

13 (5) that the most recent annual report required by § 4-38-212
14 has been delivered to the Secretary of State for filing; and

15 (6) other facts reflected in the records of the Secretary of
16 State pertaining to the limited liability company or foreign limited
17 liability company which the person requesting the certificate reasonably
18 requests.

19 (c) Subject to any qualification stated in the certificate, a
20 certificate issued by the Secretary of State under subsection (a) may be
21 relied on as conclusive evidence of the facts stated in the certificate.

22
23 4-38-212. Annual report for Secretary of State.

24 (a) A limited liability company or registered foreign limited
25 liability company shall deliver to the Secretary of State for filing an
26 annual report that states:

27 (1) the name of the company or foreign company;

28 (2) the name and street and mailing addresses of its registered
29 agent in this state;

30 (3) the street and mailing addresses of its principal office;

31 (4) if the company is member managed, the name of at least one
32 member;

33 (5) if the company is manager managed, the name of at least one
34 manager; and

35 (6) in the case of a foreign company, its jurisdiction of
36 formation and any alternate name adopted under § 4-38-906(a).

1 to the company, may state the authority, or limitations on the authority, of
2 all persons holding the position to:

3 (A) sign an instrument transferring real property held in
4 the name of the company; or

5 (B) enter into other transactions on behalf of, or
6 otherwise act for or bind, the company; and

7 (3) may state the authority, or limitations on the authority, of
8 a specific person to:

9 (A) sign an instrument transferring real property held in
10 the name of the company; or

11 (B) enter into other transactions on behalf of, or
12 otherwise act for or bind, the company.

13 (b) To amend or cancel a statement of authority filed by the Secretary
14 of State, a limited liability company must deliver to the Secretary of State
15 for filing an amendment or cancellation stating:

16 (1) the name of the company;

17 (2) the name and street and mailing addresses of the company's
18 registered agent;

19 (3) the date the statement being affected became effective; and

20 (4) the contents of the amendment or a declaration that the
21 statement is canceled.

22 (c) A statement of authority affects only the power of a person to
23 bind a limited liability company to persons that are not members.

24 (d) Subject to subsection (c) and § 4-38-103(d), and except as
25 otherwise provided in subsections (f), (g), and (h), a limitation on the
26 authority of a person or a position contained in an effective statement of
27 authority is not by itself evidence of any person's knowledge or notice of
28 the limitation.

29 (e) Subject to subsection (c), a grant of authority not pertaining to
30 transfers of real property and contained in an effective statement of
31 authority is conclusive in favor of a person that gives value in reliance on
32 the grant, except to the extent that when the person gives value:

33 (1) the person has knowledge to the contrary;

34 (2) the statement has been canceled or restrictively amended
35 under subsection (b); or

36 (3) a limitation on the grant is contained in another statement

1 of authority that became effective after the statement containing the grant
2 became effective.

3 (f) Subject to subsection (c), an effective statement of authority
4 that grants authority to transfer real property held in the name of the
5 limited liability company, a certified copy of which statement is recorded in
6 the office for recording transfers of the real property, is conclusive in
7 favor of a person that gives value in reliance on the grant without knowledge
8 to the contrary, except to the extent that when the person gives value:

9 (1) the statement has been canceled or restrictively amended
10 under subsection (b), and a certified copy of the cancellation or restrictive
11 amendment has been recorded in the office for recording transfers of the real
12 property; or

13 (2) a limitation on the grant is contained in another statement
14 of authority that became effective after the statement containing the grant
15 became effective, and a certified copy of the later-effective statement is
16 recorded in the office for recording transfers of the real property.

17 (g) Subject to subsection (c), if a certified copy of an effective
18 statement containing a limitation on the authority to transfer real property
19 held in the name of a limited liability company is recorded in the office for
20 recording transfers of that real property, all persons are deemed to know of
21 the limitation.

22 (h) Subject to subsection (i), an effective statement of dissolution
23 or termination is a cancellation of any filed statement of authority for the
24 purposes of subsection (f) and is a limitation on authority for the purposes
25 of subsection (g).

26 (i) After a statement of dissolution becomes effective, a limited
27 liability company may deliver to the Secretary of State for filing and, if
28 appropriate, may record a statement of authority that is designated as a
29 post-dissolution statement of authority. The statement operates as provided
30 in subsections (f) and (g).

31 (j) Unless earlier canceled, an effective statement of authority is
32 canceled by operation of law five years after the date on which the
33 statement, or its most recent amendment, becomes effective. This
34 cancellation operates without need for any recording under subsection (f) or
35 (g).

36 (k) An effective statement of denial operates as a restrictive

1 amendment under this section and may be recorded by certified copy for
2 purposes of subsection (f)(1).

3
4 4-38-303. Statement of denial.

5 A person named in a filed statement of authority granting that person
6 authority may deliver to the Secretary of State for filing a statement of
7 denial that:

8 (1) provides the name of the limited liability company and the
9 caption of the statement of authority to which the statement of denial
10 pertains; and

11 (2) denies the grant of authority.

12
13 4-38-304. Liability of members and managers.

14 (a) A debt, obligation, or other liability of a limited liability
15 company is solely the debt, obligation, or other liability of the company. A
16 member or manager is not personally liable, directly or indirectly, by way of
17 contribution or otherwise, for a debt, obligation, or other liability of the
18 company solely by reason of being or acting as a member or manager. This
19 subsection applies regardless of the dissolution of the company.

20 (b) The failure of a limited liability company to observe formalities
21 relating to the exercise of its powers or management of its activities and
22 affairs is not a ground for imposing liability on a member or manager for a
23 debt, obligation, or other liability of the company.

24
25 Subchapter 4 – Relations of Members to Each Other and to Limited Liability
26 Company

27
28 4-38-401. Becoming member.

29 (a) If a limited liability company is to have only one member upon
30 formation, the person becomes a member as agreed by that person and the
31 organizer of the company. That person and the organizer may be, but need not
32 be, different persons. If different, the organizer acts on behalf of the
33 initial member.

34 (b) If a limited liability company is to have more than one member
35 upon formation, those persons become members as agreed by the persons before
36 the formation of the company. The organizer acts on behalf of the persons in

1 forming the company and may be, but need not be, one of the persons.

2 (c) After formation of a limited liability company, a person becomes a
3 member:

4 (1) as provided in the operating agreement;

5 (2) as the result of a transaction effective under § 4-38-1001
6 et seq.;

7 (3) with the affirmative vote or consent of all the members; or

8 (4) as provided in § 4-38-701(a)(3).

9 (d) A person may become a member without:

10 (1) acquiring a transferable interest; or

11 (2) making or being obligated to make a contribution to the
12 limited liability company.

13
14 4-38-402. Form of contribution.

15 A contribution may consist of property transferred to, services
16 performed for, or another benefit provided to the limited liability company
17 or an agreement to transfer property to, perform services for, or provide
18 another benefit to the company.

19
20 4-38-403. Liability for contributions.

21 (a) A person's obligation to make a contribution to a limited
22 liability company is not excused by the person's death, disability,
23 termination, or other inability to perform personally.

24 (b) If a person does not fulfill an obligation to make a contribution
25 other than money, the person is obligated at the option of the limited
26 liability company to contribute money equal to the value of the part of the
27 contribution which has not been made.

28 (c) The obligation of a person to make a contribution may be
29 compromised only by the affirmative vote or consent of all the members. If a
30 creditor of a limited liability company extends credit or otherwise acts in
31 reliance on an obligation described in subsection (a) without knowledge or
32 notice of a compromise under this subsection, the creditor may enforce the
33 obligation.

34
35 4-38-404. Sharing of and right to distributions before dissolution.

36 (a) Any distribution made by a limited liability company before its

1 dissolution and winding up must be in equal shares among members and persons
2 dissociated as members, except to the extent necessary to comply with a
3 transfer effective under § 4-38-502 or charging order in effect under § 4-38-
4 503.

5 (b) A person has a right to a distribution before the dissolution and
6 winding up of a limited liability company only if the company decides to make
7 an interim distribution. A person's dissociation does not entitle the person
8 to a distribution.

9 (c) A person does not have a right to demand or receive a distribution
10 from a limited liability company in any form other than money. Except as
11 otherwise provided in § 4-38-707(d), a company may distribute an asset in
12 kind only if each part of the asset is fungible with each other part and each
13 person receives a percentage of the asset equal in value to the person's
14 share of distributions.

15 (d) If a member or transferee becomes entitled to receive a
16 distribution, the member or transferee has the status of, and is entitled to
17 all remedies available to, a creditor of the limited liability company with
18 respect to the distribution. However, the company's obligation to make a
19 distribution is subject to offset for any amount owed to the company by the
20 member or a person dissociated as a member on whose account the distribution
21 is made.

22
23 4-38-405. Limitations on distributions.

24 (a) A limited liability company may not make a distribution, including
25 a distribution under § 4-38-707, if after the distribution:

26 (1) the company would not be able to pay its debts as they
27 become due in the ordinary course of the company's activities and affairs; or

28 (2) the company's total assets would be less than the sum of its
29 total liabilities plus the amount that would be needed, if the company were
30 to be dissolved and wound up at the time of the distribution, to satisfy the
31 preferential rights upon dissolution and winding up of members and
32 transferees whose preferential rights are superior to the rights of persons
33 receiving the distribution.

34 (b) A limited liability company may base a determination that a
35 distribution is not prohibited under subsection (a) on:

36 (1) financial statements prepared on the basis of accounting

1 practices and principles that are reasonable in the circumstances; or

2 (2) a fair valuation or other method that is reasonable under
3 the circumstances.

4 (c) Except as otherwise provided in subsection (e), the effect of a
5 distribution under subsection (a) is measured:

6 (1) in the case of a distribution as defined in § 4-38-
7 102(4)(A), as of the earlier of:

8 (A) the date money or other property is transferred or
9 debt is incurred by the limited liability company; or

10 (B) the date the person entitled to the distribution
11 ceases to own the interest or right being acquired by the company in return
12 for the distribution;

13 (2) in the case of any other distribution of indebtedness, as of
14 the date the indebtedness is distributed; and

15 (3) in all other cases, as of the date:

16 (A) the distribution is authorized, if the payment occurs
17 not later than 120 days after that date; or

18 (B) the payment is made, if the payment occurs more than
19 120 days after the distribution is authorized.

20 (d) A limited liability company's indebtedness to a member or
21 transferee incurred by reason of a distribution made in accordance with this
22 section is at parity with the company's indebtedness to its general,
23 unsecured creditors, except to the extent subordinated by agreement.

24 (e) A limited liability company's indebtedness, including indebtedness
25 issued as a distribution, is not a liability for purposes of subsection (a)
26 if the terms of the indebtedness provide that payment of principal and
27 interest is made only if and to the extent that payment of a distribution
28 could then be made under this section. If the indebtedness is issued as a
29 distribution, each payment of principal or interest is treated as a
30 distribution, the effect of which is measured on the date the payment is
31 made.

32 (f) In measuring the effect of a distribution under § 4-38-707, the
33 liabilities of a dissolved limited liability company do not include any claim
34 that has been disposed of under § 4-38-704, § 4-38-705, or § 4-38-706.

35
36 4-38-406. Liability for improper distributions.

1 (a) Except as otherwise provided in subsection (b), if a member of a
2 member-managed limited liability company or manager of a manager-managed
3 limited liability company consents to a distribution made in violation of §
4 4-38-405 and in consenting to the distribution fails to comply with § 4-38-
5 409, the member or manager is personally liable to the company for the amount
6 of the distribution which exceeds the amount that could have been distributed
7 without the violation of § 4-38-405.

8 (b) To the extent the operating agreement of a member-managed limited
9 liability company expressly relieves a member of the authority and
10 responsibility to consent to distributions and imposes that authority and
11 responsibility on one or more other members, the liability stated in
12 subsection (a) applies to the other members and not the member that the
13 operating agreement relieves of the authority and responsibility.

14 (c) A person that receives a distribution knowing that the
15 distribution violated § 4-38-405 is personally liable to the limited
16 liability company but only to the extent that the distribution received by
17 the person exceeded the amount that could have been properly paid under § 4-
18 38-405.

19 (d) A person against which an action is commenced because the person
20 is liable under subsection (a) may:

21 (1) implead any other person that is liable under subsection (a)
22 and seek to enforce a right of contribution from the person; and

23 (2) implead any person that received a distribution in violation
24 of subsection (c) and seek to enforce a right of contribution from the person
25 in the amount the person received in violation of subsection (c).

26 (e) An action under this section is barred unless commenced not later
27 than two years after the distribution.

28
29 4-38-407. Management of limited liability company.

30 (a) A limited liability company is a member-managed limited liability
31 company unless the operating agreement:

32 (1) expressly provides that:

33 (A) the company is or will be “manager-managed”;

34 (B) the company is or will be “managed by managers”; or

35 (C) management of the company is or will be “vested in
36 managers”; or

1 (2) includes words of similar import.

2 (b) In a member-managed limited liability company, the following rules
3 apply:

4 (1) Except as expressly provided in this chapter, the management
5 and conduct of the company are vested in the members.

6 (2) Each member has equal rights in the management and conduct
7 of the company's activities and affairs.

8 (3) A difference arising among members as to a matter in the
9 ordinary course of the activities and affairs of the company may be decided
10 by a majority of the members.

11 (4) The affirmative vote or consent of all the members is
12 required to:

13 (A) undertake an act outside the ordinary course of the
14 activities and affairs of the company; or

15 (B) amend the operating agreement.

16 (c) In a manager-managed limited liability company, the following
17 rules apply:

18 (1) Except as expressly provided in this chapter, any matter
19 relating to the activities and affairs of the company is decided exclusively
20 by the manager, or, if there is more than one manager, by a majority of the
21 managers.

22 (2) Each manager has equal rights in the management and conduct
23 of the company's activities and affairs.

24 (3) The affirmative vote or consent of all members is required
25 to:

26 (A) undertake an act outside the ordinary course of the
27 company's activities and affairs; or

28 (B) amend the operating agreement.

29 (4) A manager may be chosen at any time by the affirmative vote
30 or consent of a majority of the members and remains a manager until a
31 successor has been chosen, unless the manager at an earlier time resigns, is
32 removed, or dies, or, in the case of a manager that is not an individual,
33 terminates. A manager may be removed at any time by the affirmative vote or
34 consent of a majority of the members without notice or cause.

35 (5) A person need not be a member to be a manager, but the
36 dissociation of a member that is also a manager removes the person as a

1 manager. If a person that is both a manager and a member ceases to be a
2 manager, that cessation does not by itself dissociate the person as a member.

3 (6) A person's ceasing to be a manager does not discharge any
4 debt, obligation, or other liability to the limited liability company or
5 members which the person incurred while a manager.

6 (d) An action requiring the vote or consent of members under this
7 chapter may be taken without a meeting, and a member may appoint a proxy or
8 other agent to vote, consent, or otherwise act for the member by signing an
9 appointing record, personally or by the member's agent.

10 (e) The dissolution of a limited liability company does not affect the
11 applicability of this section. However, a person that wrongfully causes
12 dissolution of the company loses the right to participate in management as a
13 member and a manager.

14 (f) A limited liability company shall reimburse a member for an
15 advance to the company beyond the amount of capital the member agreed to
16 contribute.

17 (g) A payment or advance made by a member which gives rise to a
18 limited liability company obligation under subsection (f) or § 4-38-408(a)
19 constitutes a loan to the company which accrues interest from the date of the
20 payment or advance.

21 (h) A member is not entitled to remuneration for services performed
22 for a member-managed limited liability company, except for reasonable
23 compensation for services rendered in winding up the activities of the
24 company.

25
26 4-38-408. Reimbursement – Indemnification – Advancement – Insurance.

27 (a) A limited liability company shall reimburse a member of a member-
28 managed company or the manager of a manager-managed company for any payment
29 made by the member or manager in the course of the member's or manager's
30 activities on behalf of the company, if the member or manager complied with §
31 4-38-405, § 4-38-407, and § 4-38-409 in making the payment.

32 (b) A limited liability company shall indemnify and hold harmless a
33 person with respect to any claim or demand against the person and any debt,
34 obligation, or other liability incurred by the person by reason of the
35 person's former or present capacity as a member or manager, if the claim,
36 demand, debt, obligation, or other liability does not arise from the person's

1 breach of § 4-38-405, § 4-38-407, or § 4-38-409.

2 (c) In the ordinary course of its activities and affairs, a limited
3 liability company may advance reasonable expenses, including attorney's fees
4 and costs, incurred by a person in connection with a claim or demand against
5 the person by reason of the person's former or present capacity as a member
6 or manager, if the person promises to repay the company if the person
7 ultimately is determined not to be entitled to be indemnified under
8 subsection (b).

9 (d) A limited liability company may purchase and maintain insurance on
10 behalf of a member or manager against liability asserted against or incurred
11 by the member or manager in that capacity or arising from that status even
12 if, under § 4-38-105(c)(7), the operating agreement could not eliminate or
13 limit the person's liability to the company for the conduct giving rise to
14 the liability.

15
16 4-38-409. Standards of conduct for members and managers.

17 (a) A member of a member-managed limited liability company owes to the
18 company and, subject to § 4-38-801, the other members the duties of loyalty
19 and care stated in subsections (b) and (c).

20 (b) The fiduciary duty of loyalty of a member in a member-managed
21 limited liability company includes the duties:

22 (1) to account to the company and hold as trustee for it any
23 property, profit, or benefit derived by the member:

24 (A) in the conduct or winding up of the company's
25 activities and affairs;

26 (B) from a use by the member of the company's property; or

27 (C) from the appropriation of a company opportunity;

28 (2) to refrain from dealing with the company in the conduct or
29 winding up of the company's activities and affairs as or on behalf of a
30 person having an interest adverse to the company; and

31 (3) to refrain from competing with the company in the conduct of
32 the company's activities and affairs before the dissolution of the company.

33 (c) The duty of care of a member of a member-managed limited liability
34 company in the conduct or winding up of the company's activities and affairs
35 is to refrain from engaging in grossly negligent or reckless conduct, willful
36 or intentional misconduct, or knowing violation of law.

1 (d) A member shall discharge the duties and obligations under this
2 chapter or under the operating agreement and exercise any rights consistently
3 with the contractual obligation of good faith and fair dealing.

4 (e) A member does not violate a duty or obligation under this chapter
5 or under the operating agreement solely because the member's conduct furthers
6 the member's own interest.

7 (f) All the members of a member-managed limited liability company or a
8 manager-managed limited liability company may authorize or ratify, after full
9 disclosure of all material facts, a specific act or transaction that
10 otherwise would violate the duty of loyalty.

11 (g) It is a defense to a claim under subsection (b)(2) and any
12 comparable claim in equity or at common law that the transaction was fair to
13 the limited liability company.

14 (h) If, as permitted by subsection (f) or (i)(6) or the operating
15 agreement, a member enters into a transaction with the limited liability
16 company which otherwise would be prohibited by subsection (b)(2), the
17 member's rights and obligations arising from the transaction are the same as
18 those of a person that is not a member.

19 (i) In a manager-managed limited liability company, the following
20 rules apply:

21 (1) Subsections (a), (b), (c), and (g) apply to the manager or
22 managers and not the members.

23 (2) The duty stated under subsection (b)(3) continues until
24 winding up is completed.

25 (3) Subsection (d) applies to managers and members.

26 (4) Subsection (e) applies only to members.

27 (5) The power to ratify under subsection (f) applies only to the
28 members.

29 (6) Subject to subsection (d), a member does not have any duty
30 to the company or to any other member solely by reason of being a member.

31
32 4-38-410. Rights to information of member, manager, and person
33 dissociated as member.

34 (a) In a member-managed limited liability company, the following rules
35 apply:

36 (1) On reasonable notice, a member may inspect and copy during

1 regular business hours, at a reasonable location specified by the company,
2 any record maintained by the company regarding the company's activities,
3 affairs, financial condition, and other circumstances, to the extent the
4 information is material to the member's rights and duties under the operating
5 agreement or this chapter.

6 (2) The company shall furnish to each member:

7 (A) without demand, any information concerning the
8 company's activities, affairs, financial condition, and other circumstances
9 which the company knows and is material to the proper exercise of the
10 member's rights and duties under the operating agreement or this chapter,
11 except to the extent the company can establish that it reasonably believes
12 the member already knows the information; and

13 (B) on demand, any other information concerning the
14 company's activities, affairs, financial condition, and other circumstances,
15 except to the extent the demand for the information demanded is unreasonable
16 or otherwise improper under the circumstances.

17 (3) The duty to furnish information under paragraph (2) also
18 applies to each member to the extent the member knows any of the information
19 described in paragraph (2).

20 (b) In a manager-managed limited liability company, the following
21 rules apply:

22 (1) The informational rights stated in subsection (a) and the
23 duty stated in subsection (a)(3) apply to the managers and not the members.

24 (2) During regular business hours and at a reasonable location
25 specified by the company, a member may inspect and copy information regarding
26 the activities, affairs, financial condition, and other circumstances of the
27 company as is just and reasonable if:

28 (A) the member seeks the information for a purpose
29 reasonably related to the member's interest as a member;

30 (B) the member makes a demand in a record received by the
31 company, describing with reasonable particularity the information sought and
32 the purpose for seeking the information; and

33 (C) the information sought is directly connected to the
34 member's purpose.

35 (3) Not later than 10 days after receiving a demand pursuant to
36 paragraph (2)(B), the company shall inform in a record the member that made

1 the demand of:

2 (A) what information the company will provide in response
3 to the demand and when and where the company will provide the information;
4 and

5 (B) the company's reasons for declining, if the company
6 declines to provide any demanded information.

7 (4) Whenever this chapter or an operating agreement provides for
8 a member to vote on or give or withhold consent to a matter, before the vote
9 is cast or consent is given or withheld, the company shall, without demand,
10 provide the member with all information that is known to the company and is
11 material to the member's decision.

12 (c) Subject to subsection (h), on 10 days' demand made in a record
13 received by a limited liability company, a person dissociated as a member may
14 have access to the information to which the person was entitled while a
15 member if:

16 (1) the information pertains to the period during which the
17 person was a member;

18 (2) the person seeks the information in good faith; and

19 (3) the person satisfies the requirements imposed on a member by
20 subsection (b)(2).

21 (d) A limited liability company shall respond to a demand made
22 pursuant to subsection (c) in the manner provided in subsection (b)(3).

23 (e) A limited liability company may charge a person that makes a
24 demand under this section the reasonable costs of copying, limited to the
25 costs of labor and material.

26 (f) A member or person dissociated as a member may exercise the rights
27 under this section through an agent or, in the case of an individual under
28 legal disability, a legal representative. Any restriction or condition
29 imposed by the operating agreement or under subsection (h) applies both to
30 the agent or legal representative and to the member or person dissociated as
31 a member.

32 (g) Subject to § 4-38-504, the rights under this section do not extend
33 to a person as transferee.

34 (h) In addition to any restriction or condition stated in its
35 operating agreement, a limited liability company, as a matter within the
36 ordinary course of its activities and affairs, may impose reasonable

1 restrictions and conditions on access to and use of information to be
2 furnished under this section, including designating information confidential
3 and imposing nondisclosure and safeguarding obligations on the recipient. In
4 a dispute concerning the reasonableness of a restriction under this
5 subsection, the company has the burden of proving reasonableness.

6
7 Subchapter 5 – Transferable Interests and Rights of Transferees and Creditors

8
9 4-38-501. Nature of transferrable interest.

10 A transferable interest is personal property.

11
12 4-38-502. Transfer of transferable interest.

13 (a) Subject to § 4-38-503(f), a transfer, in whole or in part, of a
14 transferable interest:

15 (1) is permissible;

16 (2) does not by itself cause a person's dissociation as a member
17 or a dissolution and winding up of the limited liability company's activities
18 and affairs; and

19 (3) subject to § 4-38-504, does not entitle the transferee to:

20 (A) participate in the management or conduct of the
21 company's activities and affairs; or

22 (B) except as otherwise provided in subsection (c), have
23 access to records or other information concerning the company's activities
24 and affairs.

25 (b) A transferee has the right to receive, in accordance with the
26 transfer, distributions to which the transferor would otherwise be entitled.

27 (c) In a dissolution and winding up of a limited liability company, a
28 transferee is entitled to an account of the company's transactions only from
29 the date of dissolution.

30 (d) A transferable interest may be evidenced by a certificate of the
31 interest issued by a limited liability company in a record, and, subject to
32 this section, the interest represented by the certificate may be transferred
33 by a transfer of the certificate.

34 (e) A limited liability company need not give effect to a transferee's
35 rights under this section until the company knows or has notice of the
36 transfer.

1 (f) A transfer of a transferable interest in violation of a
2 restriction on transfer contained in the operating agreement is ineffective
3 if the intended transferee has knowledge or notice of the restriction at the
4 time of transfer.

5 (g) Except as otherwise provided in § 4-38-602(5)(B), if a member
6 transfers a transferable interest, the transferor retains the rights of a
7 member other than the transferable interest transferred and retains all the
8 duties and obligations of a member.

9 (h) If a member transfers a transferable interest to a person that
10 becomes a member with respect to the transferred interest, the transferee is
11 liable for the member's obligations under §§ 4-38-403 and 4-38-406 known to
12 the transferee when the transferee becomes a member.

13
14 4-38-503. Charging order.

15 (a) On application by a judgment creditor of a member or transferee, a
16 court may enter a charging order against the transferable interest of the
17 judgment debtor for the unsatisfied amount of the judgment. Except as
18 otherwise provided in subsection (f), a charging order constitutes a lien on
19 a judgment debtor's transferable interest and requires the limited liability
20 company to pay over to the person to which the charging order was issued any
21 distribution that otherwise would be paid to the judgment debtor.

22 (b) To the extent necessary to effectuate the collection of
23 distributions pursuant to a charging order in effect under subsection (a),
24 the court may:

25 (1) appoint a receiver of the distributions subject to the
26 charging order, with the power to make all inquiries the judgment debtor
27 might have made; and

28 (2) make all other orders necessary to give effect to the
29 charging order.

30 (c) Upon a showing that distributions under a charging order will not
31 pay the judgment debt within a reasonable time, the court may foreclose the
32 lien and order the sale of the transferable interest. Except as otherwise
33 provided in subsection (f), the purchaser at the foreclosure sale obtains
34 only the transferable interest, does not thereby become a member, and is
35 subject to § 4-38-502.

36 (d) At any time before foreclosure under subsection (c), the member or

1 transferee whose transferable interest is subject to a charging order under
2 subsection (a) may extinguish the charging order by satisfying the judgment
3 and filing a certified copy of the satisfaction with the court that issued
4 the charging order.

5 (e) At any time before foreclosure under subsection (c), a limited
6 liability company or one or more members whose transferable interests are not
7 subject to the charging order may pay to the judgment creditor the full
8 amount due under the judgment and thereby succeed to the rights of the
9 judgment creditor, including the charging order.

10 (f) If a court orders foreclosure of a charging order lien against the
11 sole member of a limited liability company:

12 (1) the court shall confirm the sale;

13 (2) the purchaser at the sale obtains the member's entire
14 interest, not only the member's transferable interest;

15 (3) the purchaser thereby becomes a member; and

16 (4) the person whose interest was subject to the foreclosed
17 charging order is dissociated as a member.

18 (g) This chapter does not deprive any member or transferee of the
19 benefit of any exemption law applicable to the transferable interest of the
20 member or transferee.

21 (h) This section provides the exclusive remedy by which a person
22 seeking in the capacity of judgment creditor to enforce a judgment against a
23 member or transferee may satisfy the judgment from the judgment debtor's
24 transferable interest.

25
26 4-38-504. Power of legal representative of deceased member.

27 If a member dies, the deceased member's legal representative may
28 exercise:

29 (1) the rights of a transferee provided in § 4-38-502(c); and

30 (2) for the purposes of settling the estate, the rights the
31 deceased member had under § 4-38-410.

32
33 Subchapter 6 – Dissociation

34
35 4-38-601. Power to dissociate as member – Wrongful dissociation.

36 (a) A person has the power to dissociate as a member at any time,

1 rightfully or wrongfully, by withdrawing as a member by express will under §
2 4-38-602(1).

3 (b) A person's dissociation as a member is wrongful only if the
4 dissociation:

5 (1) is in breach of an express provision of the operating
6 agreement; or

7 (2) occurs before the completion of the winding up of the
8 limited liability company and:

9 (A) the person withdraws as a member by express will;

10 (B) the person is expelled as a member by judicial order
11 under § 4-38-602(6);

12 (C) the person is dissociated under § 4-38-602(8); or

13 (D) in the case of a person that is not a trust other than
14 a business trust, an estate, or an individual, the person is expelled or
15 otherwise dissociated as a member because it willfully dissolved or
16 terminated.

17 (c) A person that wrongfully dissociates as a member is liable to the
18 limited liability company and, subject to § 4-38-801, to the other members
19 for damages caused by the dissociation. The liability is in addition to any
20 debt, obligation, or other liability of the member to the company or the
21 other members.

22
23 4-38-602. Events causing dissociation.

24 A person is dissociated as a member when:

25 (1) the limited liability company knows or has notice of the
26 person's express will to withdraw as a member, but, if the person has
27 specified a withdrawal date later than the date the company knew or had
28 notice, on that later date;

29 (2) an event stated in the operating agreement as causing the
30 person's dissociation occurs;

31 (3) the person's entire interest is transferred in a foreclosure
32 sale under § 4-38-503(f);

33 (4) the person is expelled as a member pursuant to the operating
34 agreement;

35 (5) the person is expelled as a member by the affirmative vote
36 or consent of all the other members if:

1 (A) it is unlawful to carry on the limited liability
2 company's activities and affairs with the person as a member;

3 (B) there has been a transfer of all the person's
4 transferable interest in the company, other than:

5 (i) a transfer for security purposes; or

6 (ii) a charging order in effect under § 4-38-503
7 which has not been foreclosed;

8 (C) the person is an entity and:

9 (i) the company notifies the person that it will be
10 expelled as a member because the person has filed a statement of dissolution
11 or the equivalent, the person has been administratively dissolved, the
12 person's charter or the equivalent has been revoked, or the person's right to
13 conduct business has been suspended by the person's jurisdiction of
14 formation; and

15 (ii) not later than 90 days after the notification,
16 the statement of dissolution or the equivalent has not been withdrawn,
17 rescinded, or revoked, the person has not been reinstated, or the person's
18 charter or the equivalent or right to conduct business has not been
19 reinstated; or

20 (D) the person is an unincorporated entity that has been
21 dissolved and whose activities and affairs are being wound up;

22 (6) on application by the limited liability company or a member
23 in a direct action under § 4-38-801, the person is expelled as a member by
24 judicial order because the person:

25 (A) has engaged or is engaging in wrongful conduct that
26 has affected adversely and materially, or will affect adversely and
27 materially, the company's activities and affairs;

28 (B) has committed willfully or persistently, or is
29 committing willfully or persistently, a material breach of the operating
30 agreement or a duty or obligation under § 4-38-409; or

31 (C) has engaged or is engaging in conduct relating to the
32 company's activities and affairs which makes it not reasonably practicable to
33 carry on the activities and affairs with the person as a member;

34 (7) in the case of an individual:

35 (A) the individual dies; or

36 (B) in a member-managed limited liability company;

1 (i) a guardian or general conservator for the
2 individual is appointed; or

3 (ii) a court orders that the individual has
4 otherwise become incapable of performing the individual's duties as a member
5 under this chapter or the operating agreement;

6 (8) in a member-managed limited liability company, the person:

7 (A) becomes a debtor in bankruptcy;

8 (B) signs an assignment for the benefit of creditors; or

9 (C) seeks, consents to, or acquiesces in the appointment
10 of a trustee, receiver, or liquidator of the person or of all or
11 substantially all the person's property;

12 (9) in the case of a person that is a testamentary or inter
13 vivos trust or is acting as a member by virtue of being a trustee of such a
14 trust, the trust's entire transferable interest in the limited liability
15 company is distributed;

16 (10) in the case of a person that is an estate or is acting as a
17 member by virtue of being a personal representative of an estate, the
18 estate's entire transferable interest in the limited liability company is
19 distributed;

20 (11) in the case of a person that is not an individual, the
21 existence of the person terminates;

22 (12) the limited liability company participates in a merger
23 under § 4-38-1001 et seq. and:

24 (A) the company is not the surviving entity; or

25 (B) otherwise as a result of the merger, the person ceases
26 to be a member;

27 (13) the limited liability company participates in an interest
28 exchange under § 4-38-1001 et seq. and, as a result of the interest exchange,
29 the person ceases to be a member;

30 (14) the limited liability company participates in a conversion
31 under § 4-38-1001 et seq.;

32 (15) the limited liability company participates in a
33 domestication under § 4-38-1001 et seq. and, as a result of the
34 domestication, the person ceases to be a member; or

35 (16) the limited liability company dissolves and completes
36 winding up.

1
2 4-38-603. Effect of dissociation.

3 (a) If a person is dissociated as a member:

4 (1) the person's right to participate as a member in the
5 management and conduct of the limited liability company's activities and
6 affairs terminates;

7 (2) the person's duties and obligations under § 4-38-409 as a
8 member end with regard to matters arising and events occurring after the
9 person's dissociation; and

10 (3) subject to § 4-38-504 and § 4-38-1001 et seq., any
11 transferable interest owned by the person in the person's capacity as a
12 member immediately before dissociation is owned by the person solely as a
13 transferee.

14 (b) A person's dissociation as a member does not of itself discharge
15 the person from any debt, obligation, or other liability to the limited
16 liability company or the other members which the person incurred while a
17 member.

18
19 Subchapter 7 – Dissolution and Winding Up

20
21 4-38-701. Events causing dissolution.

22 (a) A limited liability company is dissolved, and its activities and
23 affairs must be wound up, upon the occurrence of any of the following:

24 (1) an event or circumstance that the operating agreement states
25 causes dissolution;

26 (2) the affirmative vote or consent of all the members;

27 (3) the passage of 90 consecutive days during which the company
28 has no members unless before the end of the period:

29 (A) consent to admit at least one specified person as a
30 member is given by transferees owning the rights to receive a majority of
31 distributions as transferees at the time the consent is to be effective; and

32 (B) at least one person becomes a member in accordance
33 with the consent;

34 (4) on application by a member, the entry by the circuit court
35 of an order dissolving the company on the grounds that:

36 (A) the conduct of all or substantially all the company's

1 activities and affairs is unlawful;

2 (B) it is not reasonably practicable to carry on the
3 company's activities and affairs in conformity with the certificate of
4 organization and the operating agreement; or

5 (C) the managers or those members in control of the
6 company:

7 (i) have acted, are acting, or will act in a manner
8 that is illegal or fraudulent; or

9 (ii) have acted or are acting in a manner that is
10 oppressive and was, is, or will be directly harmful to the applicant; or

11 (5) the signing and filing of a statement of administrative
12 dissolution by the Secretary of State under § 4-38-708.

13 (b) In a proceeding brought under subsection (a)(4)(C), the court may
14 order a remedy other than dissolution.

15
16 4-38-702. Winding up.

17 (a) A dissolved limited liability company shall wind up its activities
18 and affairs and, except as otherwise provided in § 4-38-703, the company
19 continues after dissolution only for the purpose of winding up.

20 (b) In winding up its activities and affairs, a limited liability
21 company:

22 (1) shall discharge the company's debts, obligations, and other
23 liabilities, settle and close the company's activities and affairs, and
24 marshal and distribute the assets of the company; and

25 (2) may:

26 (A) deliver to the Secretary of State for filing a
27 statement of dissolution stating the name of the company and that the company
28 is dissolved;

29 (B) preserve the company activities, affairs, and property
30 as a going concern for a reasonable time;

31 (C) prosecute and defend actions and proceedings, whether
32 civil, criminal, or administrative;

33 (D) transfer the company's property;

34 (E) settle disputes by mediation or arbitration;

35 (F) deliver to the Secretary of State for filing a
36 statement of termination stating the name of the company and that the company

1 is terminated; and

2 (G) perform other acts necessary or appropriate to the
3 winding up.

4 (c) If a dissolved limited liability company has no members, the legal
5 representative of the last person to have been a member may wind up the
6 activities and affairs of the company. If the person does so, the person has
7 the powers of a sole manager under § 4-38-407(c) and is deemed to be a
8 manager for the purposes of § 4-38-304(a).

9 (d) If the legal representative under subsection (c) declines or fails
10 to wind up the limited liability company's activities and affairs, a person
11 may be appointed to do so by the consent of transferees owning a majority of
12 the rights to receive distributions as transferees at the time the consent is
13 to be effective. A person appointed under this subsection:

14 (1) has the powers of a sole manager under § 4-38-407(c) and is
15 deemed to be a manager for the purposes of § 4-38-304(a); and

16 (2) shall deliver promptly to the Secretary of State for filing
17 an amendment to the company's certificate of organization stating:

18 (A) that the company has no members;

19 (B) the name and street and mailing addresses of the
20 person; and

21 (C) that the person has been appointed pursuant to this
22 subsection to wind up the company.

23 (e) The circuit court may order judicial supervision of the winding up
24 of a dissolved limited liability company, including the appointment of a
25 person to wind up the company's activities and affairs:

26 (1) on the application of a member, if the applicant establishes
27 good cause;

28 (2) on the application of a transferee, if:

29 (A) the company does not have any members;

30 (B) the legal representative of the last person to have
31 been a member declines or fails to wind up the company's activities; and

32 (C) within a reasonable time following the dissolution a
33 person has not been appointed pursuant to subsection (c); or

34 (3) in connection with a proceeding under § 4-38-701(a)(4).

35
36 4-38-703. Rescinding dissolution.

1 (a) A limited liability company may rescind its dissolution within 120
2 days after the election to dissolve unless:

3 (1) termination has become effective;

4 (2) a court has entered an order dissolving the limited
5 liability company; or

6 (3) the Secretary of State has dissolved the limited liability
7 company under § 4-38-708.

8 (b) Rescinding dissolution under this section requires:

9 (1) the affirmative vote or consent of each member; and

10 (2) if the limited liability company has delivered to the
11 Secretary of State for filing a statement of dissolution and:

12 (A) the statement has not become effective, delivery to
13 the Secretary of State for filing of a statement of withdrawal under § 4-38-
14 208 applicable to the statement of dissolution; or

15 (B) if the statement of dissolution has become effective,
16 delivery to the Secretary of State for filing of a statement of rescission
17 stating the name of the company and that dissolution has been rescinded under
18 this section.

19 (c) If a limited liability company rescinds its dissolution:

20 (1) the company resumes carrying on its activities and affairs
21 as if dissolution had never occurred;

22 (2) subject to paragraph (3), any liability incurred by the
23 company after the dissolution and before the rescission has become effective
24 is determined as if dissolution had never occurred; and

25 (3) the rights of a third party arising out of conduct in
26 reliance on the dissolution before the third party knew or had notice of the
27 rescission may not be adversely affected.

28
29 4-38-704. Known claims against dissolved limited liability company.

30 (a) Except as otherwise provided in subsection (d), a dissolved
31 limited liability company may give notice of a known claim under subsection
32 (b), which has the effect provided in subsection (c).

33 (b) A dissolved limited liability company may in a record notify its
34 known claimants of the dissolution. The notice must:

35 (1) specify the information required to be included in a claim;

36 (2) state that a claim must be in writing and provide a mailing

1 address to which the claim is to be sent;

2 (3) state the deadline for receipt of a claim, which may not be
3 less than 120 days after the date the notice is received by the claimant; and

4 (4) state that the claim will be barred if not received by the
5 deadline.

6 (c) A claim against a dissolved limited liability company is barred if
7 the requirements of subsection (b) are met and:

8 (1) the claim is not received by the specified deadline; or

9 (2) if the claim is timely received but rejected by the company:

10 (A) the company causes the claimant to receive a notice in
11 a record stating that the claim is rejected and will be barred unless the
12 claimant commences an action against the company to enforce the claim not
13 later than 90 days after the claimant receives the notice; and

14 (B) the claimant does not commence the required action not
15 later than 90 days after the claimant receives the notice.

16 (d) This section does not apply to a claim based on an event occurring
17 after the date of dissolution or a liability that on that date is contingent.

18
19 4-38-705. Other claims against dissolved limited liability company.

20 (a) A dissolved limited liability company may publish notice of its
21 dissolution and request persons having claims against the company to present
22 them in accordance with the notice.

23 (b) A notice under subsection (a) must:

24 (1) be published at least once in a newspaper of general
25 circulation in the county in this state in which the dissolved limited
26 liability company's principal office is located or, if the principal office
27 is not located in this state, in the county in which the office of the
28 company's registered agent is or was last located;

29 (2) describe the information required to be contained in a
30 claim, state that the claim must be in writing, and provide a mailing address
31 to which the claim is to be sent; and

32 (3) state that a claim against the company is barred unless an
33 action to enforce the claim is commenced not later than three years after
34 publication of the notice.

35 (c) If a dissolved limited liability company publishes a notice in
36 accordance with subsection (b), the claim of each of the following claimants

1 is barred unless the claimant commences an action to enforce the claim
2 against the company not later than three years after the publication date of
3 the notice:

4 (1) a claimant that did not receive notice in a record under §
5 4-38-704;

6 (2) a claimant whose claim was timely sent to the company but
7 not acted on; and

8 (3) a claimant whose claim is contingent at, or based on an
9 event occurring after, the date of dissolution.

10 (d) A claim not barred under this section or § 4-38-704 may be
11 enforced:

12 (1) against a dissolved limited liability company, to the extent
13 of its undistributed assets; and

14 (2) except as otherwise provided in § 4-38-706, if assets of the
15 company have been distributed after dissolution, against a member or
16 transferee to the extent of that person's proportionate share of the claim or
17 of the company's assets distributed to the member or transferee after
18 dissolution, whichever is less, but a person's total liability for all claims
19 under this paragraph may not exceed the total amount of assets distributed to
20 the person after dissolution.

21
22 4-38-706. Court proceedings.

23 (a) A dissolved limited liability company that has published a notice
24 under § 4-38-705 may file an application with the circuit court in the county
25 where the company's principal office is located or, if the principal office
26 is not located in this state, where the office of its registered agent is or
27 was last located, for a determination of the amount and form of security to
28 be provided for payment of claims that are reasonably expected to arise after
29 the date of dissolution based on facts known to the company and:

30 (1) at the time of application:

31 (A) are contingent; or

32 (B) have not been made known to the company; or

33 (2) are based on an event occurring after the date of
34 dissolution.

35 (b) Security is not required for any claim that is or is reasonably
36 anticipated to be barred under § 4-38-705.

1 (c) Not later than 10 days after the filing of an application under
2 subsection (a), the dissolved limited liability company shall give notice of
3 the proceeding to each claimant holding a contingent claim known to the
4 company.

5 (d) In a proceeding under this section, the court may appoint a
6 guardian ad litem to represent all claimants whose identities are unknown.
7 The reasonable fees and expenses of the guardian, including all reasonable
8 expert witness fees, must be paid by the dissolved limited liability company.

9 (e) A dissolved limited liability company that provides security in
10 the amount and form ordered by the court under subsection (a) satisfies the
11 company's obligations with respect to claims that are contingent, have not
12 been made known to the company, or are based on an event occurring after the
13 date of dissolution, and such claims may not be enforced against a member or
14 transferee on account of assets received in liquidation.

15
16 4-38-707. Disposition of assets in the winding up.

17 (a) In winding up its activities and affairs, a limited liability
18 company shall apply its assets to discharge the company's obligations to
19 creditors, including members that are creditors.

20 (b) After a limited liability company complies with subsection (a),
21 any surplus must be distributed in the following order, subject to any
22 charging order in effect under § 4-38-503:

23 (1) to each person owning a transferable interest that reflects
24 contributions made and not previously returned, an amount equal to the value
25 of the unreturned contributions; and

26 (2) among persons owning transferable interests in proportion to
27 their respective rights to share in distributions immediately before the
28 dissolution of the company.

29 (c) If a limited liability company does not have sufficient surplus to
30 comply with subsection (b)(1), any surplus must be distributed among the
31 owners of transferable interests in proportion to the value of the respective
32 unreturned contributions.

33 (d) All distributions made under subsections (b) and (c) must be paid
34 in money.

35
36 4-38-708. Administrative dissolution.

1 (a) The Secretary of State may commence a proceeding under subsection
2 (b) to dissolve a limited liability company administratively if the company
3 does not:

4 (1) pay any fee, tax, interest, or penalty required to be paid
5 to the Secretary of State not later than six months after it is due;

6 (2) deliver an annual report to the Secretary of State not later
7 than six months after it is due; or

8 (3) have a registered agent in this state for 60 consecutive
9 days.

10 (b) If the Secretary of State determines that one or more grounds
11 exist for administratively dissolving a limited liability company, the
12 Secretary of State shall serve the company with notice in a record of the
13 Secretary of State's determination.

14 (c) If a limited liability company, not later than 60 days after
15 service of the notice under subsection (b), does not cure or demonstrate to
16 the satisfaction of the Secretary of State the nonexistence of each ground
17 determined by the Secretary of State, the Secretary of State shall
18 administratively dissolve the company by signing a statement of
19 administrative dissolution that recites the grounds for dissolution and the
20 effective date of dissolution. The Secretary of State shall file the
21 statement and serve a copy on the company pursuant to § 4-38-210.

22 (d) A limited liability company that is administratively dissolved
23 continues in existence as an entity but may not carry on any activities
24 except as necessary to wind up its activities and affairs and liquidate its
25 assets under § 4-38-702, § 4-38-704, § 4-38-705, § 4-38-706, and § 4-38-707,
26 or to apply for reinstatement under § 4-38-709.

27 (e) The administrative dissolution of a limited liability company does
28 not terminate the authority of its registered agent.

29 (f) If a limited liability company is dissolved, administratively or
30 otherwise, the name is available for use by another formed limited liability
31 company, and the dissolved company would be required, upon reinstatement, to
32 use a new name if the prior name was taken.

33
34 4-38-709. Reinstatement.

35 (a) A limited liability company that is administratively dissolved
36 under § 4-38-708 may apply to the Secretary of State for reinstatement not

1 later than two years after the effective date of dissolution. The
2 application must state:

3 (1) the name of the company at the time of its administrative
4 dissolution and, if needed, a different name that satisfies § 4-38-112;

5 (2) the address of the principal office of the company and the
6 name and street and mailing addresses of its registered agent;

7 (3) the effective date of the company's administrative
8 dissolution; and

9 (4) that the grounds for dissolution did not exist or have been
10 cured.

11 (b) To be reinstated, a limited liability company must pay all fees,
12 taxes, interest, and penalties that were due to the Secretary of State at the
13 time of the company's administrative dissolution and all fees, taxes,
14 interest, and penalties that would have been due to the Secretary of State
15 while the company was administratively dissolved.

16 (c) If the Secretary of State determines that an application under
17 subsection (a) contains the required information, is satisfied that the
18 information is correct, and determines that all payments required to be made
19 to the Secretary of State by subsection (b) have been made, the Secretary of
20 State shall:

21 (1) cancel the statement of administrative dissolution and
22 prepare a statement of reinstatement that states the Secretary of State's
23 determination and the effective date of reinstatement; and

24 (2) file the statement of reinstatement and serve a copy on the
25 limited liability company.

26 (d) When reinstatement under this section has become effective, the
27 following rules apply:

28 (1) The reinstatement relates back to and takes effect as of the
29 effective date of the administrative dissolution.

30 (2) The limited liability company resumes carrying on its
31 activities and affairs as if the administrative dissolution had not occurred.

32 (3) The rights of a person arising out of an act or omission in
33 reliance on the dissolution before the person knew or had notice of the
34 reinstatement are not affected.

35
36 4-38-710. Judicial review of denial of reinstatement.

1 (a) If the Secretary of State denies a limited liability company's
2 application for reinstatement following administrative dissolution, the
3 Secretary of State shall serve the company with a notice in a record that
4 explains the reasons for the denial.

5 (b) A limited liability company may seek judicial review of denial of
6 reinstatement in the circuit court not later than 30 days after service of
7 the notice of denial.

8
9 Subchapter 8 – Actions by Members

10
11 4-38-801. Direct action by member.

12 (a) Subject to subsection (b), a member may maintain a direct action
13 against another member, a manager, or the limited liability company to
14 enforce the member's rights and protect the member's interests, including
15 rights and interests under the operating agreement or this chapter or arising
16 independently of the membership relationship.

17 (b) A member maintaining a direct action under this section must plead
18 and prove an actual or threatened injury that is not solely the result of an
19 injury suffered or threatened to be suffered by the limited liability
20 company.

21
22 4-38-802. Derivative action.

23 A member may maintain a derivative action to enforce a right of a
24 limited liability company if:

25 (1) the member first makes a demand on the other members in a
26 member-managed limited liability company, or the managers of a manager-
27 managed limited liability company, requesting that they cause the company to
28 bring an action to enforce the right, and the managers or other members do
29 not bring the action within a reasonable time; or

30 (2) a demand under paragraph (1) would be futile.

31
32 4-38-803. Proper plaintiff.

33 A derivative action to enforce a right of a limited liability company
34 may be maintained only by a person that is a member at the time the action is
35 commenced and:

36 (1) was a member when the conduct giving rise to the action

1 occurred; or

2 (2) whose status as a member devolved on the person by operation
3 of law or pursuant to the terms of the operating agreement from a person that
4 was a member at the time of the conduct.

5
6 4-38-804. Pleading.

7 In a derivative action, the complaint must state with particularity:

8 (1) the date and content of plaintiff's demand and the response
9 to the demand by the managers or other members; or

10 (2) why demand should be excused as futile.

11
12 4-38-805. Special litigation committee.

13 (a) If a limited liability company is named as or made a party in a
14 derivative proceeding, the company may appoint a special litigation committee
15 to investigate the claims asserted in the proceeding and determine whether
16 pursuing the action is in the best interests of the company. If the company
17 appoints a special litigation committee, on motion by the committee made in
18 the name of the company, except for good cause shown, the court shall stay
19 discovery for the time reasonably necessary to permit the committee to make
20 its investigation. This subsection does not prevent the court from:

21 (1) enforcing a person's right to information under add a § 4-
22 38-410; or

23 (2) granting extraordinary relief in the form of a temporary
24 restraining order or preliminary injunction.

25 (b) A special litigation committee must be composed of one or more
26 disinterested and independent individuals, who may be members.

27 (c) A special litigation committee may be appointed:

28 (1) in a member-managed limited liability company:

29 (A) by the affirmative vote or consent of a majority of
30 the members not named as parties in the proceeding; or

31 (B) if all members are named as parties in the proceeding,
32 by a majority of the members named as defendants; or

33 (2) in a manager-managed limited liability company:

34 (A) by a majority of the managers not named as parties in
35 the proceeding; or

36 (B) if all managers are named as parties in the

1 proceeding, by a majority of the managers named as defendants.

2 (d) After appropriate investigation, a special litigation committee
3 may determine that it is in the best interests of the limited liability
4 company that the proceeding:

5 (1) continue under the control of the plaintiff;

6 (2) continue under the control of the committee;

7 (3) be settled on terms approved by the committee; or

8 (4) be dismissed.

9 (e) After making a determination under subsection (d), a special
10 litigation committee shall file with the court a statement of its
11 determination and its report supporting its determination and shall serve
12 each party with a copy of the determination and report. The court shall
13 determine whether the members of the committee were disinterested and
14 independent and whether the committee conducted its investigation and made
15 its recommendation in good faith, independently, and with reasonable care,
16 with the committee having the burden of proof. If the court finds that the
17 members of the committee were disinterested and independent and that the
18 committee acted in good faith, independently, and with reasonable care, the
19 court shall enforce the determination of the committee. Otherwise, the court
20 shall dissolve the stay of discovery entered under subsection (a) and allow
21 the action to continue under the control of the plaintiff.

22
23 4-38-806. Proceeds and expenses.

24 (a) Except as otherwise provided in subsection (b):

25 (1) any proceeds or other benefits of a derivative action,
26 whether by judgment, compromise, or settlement, belong to the limited
27 liability company and not to the plaintiff; and

28 (2) if the plaintiff receives any proceeds, the plaintiff shall
29 remit them immediately to the company.

30 (b) If a derivative action is successful in whole or in part, the
31 court may award the plaintiff reasonable expenses, including reasonable
32 attorney's fees and costs, from the recovery of the limited liability
33 company.

34 (c) A derivative action on behalf of a limited liability company may
35 not be voluntarily dismissed or settled without the court's approval.

36

1 Subchapter 9 – Foreign Limited Liability Companies

2
3 4-38-901. Governing law.

4 (a) The law of the jurisdiction of formation of a foreign limited
5 liability company governs:

6 (1) the internal affairs of the company;

7 (2) the liability of a member as member and a manager as manager
8 for a debt, obligation, or other liability of the company; and

9 (3) the liability of a series of the company.

10 (b) A foreign limited liability company is not precluded from
11 registering to do business in this state because of any difference between
12 the law of its jurisdiction of formation and the law of this state.

13 (c) Registration of a foreign limited liability company to do business
14 in this state does not authorize the foreign company to engage in any
15 activities and affairs or exercise any power that a limited liability company
16 may not engage in or exercise in this state.

17
18 4-38-902. Registration to do business in this state.

19 (a) A foreign limited liability company may not do business in this
20 state until it registers with the Secretary of State under this subchapter.

21 (b) A foreign limited liability company doing business in this state
22 may not maintain an action or proceeding in this state unless it is
23 registered to do business in this state.

24 (c) The failure of a foreign limited liability company to register to
25 do business in this state does not impair the validity of a contract or act
26 of the company or preclude it from defending an action or proceeding in this
27 state.

28 (d) A limitation on the liability of a member or manager of a foreign
29 limited liability company is not waived solely because the company does
30 business in this state without registering to do business in this state.

31 (e) Section 4-38-901(a) and (b) applies even if a foreign limited
32 liability company fails to register under this subchapter.

33
34 4-38-903. Foreign registration statement.

35 To register to do business in this state, a foreign limited liability
36 company must deliver a foreign registration statement to the Secretary of

1 State for filing. The statement must state:

2 (1) the name of the company and, if the name does not comply
3 with § 4-38-112, an alternate name adopted pursuant to § 4-38-906(a);

4 (2) that the company is a foreign limited liability company;

5 (3) the company's jurisdiction of formation;

6 (4) the street and mailing addresses of the company's principal
7 office and, if the law of the company's jurisdiction of formation requires
8 the company to maintain an office in that jurisdiction, the street and
9 mailing addresses of the required office; and

10 (5) the name and street and mailing addresses of the company's
11 registered agent in this state.

12
13 4-38-904. Amendment of foreign registration statement.

14 A registered foreign limited liability company shall deliver to the
15 Secretary of State for filing an amendment to its foreign registration
16 statement if there is a change in:

17 (1) the name of the company;

18 (2) the company's jurisdiction of formation;

19 (3) an address required by § 4-38-903(4); or

20 (4) the information required by § 4-38-903(5).

21
22 4-38-905. Activities not constituting doing business.

23 (a) Activities of a foreign limited liability company which do not
24 constitute doing business in this state under this subchapter include:

25 (1) maintaining, defending, mediating, arbitrating, or settling
26 an action or proceeding;

27 (2) carrying on any activity concerning its internal affairs,
28 including holding meetings of its members or managers;

29 (3) maintaining accounts in financial institutions;

30 (4) maintaining offices or agencies for the transfer, exchange,
31 and registration of securities of the company or maintaining trustees or
32 depositories with respect to those securities;

33 (5) selling through independent contractors;

34 (6) soliciting or obtaining orders by any means if the orders
35 require acceptance outside this state before they become contracts;

36 (7) creating or acquiring indebtedness, mortgages, or security

1 interests in property;

2 (8) securing or collecting debts or enforcing mortgages or
3 security interests in property securing the debts and holding, protecting, or
4 maintaining property;

5 (9) conducting an isolated transaction that is not in the course
6 of similar transactions;

7 (10) owning, without more, property; and

8 (11) doing business in interstate commerce.

9 (b) A person does not do business in this state solely by being a
10 member or manager of a foreign limited liability company that does business
11 in this state.

12 (c) This section does not apply in determining the contacts or
13 activities that may subject a foreign limited liability company to service of
14 process, taxation, or regulation under law of this state other than this
15 chapter.

16
17 4-38-906. Noncomplying name of foreign limited liability company.

18 (a) A foreign limited liability company whose name does not comply
19 with § 4-38-112 may not register to do business in this state until it
20 adopts, for the purpose of doing business in this state, an alternate name
21 that complies with § 4-38-112. A company that registers under an alternate
22 name under this subsection need not comply with § 4-26-405, § 4-27-404, or §
23 4-42-707. After registering to do business in this state with an alternate
24 name, a company shall do business in this state under:

25 (1) the alternate name;

26 (2) the company's name, with the addition of its jurisdiction of
27 formation; or

28 (3) a name the company is authorized to use under § 4-26-405, §
29 4-27-404, and § 4-42-707.

30 (b) If a registered foreign limited liability company changes its name
31 to one that does not comply with § 4-38-112, it may not do business in this
32 state until it complies with subsection (a) by amending its registration to
33 adopt an alternate name that complies with § 4-38-112.

34
35 4-38-907. Withdrawal deemed on conversion to domestic filing entity or
36 domestic limited liability partnership.

1 A registered foreign limited liability company that converts to a
2 domestic limited liability partnership or to a domestic entity whose
3 formation requires delivery of a record to the Secretary of State for filing
4 is deemed to have withdrawn its registration on the effective date of the
5 conversion.

6
7 4-38-908. Withdrawal on dissolution or conversion to nonfiling entity
8 other than limited liability partnership.

9 (a) A registered foreign limited liability company that has dissolved
10 and completed winding up or has converted to a domestic or foreign entity
11 whose formation does not require the public filing of a record, other than a
12 limited liability partnership, shall deliver a statement of withdrawal to the
13 Secretary of State for filing. The statement must state:

14 (1) in the case of a company that has completed winding up:

15 (A) its name and jurisdiction of formation;

16 (B) that the company surrenders its registration to do
17 business in this state; and

18 (2) in the case of a company that has converted:

19 (A) the name of the converting company and its
20 jurisdiction of formation;

21 (B) the type of entity to which the company has converted
22 and its jurisdiction of formation;

23 (C) that the converted entity surrenders the converting
24 company's registration to do business in this state and revokes the authority
25 of the converting company's registered agent to act as registered agent in
26 this state on behalf of the company or the converted entity; and

27 (D) a mailing address to which service of process may be
28 made under subsection (b).

29 (b) After a withdrawal under this section has become effective,
30 service of process in any action or proceeding based on a cause of action
31 arising during the time the foreign limited liability company was registered
32 to do business in this state may be made pursuant to § 4-38-119.

33
34 4-38-909. Transfer of registration.

35 (a) When a registered foreign limited liability company has merged
36 into a foreign entity that is not registered to do business in this state or

1 has converted to a foreign entity required to register with the Secretary of
2 State to do business in this state, the foreign entity shall deliver to the
3 Secretary of State for filing an application for transfer of registration.

4 The application must state:

5 (1) the name of the registered foreign limited liability company
6 before the merger or conversion;

7 (2) that before the merger or conversion the registration
8 pertained to a foreign limited liability company;

9 (3) the name of the applicant foreign entity into which the
10 foreign limited liability company has merged or to which it has been
11 converted and, if the name does not comply with § 4-38-112, an alternate name
12 adopted pursuant to § 4-38-906(a);

13 (4) the type of entity of the applicant foreign entity and its
14 jurisdiction of formation;

15 (5) the street and mailing addresses of the principal office of
16 the applicant foreign entity and, if the law of the entity's jurisdiction of
17 formation requires the entity to maintain an office in that jurisdiction, the
18 street and mailing addresses of that office; and

19 (6) the name and street and mailing addresses of the applicant
20 foreign entity's registered agent in this state.

21 (b) When an application for transfer of registration takes effect, the
22 registration of the foreign limited liability company to do business in this
23 state is transferred without interruption to the foreign entity into which
24 the company has merged or to which it has been converted.

25
26 4-38-910. Termination of registration.

27 (a) The Secretary of State may terminate the registration of a
28 registered foreign limited liability company in the manner provided in
29 subsections (b) and (c) if the company does not:

30 (1) pay, not later than 60 days after the due date, any fee,
31 tax, interest, or penalty required to be paid to the Secretary of State under
32 this chapter or law other than this chapter;

33 (2) deliver to the Secretary of State for filing, not later than
34 60 days after the due date, an annual report required under § 4-38-212;

35 (3) have a registered agent as required by § 4-38-115; or

36 (4) deliver to the Secretary of State for filing a statement of

1 a change under § 4-38-116 not later than 30 days after a change has occurred
2 in the name or address of the registered agent.

3 (b) The Secretary of State may terminate the registration of a
4 registered foreign limited liability company by:

5 (1) filing a notice of termination or noting the termination in
6 the records of the Secretary of State; and

7 (2) delivering a copy of the notice or the information in the
8 notation to the company's registered agent or, if the company does not have a
9 registered agent, to the company's principal office.

10 (c) The notice must state or the information in the notation must
11 include:

12 (1) the effective date of the termination, which must be at
13 least 60 days after the date the Secretary of State delivers the copy; and

14 (2) the grounds for termination under subsection (a).

15 (d) The authority of a registered foreign limited liability company to
16 do business in this state ceases on the effective date of the notice of
17 termination or notation under subsection (b), unless before that date the
18 company cures each ground for termination stated in the notice or notation.
19 If the company cures each ground, the Secretary of State shall file a record
20 so stating.

21
22 4-38-911. Withdrawal of registration of registered foreign limited
23 liability company.

24 (a) A registered foreign limited liability company may withdraw its
25 registration by delivering a statement of withdrawal to the Secretary of
26 State for filing. The statement of withdrawal must state:

27 (1) the name of the company and its jurisdiction of formation;

28 (2) that the company is not doing business in this state and
29 that it withdraws its registration to do business in this state;

30 (3) that the company revokes the authority of its registered
31 agent to accept service on its behalf in this state; and

32 (4) an address to which service of process may be made under
33 subsection (b).

34 (b) After the withdrawal of the registration of a foreign limited
35 liability company, service of process in any action or proceeding based on a
36 cause of action arising during the time the company was registered to do

1 business in this state may be made pursuant to § 4-38-119.

2
3 4-38-912. Action by Attorney General.

4 The Attorney General may maintain an action to enjoin a foreign limited
5 liability company from doing business in this state in violation of this
6 chapter.

7
8 4-38-913. Transaction of business without registration.

9 (a) A foreign limited liability company transacting business in this
10 state shall not maintain an action, suit, or proceeding in a court of this
11 state until it has registered in this state.

12 (b) The failure of a foreign limited liability company to register in
13 this state does not:

14 (1) impair the validity of any contract or act of the foreign
15 limited liability company;

16 (2) affect the right of any other party to the contract to
17 maintain any action, suit, or proceeding on the contract; or

18 (3) prevent the foreign limited liability company from defending
19 any action, suit, or proceeding in any court of this state.

20 (c) A foreign limited liability company transacting business in this
21 state without registration may be served with process under § 4-20-113 if the
22 foreign limited liability company:

23 (1) fails to appoint an agent for service of process under § 4-
24 20-112;

25 (2) no longer has an agent for service of process; or

26 (3) has an agent for service of process that cannot with
27 reasonable diligence be served.

28 (d)(1) A foreign limited liability company which transacts business in
29 this state without registration shall be liable to the state for the years or
30 parts thereof during which it transacted business in this state without
31 registration in an amount equal to all fees which would have been imposed by
32 this chapter upon that foreign limited liability company had it duly
33 registered and all penalties imposed by this chapter.

34 (2) The Attorney General may bring proceedings to recover all
35 amounts due this state under the provisions of this section.

36 (e) A foreign limited liability company which transacts business in

1 this state without registration shall be subject to a civil penalty, payable
 2 to the state, not to exceed five thousand dollars (\$5,000) for each twelve-
 3 month period or part thereof, beginning with the date it began transacting
 4 business in this state and ending on the date it becomes registered.

5 (f)(1) The civil penalty set forth in subsection (e) of this section
 6 may be recovered in an action brought within a court by the Attorney General.

7 (2) Upon a finding by the court that a foreign limited liability
 8 company has transacted business in this state in violation of this chapter,
 9 the court shall issue, in addition to the imposition of a civil penalty, an
 10 injunction restraining further transactions of the business of the foreign
 11 limited liability company and the further exercise of any limited liability
 12 company's rights and privileges in this state.

13 (3) The foreign limited liability company shall be enjoined from
 14 transacting business in this state until all civil penalties plus any
 15 interest and court costs which the court may assess have been paid and until
 16 the foreign limited liability company has otherwise complied with this
 17 subchapter.

18 (g) A member or manager of a foreign limited liability company is not
 19 liable for the debts and obligations of the limited liability company solely
 20 because the limited liability company transacted business in this state
 21 without registration.

 23 Subchapter 10 – Merger, Interest Exchange, Conversion, and Domestication
 24

25 PART 1 – General Provisions
 26

27 4-38-1001. Definitions.

28 In this subchapter:

29 (1) “Acquired entity” means the entity, all of one or more
 30 classes or series of interests of which are acquired in an interest exchange.

31 (2) “Acquiring entity” means the entity that acquires all of one
 32 or more classes or series of interests of the acquired entity in an interest
 33 exchange.

34 (3) “Conversion” means a transaction authorized by Part 4.

35 (4) “Converted entity” means the converting entity as it
 36 continues in existence after a conversion.

1 (5) “Converting entity” means the domestic entity that approves
2 a plan of conversion pursuant to § 4-38-1043 or the foreign entity that
3 approves a conversion pursuant to the law of its jurisdiction of formation.

4 (6) “Distributional interest” means the right under an
5 unincorporated entity’s organic law and organic rules to receive
6 distributions from the entity.

7 (7) “Domestic”, with respect to an entity, means governed as to
8 its internal affairs by the law of this state.

9 (8) “Domesticated limited liability company” means the
10 domesticating limited liability company as it continues in existence after a
11 domestication.

12 (9) “Domesticating limited liability company” means the domestic
13 limited liability company that approves a plan of domestication pursuant to §
14 4-38-1053 or the foreign limited liability company that approves a
15 domestication pursuant to the law of its jurisdiction of formation.

16 (10) “Domestication” means a transaction authorized by Part 5.

17 (11) “Entity”:

18 (A) means:

19 (i) a business corporation;

20 (ii) a nonprofit corporation;

21 (iii) a general partnership, including a limited
22 liability partnership;

23 (iv) a limited partnership, including a limited
24 liability limited partnership;

25 (v) a limited liability company;

26 (vi) a general cooperative association;

27 (vii) a limited cooperative association;

28 (viii) an unincorporated nonprofit association;

29 (ix) a statutory trust, business trust, or common-
30 law business trust; or

31 (x) any other person that has:

32 (I) a legal existence separate from any
33 interest holder of that person; or

34 (II) the power to acquire an interest in real
35 property in its own name; and

36 (B) does not include:

- 1 (i) an individual;
2 (ii) a trust with a predominantly donative purpose
3 or a charitable trust;
4 (iii) an association or relationship that is not an
5 entity listed in subparagraph A and is not a partnership under the rules
6 stated in § 4-46-202(c) of the Uniform Partnership Act (1996) or a similar
7 provision of the law of another jurisdiction;
8 (iv) a decedent's estate; or
9 (v) a government or a governmental subdivision,
10 agency, or instrumentality.

11 (12) "Filing entity" means an entity whose formation requires
12 the filing of a public organic record. The term does not include a limited
13 liability partnership.

14 (13) "Foreign", with respect to an entity, means an entity
15 governed as to its internal affairs by the law of a jurisdiction other than
16 this state.

17 (14) "Governance interest" means a right under the organic law
18 or organic rules of an unincorporated entity, other than as a governor,
19 agent, assignee, or proxy, to:

20 (A) receive or demand access to information concerning, or
21 the books and records of, the entity;

22 (B) vote for or consent to the election of the governors
23 of the entity; or

24 (C) receive notice of or vote on or consent to an issue
25 involving the internal affairs of the entity.

26 (15) "Governor" means:

27 (A) a director of a business corporation;

28 (B) a director or trustee of a nonprofit corporation;

29 (C) a general partner of a general partnership;

30 (D) a general partner of a limited partnership;

31 (E) a manager of a manager-managed limited liability
32 company;

33 (F) a member of a member-managed limited liability
34 company;

35 (G) a director of a general cooperative association;

36 (H) a director of a limited cooperative association;

1 (I) a manager of an unincorporated nonprofit association;
2 (J) a trustee of a statutory trust, business trust, or
3 common-law business trust; or

4 (K) any other person under whose authority the powers of
5 an entity are exercised and under whose direction the activities and affairs
6 of the entity are managed pursuant to the organic law and organic rules of
7 the entity.

8 (16) "Interest" means:

9 (A) a share in a business corporation;

10 (B) a membership in a nonprofit corporation;

11 (C) a partnership interest in a general partnership;

12 (D) a partnership interest in a limited partnership;

13 (E) a membership interest in a limited liability company;

14 (F) a share in a general cooperative association;

15 (G) a member's interest in a limited cooperative
16 association;

17 (H) a membership in an unincorporated nonprofit
18 association;

19 (I) a beneficial interest in a statutory trust, business
20 trust, or common-law business trust; or

21 (J) a governance interest or distributional interest in
22 any other type of unincorporated entity.

23 (17) "Interest exchange" means a transaction authorized by Part
24 3.

25 (18) "Interest holder" means:

26 (A) a shareholder of a business corporation;

27 (B) a member of a nonprofit corporation;

28 (C) a general partner of a general partnership;

29 (D) a general partner of a limited partnership;

30 (E) a limited partner of a limited partnership;

31 (F) a member of a limited liability company;

32 (G) a shareholder of a general cooperative association;

33 (H) a member of a limited cooperative association;

34 (I) a member of an unincorporated nonprofit association;

35 (J) a beneficiary or beneficial owner of a statutory
36 trust, business trust, or common-law business trust; or

1 (K) any other direct holder of an interest.

2 (19) "Interest holder liability" means:

3 (A) personal liability for a liability of an entity which
4 is imposed on a person:

5 (i) solely by reason of the status of the person as
6 an interest holder; or

7 (ii) by the organic rules of the entity which make
8 one or more specified interest holders or categories of interest holders
9 liable in their capacity as interest holders for all or specified liabilities
10 of the entity; or

11 (B) an obligation of an interest holder under the organic
12 rules of an entity to contribute to the entity.

13 (20) "Merger" means a transaction authorized by Part 2.

14 (21) "Merging entity" means an entity that is a party to a
15 merger and exists immediately before the merger becomes effective.

16 (22) "Organic law" means the law of an entity's jurisdiction of
17 formation governing the internal affairs of the entity.

18 (23) "Organic rules" means the public organic record and private
19 organic rules of an entity.

20 (24) "Plan" means a plan of merger, plan of interest exchange,
21 plan of conversion, or plan of domestication.

22 (25) "Plan of conversion" means a plan under § 4-38-1042.

23 (26) "Plan of domestication" means a plan under § 4-38-1052.

24 (27) "Plan of interest exchange" means a plan under § 4-38-1032.

25 (28) "Plan of merger" means a plan under § 4-38-1022.

26 (29) "Private organic rules" means the rules, whether or not in
27 a record, that govern the internal affairs of an entity, are binding on all
28 its interest holders, and are not part of its public organic record, if any.

29 The term includes:

30 (A) the bylaws of a business corporation;

31 (B) the bylaws of a nonprofit corporation;

32 (C) the partnership agreement of a general partnership;

33 (D) the partnership agreement of a limited partnership;

34 (E) the operating agreement of a limited liability
35 company;

36 (F) the bylaws of a general cooperative association;

1 (G) the bylaws of a limited cooperative association;

2 (H) the governing principles of an unincorporated
3 nonprofit association; and

4 (I) the trust instrument of a statutory trust or similar
5 rules of a business trust or common-law business trust.

6 (30) "Protected agreement" means:

7 (A) a record evidencing indebtedness and any related
8 agreement in effect on the effective date of this chapter;

9 (B) an agreement that is binding on an entity on the
10 effective date of this chapter;

11 (C) the organic rules of an entity in effect on the
12 effective date of this chapter; or

13 (D) an agreement that is binding on any of the governors
14 or interest holders of an entity on the effective date of this chapter.

15 (31) "Public organic record" means the record the filing of
16 which by the Secretary of State is required to form an entity and any
17 amendment to or restatement of that record. The term includes:

18 (A) the articles of incorporation of a business
19 corporation;

20 (B) the articles of incorporation of a nonprofit
21 corporation;

22 (C) the certificate of limited partnership of a limited
23 partnership;

24 (D) the certificate of organization of a limited liability
25 company;

26 (E) the articles of incorporation of a general cooperative
27 association;

28 (F) the articles of organization of a limited cooperative
29 association; and

30 (G) the certificate of trust of a statutory trust or
31 similar record of a business trust.

32 (32) "Registered foreign entity" means a foreign entity that is
33 registered to do business in this state pursuant to a record filed by the
34 Secretary of State.

35 (33) "Statement of conversion" means a statement under § 4-38-
36 1045.

1 (34) "Statement of domestication" means a statement under § 4-
2 38-1055.

3 (35) "Statement of interest exchange" means a statement under §
4 4-38-1035.

5 (36) "Statement of merger" means a statement under § 4-38-1025.

6 (37) "Surviving entity" means the entity that continues in
7 existence after or is created by a merger.

8 (38) "Type of entity" means a generic form of entity:

9 (A) recognized at common law; or

10 (B) formed under an organic law, whether or not some
11 entities formed under that organic law are subject to provisions of that law
12 that create different categories of the form of entity.

13
14 4-38-1002. Relationship of chapter to other laws.

15 (a) This chapter does not authorize an act prohibited by, and does not
16 affect the application or requirements of, law other than this chapter.

17 (b) A transaction effected under this chapter may not create or impair
18 a right, duty or obligation of a person under the statutory law of this state
19 other than this chapter relating to a change in control, takeover, business
20 combination, control-share acquisition, or similar transaction involving a
21 domestic merging, acquired, converting, or domesticating business corporation
22 unless:

23 (1) if the corporation does not survive the transaction, the
24 transaction satisfies any requirements of the law; or

25 (2) if the corporation survives the transaction, the approval of
26 the plan is by a vote of the shareholders or directors which would be
27 sufficient to create or impair the right, duty, or obligation directly under
28 the law.

29
30 4-38-1003. Required notice or approval.

31 (a) A domestic or foreign entity that is required to give notice to,
32 or obtain the approval of, a governmental agency or officer of this state to
33 be a party to a merger must give the notice or obtain the approval to be a
34 party to an interest exchange, conversion, or domestication.

35 (b) Property held for a charitable purpose under the law of this state
36 by a domestic or foreign entity immediately before a transaction under this

1 chapter becomes effective may not, as a result of the transaction, be
2 diverted from the objects for which it was donated, granted, devised, or
3 otherwise transferred unless, to the extent required by or pursuant to the
4 law of this state concerning cy pres or other law dealing with nondiversion
5 of charitable assets, the entity obtains an appropriate order of the circuit
6 court the Attorney General specifying the disposition of the property.

7 (c) A bequest, devise, gift, grant, or promise contained in a will or
8 other instrument of donation, subscription, or conveyance which is made to a
9 merging entity that is not the surviving entity and which takes effect or
10 remains payable after the merger inures to the surviving entity.

11 (d) A trust obligation that would govern property if transferred to a
12 nonsurviving entity applies to property that is transferred to the surviving
13 entity under this section.

14
15 4-38-1004. Nonexclusivity.

16 The fact that a transaction under this chapter produces a certain
17 result does not preclude the same result from being accomplished in any other
18 manner permitted by law other than this chapter.

19
20 4-38-1005. Reference to external facts.

21 A plan may refer to facts ascertainable outside the plan if the manner
22 in which the facts will operate upon the plan is specified in the plan. The
23 facts may include the occurrence of an event or a determination or action by
24 a person, whether or not the event, determination, or action is within the
25 control of a party to the transaction.

26
27 4-38-1006. Appraisal rights.

28 An interest holder of a domestic merging, acquired, converting, or
29 domesticating limited liability company is entitled to contractual appraisal
30 rights in connection with a transaction under this chapter to the extent
31 provided in:

32 (1) the operating agreement; or

33 (2) the plan.

34
35 PART 2 – Merger

36

1 4-38-1021. Merger authorized.

2 (a) By complying with this part:

3 (1) one or more domestic limited liability companies may merge
4 with one or more domestic or foreign entities into a domestic or foreign
5 surviving entity; and

6 (2) two or more foreign entities may merge into a domestic
7 limited liability company.

8 (b) By complying with the provisions of this part applicable to
9 foreign entities, a foreign entity may be a party to a merger under this part
10 or may be the surviving entity in such a merger if the merger is authorized
11 by the law of the foreign entity's jurisdiction of formation.

12
13 4-38-1022. Plan of merger.

14 (a) A domestic limited liability company may become a party to a
15 merger under this part by approving a plan of merger. The plan must be in a
16 record and contain:

17 (1) as to each merging entity, its name, jurisdiction of
18 formation, and type of entity;

19 (2) if the surviving entity is to be created in the merger, a
20 statement to that effect and the entity's name, jurisdiction of formation,
21 and type of entity;

22 (3) the manner of converting the interests in each party to the
23 merger into interests, securities, obligations, money, other property, rights
24 to acquire interests or securities, or any combination of the foregoing;

25 (4) if the surviving entity exists before the merger, any
26 proposed amendments to:

27 (A) its public organic record, if any; and

28 (B) its private organic rules that are, or are proposed to
29 be, in a record;

30 (5) if the surviving entity is to be created in the merger:

31 (A) its proposed public organic record, if any; and

32 (B) the full text of its private organic rules that are
33 proposed to be in a record;

34 (6) the other terms and conditions of the merger; and

35 (7) any other provision required by the law of a merging
36 entity's jurisdiction of formation or the organic rules of a merging entity.

1 (b) In addition to the requirements of subsection (a), a plan of
2 merger may contain any other provision not prohibited by law.

3
4 4-38-1023. Approval of merger.

5 (a) A plan of merger is not effective unless it has been approved:

6 (1) by a domestic merging limited liability company, by all the
7 members of the company entitled to vote on or consent to any matter; and

8 (2) in a record, by each member of a domestic merging limited
9 liability company which will have interest holder liability for debts,
10 obligations, and other liabilities that are incurred after the merger becomes
11 effective, unless:

12 (A) the operating agreement of the company provides in a
13 record for the approval of a merger in which some or all of its members
14 become subject to interest holder liability by the affirmative vote or
15 consent of fewer than all the members; and

16 (B) the member consented in a record to or voted for that
17 provision of the operating agreement or became a member after the adoption of
18 that provision.

19 (b) A merger involving a domestic merging entity that is not a limited
20 liability company is not effective unless the merger is approved by that
21 entity in accordance with its organic law.

22 (c) A merger involving a foreign merging entity is not effective
23 unless the merger is approved by the foreign entity in accordance with the
24 law of the foreign entity's jurisdiction of formation.

25
26 4-38-1024. Amendment or abandonment of plan of merger.

27 (a) A plan of merger may be amended only with the consent of each
28 party to the plan, except as otherwise provided in the plan.

29 (b) A domestic merging limited liability company may approve an
30 amendment of a plan of merger:

31 (1) in the same manner as the plan was approved, if the plan
32 does not provide for the manner in which it may be amended; or

33 (2) by its managers or members in the manner provided in the
34 plan, but a member that was entitled to vote on or consent to approval of the
35 merger is entitled to vote on or consent to any amendment of the plan that
36 will change:

1 (A) the amount or kind of interests, securities,
2 obligations, money, other property, rights to acquire interests or
3 securities, or any combination of the foregoing, to be received by the
4 interest holders of any party to the plan;

5 (B) the public organic record, if any, or private organic
6 rules of the surviving entity that will be in effect immediately after the
7 merger becomes effective, except for changes that do not require approval of
8 the interest holders of the surviving entity under its organic law or organic
9 rules; or

10 (C) any other terms or conditions of the plan, if the
11 change would adversely affect the member in any material respect.

12 (c) After a plan of merger has been approved and before a statement of
13 merger becomes effective, the plan may be abandoned as provided in the plan.
14 Unless prohibited by the plan, a domestic merging limited liability company
15 may abandon the plan in the same manner as the plan was approved.

16 (d) If a plan of merger is abandoned after a statement of merger has
17 been delivered to the Secretary of State for filing and before the statement
18 becomes effective, a statement of abandonment, signed by a party to the plan,
19 must be delivered to the Secretary of State for filing before the statement
20 of merger becomes effective. The statement of abandonment takes effect on
21 filing, and the merger is abandoned and does not become effective. The
22 statement of abandonment must contain:

23 (1) the name of each party to the plan of merger;

24 (2) the date on which the statement of merger was filed by the
25 Secretary of State; and

26 (3) a statement that the merger has been abandoned in accordance
27 with this section.

28
29 4-38-1025. Statement of merger – Effective date of merger.

30 (a) A statement of merger must be signed by each merging entity and
31 delivered to the Secretary of State for filing.

32 (b) A statement of merger must contain:

33 (1) the name, jurisdiction of formation, and type of entity of
34 each merging entity that is not the surviving entity;

35 (2) the name, jurisdiction of formation, and type of entity of
36 the surviving entity;

1 (3) a statement that the merger was approved by each domestic
2 merging entity, if any, in accordance with this part and by each foreign
3 merging entity, if any, in accordance with the law of its jurisdiction of
4 formation;

5 (4) if the surviving entity exists before the merger and is a
6 domestic filing entity, any amendment to its public organic record approved
7 as part of the plan of merger;

8 (5) if the surviving entity is created by the merger and is a
9 domestic filing entity, its public organic record, as an attachment; and

10 (6) if the surviving entity is created by the merger and is a
11 domestic limited liability partnership, its statement of qualification, as an
12 attachment.

13 (c) In addition to the requirements of subsection (b), a statement of
14 merger may contain any other provision not prohibited by law.

15 (d) If the surviving entity is a domestic entity, its public organic
16 record, if any, must satisfy the requirements of the law of this state,
17 except that the public organic record does not need to be signed.

18 (e) A plan of merger that is signed by all the merging entities and
19 meets all the requirements of subsection (b) may be delivered to the
20 Secretary of State for filing instead of a statement of merger and on filing
21 has the same effect. If a plan of merger is filed as provided in this
22 subsection, references in this article to a statement of merger refer to the
23 plan of merger filed under this subsection.

24 (f) If the surviving entity is a domestic limited liability company,
25 the merger becomes effective when the statement of merger is effective. In
26 all other cases, the merger becomes effective on the later of:

27 (1) the date and time provided by the organic law of the
28 surviving entity; and

29 (2) when the statement is effective.

30
31 4-38-1026. Effect of merger.

32 (a) When a merger becomes effective:

33 (1) the surviving entity continues or comes into existence;

34 (2) each merging entity that is not the surviving entity ceases
35 to exist;

36 (3) all property of each merging entity vests in the surviving

1 entity without transfer, reversion, or impairment;

2 (4) all debts, obligations, and other liabilities of each
3 merging entity are debts, obligations, and other liabilities of the surviving
4 entity;

5 (5) except as otherwise provided by law or the plan of merger,
6 all the rights, privileges, immunities, powers, and purposes of each merging
7 entity vest in the surviving entity;

8 (6) if the surviving entity exists before the merger:

9 (A) all its property continues to be vested in it without
10 transfer, reversion, or impairment;

11 (B) it remains subject to all its debts, obligations, and
12 other liabilities; and

13 (C) all its rights, privileges, immunities, powers, and
14 purposes continue to be vested in it;

15 (7) the name of the surviving entity may be substituted for the
16 name of any merging entity that is a party to any pending action or
17 proceeding;

18 (8) if the surviving entity exists before the merger:

19 (A) its public organic record, if any, is amended to the
20 extent provided in the statement of merger; and

21 (B) its private organic rules that are to be in a record,
22 if any, are amended to the extent provided in the plan of merger;

23 (9) if the surviving entity is created by the merger, its
24 private organic rules are effective and:

25 (A) if it is a filing entity, its public organic record
26 becomes effective; and

27 (B) if it is a limited liability partnership, its
28 statement of qualification becomes effective; and

29 (10) the interests in each merging entity which are to be
30 converted in the merger are converted, and the interest holders of those
31 interests are entitled only to the rights provided to them under the plan of
32 merger and to any appraisal rights they have under § 4-38-1006 and the
33 merging entity's organic law.

34 (b) Except as otherwise provided in the organic law or organic rules
35 of a merging entity, the merger does not give rise to any rights that an
36 interest holder, governor, or third party would have upon a dissolution,

1 liquidation, or winding up of the merging entity.

2 (c) When a merger becomes effective, a person that did not have
3 interest holder liability with respect to any of the merging entities and
4 becomes subject to interest holder liability with respect to a domestic
5 entity as a result of the merger has interest holder liability only to the
6 extent provided by the organic law of that entity and only for those debts,

9 (d) When a merger becomes effective, the interest holder liability of
10 a person that ceases to hold an interest in a domestic merging limited
11 liability company with respect to which the person had interest holder
12 liability is subject to the following rules:

13 (1) The merger does not discharge any interest holder liability
14 under this chapter to the extent the interest holder liability was incurred
15 before the merger became effective;

16 (2) The person does not have interest holder liability under
17 this chapter for any debt, obligation, or other liability that is incurred
18 after the merger becomes effective;

19 (3) This chapter continues to apply to the release, collection,
20 or discharge of any interest holder liability preserved under paragraph (1)
21 as if the merger had not occurred; and

22 (4) The person has whatever rights of contribution from any
23 other person as are provided by this chapter, law other than this chapter, or
24 the operating agreement of the domestic merging limited liability company
25 with respect to any interest holder liability preserved under paragraph (1)
26 as if the merger had not occurred.

27 (e) When a merger becomes effective, a foreign entity that is the
28 surviving entity may be served with process in this state for the collection
29 and enforcement of any debts, obligations, or other liabilities of a domestic
30 merging limited liability company as provided in § 4-38-119.

31 (f) When a merger becomes effective, the registration to do business
32 in this state of any foreign merging entity that is not the surviving entity
33 is canceled.

34
35 PART 3 – Interest Exchange
36

1 4-38-1031. Interest exchange authorized.

2 (a) By complying with this part:

3 (1) a domestic limited liability company may acquire all of one
4 or more classes or series of interests of another domestic entity or a
5 foreign entity in exchange for interests, securities, obligations, money,
6 other property, rights to acquire interests or securities, or any combination
7 of the foregoing; or

8 (2) all of one or more classes or series of interests of a
9 domestic limited liability company may be acquired by another domestic entity
10 or a foreign entity in exchange for interests, securities, obligations,
11 money, other property, rights to acquire interests or securities, or any
12 combination of the foregoing.

13 (b) By complying with the provisions of this part applicable to
14 foreign entities, a foreign entity may be the acquiring or acquired entity in
15 an interest exchange under this part if the interest exchange is authorized
16 by the law of the foreign entity's jurisdiction of formation.

17 (c) If a protected agreement contains a provision that applies to a
18 merger of a domestic limited liability company but does not refer to an
19 interest exchange, the provision applies to an interest exchange in which the
20 domestic limited liability company is the acquired entity as if the interest
21 exchange were a merger until the provision is amended after the effective
22 date of this chapter.

23
24 4-38-1032. Plan of interest exchange.

25 (a) A domestic limited liability company may be the acquired entity in
26 an interest exchange under this part by approving a plan of interest
27 exchange. The plan must be in a record and contain:

28 (1) the name of the acquired entity;

29 (2) the name, jurisdiction of formation, and type of entity of
30 the acquiring entity;

31 (3) the manner of converting the interests in the acquired
32 entity into interests, securities, obligations, money, other property, rights
33 to acquire interests or securities, or any combination of the foregoing;

34 (4) any proposed amendments to:

35 (A) the certificate of organization of the acquired
36 entity; and

1 (B) the operating agreement of the acquired entity that
2 are, or are proposed to be, in a record;

3 (5) the other terms and conditions of the interest exchange; and

4 (6) any other provision required by the law of this state or the
5 operating agreement of the acquired entity.

6 (b) In addition to the requirements of subsection (a), a plan of
7 interest exchange may contain any other provision not prohibited by law.

8
9 4-38-1033. Approval of interest exchange.

10 (a) A plan of interest exchange is not effective unless it has been
11 approved:

12 (1) by all the members of a domestic acquired limited liability
13 company entitled to vote on or consent to any matter; and

14 (2) in a record, by each member of the domestic acquired limited
15 liability company that will have interest holder liability for debts,
16 obligations, and other liabilities that are incurred after the interest
17 exchange becomes effective, unless:

18 (A) the operating agreement of the company provides in a
19 record for the approval of an interest exchange or a merger in which some or
20 all of its members become subject to interest holder liability by the
21 affirmative vote or consent of fewer than all the members; and

22 (B) the member consented in a record to or voted for that
23 provision of the operating agreement or became a member after the adoption of
24 that provision.

25 (b) An interest exchange involving a domestic acquired entity that is
26 not a limited liability company is not effective unless it is approved by the
27 domestic entity in accordance with its organic law.

28 (c) An interest exchange involving a foreign acquired entity is not
29 effective unless it is approved by the foreign entity in accordance with the
30 law of the foreign entity's jurisdiction of formation.

31 (d) Except as otherwise provided in its organic law or organic rules,
32 the interest holders of the acquiring entity are not required to approve the
33 interest exchange.

34
35 4-38-1034. Amendment or abandonment of plan of interest exchange.

36 (a) A plan of interest exchange may be amended only with the consent

1 of each party to the plan, except as otherwise provided in the plan.

2 (b) A domestic acquired limited liability company may approve an
3 amendment of a plan of interest exchange:

4 (1) in the same manner as the plan was approved, if the plan
5 does not provide for the manner in which it may be amended; or

6 (2) by its managers or members in the manner provided in the
7 plan, but a member that was entitled to vote on or consent to approval of the
8 interest exchange is entitled to vote on or consent to any amendment of the
9 plan that will change:

10 (A) the amount or kind of interests, securities,
11 obligations, money, other property, rights to acquire interests or
12 securities, or any combination of the foregoing, to be received by any of the
13 members of the acquired company under the plan;

14 (B) the certificate of organization or operating agreement
15 of the acquired company that will be in effect immediately after the interest
16 exchange becomes effective, except for changes that do not require approval
17 of the members of the acquired company under this chapter or the operating
18 agreement; or

19 (C) any other terms or conditions of the plan, if the
20 change would adversely affect the member in any material respect.

21 (c) After a plan of interest exchange has been approved and before a
22 statement of interest exchange becomes effective, the plan may be abandoned
23 as provided in the plan. Unless prohibited by the plan, a domestic acquired
24 limited liability company may abandon the plan in the same manner as the plan
25 was approved.

26 (d) If a plan of interest exchange is abandoned after a statement of
27 interest exchange has been delivered to the Secretary of State for filing and
28 before the statement becomes effective, a statement of abandonment, signed by
29 the acquired limited liability company, must be delivered to the Secretary of
30 State for filing before the statement of interest exchange becomes effective.
31 The statement of abandonment takes effect on filing, and the interest
32 exchange is abandoned and does not become effective. The statement of
33 abandonment must contain:

34 (1) the name of the acquired company;

35 (2) the date on which the statement of interest exchange was
36 filed by the Secretary of State; and

1 (3) a statement that the interest exchange has been abandoned in
2 accordance with this section.

3
4 4-38-1035. Statement of interest exchange; Effective date of interest
5 exchange.

6 (a) A statement of interest exchange must be signed by a domestic
7 acquired limited liability company and delivered to the Secretary of State
8 for filing.

9 (b) A statement of interest exchange must contain:

10 (1) the name of the acquired limited liability company;

11 (2) the name, jurisdiction of formation, and type of entity of
12 the acquiring entity;

13 (3) a statement that the plan of interest exchange was approved
14 by the acquired company in accordance with this part; and

15 (4) any amendments to the acquired company's certificate of
16 organization approved as part of the plan of interest exchange.

17 (c) In addition to the requirements of subsection (b), a statement of
18 interest exchange may contain any other provision not prohibited by law.

19 (d) A plan of interest exchange that is signed by a domestic acquired
20 limited liability company and meets all the requirements of subsection (b)
21 may be delivered to the Secretary of State for filing instead of a statement
22 of interest exchange and on filing has the same effect. If a plan of
23 interest exchange is filed as provided in this subsection, references in this
24 subchapter to a statement of interest exchange refer to the plan of interest
25 exchange filed under this subsection.

26 (e) An interest exchange becomes effective when the statement of
27 interest exchange is effective.

28
29 4-38-1036. Effect of interest exchange.

30 (a) When an interest exchange in which the acquired entity is a
31 domestic limited liability company becomes effective:

32 (1) the interests in the acquired company which are the subject
33 of the interest exchange are converted, and the members holding those
34 interests are entitled only to the rights provided to them under the plan of
35 interest exchange and to any appraisal rights they have under § 4-38-1006;

36 (2) the acquiring entity becomes the interest holder of the

1 interests in the acquired company stated in the plan of interest exchange to
2 be acquired by the acquiring entity;

3 (3) the certificate of organization of the acquired company is
4 amended to the extent provided in the statement of interest exchange; and

5 (4) the provisions of the operating agreement of the acquired
6 company that are to be in a record, if any, are amended to the extent
7 provided in the plan of interest exchange.

8 (b) Except as otherwise provided in the operating agreement of a
9 domestic acquired limited liability company, the interest exchange does not
10 give rise to any rights that a member, manager, or third party would have
11 upon a dissolution, liquidation, or winding up of the acquired company.

12 (c) When an interest exchange becomes effective, a person that did not
13 have interest holder liability with respect to a domestic acquired limited
14 liability company and becomes subject to interest holder liability with
15 respect to a domestic entity as a result of the interest exchange has
16 interest holder liability only to the extent provided by the organic law of
17 the entity and only for those debts, obligations, and other liabilities that
18 are incurred after the interest exchange becomes effective.

19 (d) When an interest exchange becomes effective, the interest holder
20 liability of a person that ceases to hold an interest in a domestic acquired
21 limited liability company with respect to which the person had interest
22 holder liability is subject to the following rules:

23 (1) The interest exchange does not discharge any interest holder
24 liability under this chapter to the extent the interest holder liability was
25 incurred before the interest exchange became effective.

26 (2) The person does not have interest holder liability under
27 this chapter for any debt, obligation, or other liability that is incurred
28 after the interest exchange becomes effective.

29 (3) This chapter continues to apply to the release, collection,
30 or discharge of any interest holder liability preserved under paragraph (1)
31 as if the interest exchange had not occurred.

32 (4) The person has whatever rights of contribution from any
33 other person as are provided by this chapter, law other than this chapter, or
34 the operating agreement of the acquired company with respect to any interest
35 holder liability preserved under paragraph (1) as if the interest exchange
36 had not occurred.

4 4-38-1041. Conversion authorized.

5 (a) By complying with this part, a domestic limited liability company
6 may become:

7 (1) a domestic entity that is a different type of entity; or

8 (2) a foreign entity that is a different type of entity, if the
9 conversion is authorized by the law of the foreign entity's jurisdiction of
10 formation.

11 (b) By complying with the provisions of this part applicable to
12 foreign entities, a foreign entity that is not a foreign limited liability
13 company may become a domestic limited liability company if the conversion is
14 authorized by the law of the foreign entity's jurisdiction of formation.

15 (c) If a protected agreement contains a provision that applies to a
16 merger of a domestic limited liability company but does not refer to a
17 conversion, the provision applies to a conversion of the company as if the
18 conversion were a merger until the provision is amended after the effective
19 date of this chapter.

20
21 4-38-1042. Plan of conversion.

22 (a) A domestic limited liability company may convert to a different
23 type of entity under this part by approving a plan of conversion. The plan
24 must be in a record and contain:

25 (1) the name of the converting limited liability company;

26 (2) the name, jurisdiction of formation, and type of entity of
27 the converted entity;

28 (3) the manner of converting the interests in the converting
29 limited liability company into interests, securities, obligations, money,
30 other property, rights to acquire interests or securities, or any combination
31 of the foregoing;

32 (4) the proposed public organic record of the converted entity
33 if it will be a filing entity;

34 (5) the full text of the private organic rules of the converted
35 entity which are proposed to be in a record;

36 (6) the other terms and conditions of the conversion; and

1 (7) any other provision required by the law of this state or the
2 operating agreement of the converting limited liability company.

3 (b) In addition to the requirements of subsection (a), a plan of
4 conversion may contain any other provision not prohibited by law.

5
6 4-38-1043. Approval of conversion.

7 (a) A plan of conversion is not effective unless it has been approved:

8 (1) by a domestic converting limited liability company, by all
9 the members of the limited liability company entitled to vote on or consent
10 to any matter; and

11 (2) in a record, by each member of a domestic converting limited
12 liability company which will have interest holder liability for debts,
13 obligations, and other liabilities that are incurred after the conversion
14 becomes effective, unless:

15 (A) the operating agreement of the company provides in a
16 record for the approval of a conversion or a merger in which some or all of
17 its members become subject to interest holder liability by the affirmative
18 vote or consent of fewer than all the members; and

19 (B) the member voted for or consented in a record to that
20 provision of the operating agreement or became a member after the adoption of
21 that provision.

22 (b) A conversion involving a domestic converting entity that is not a
23 limited liability company is not effective unless it is approved by the
24 domestic converting entity in accordance with its organic law.

25 (c) A conversion of a foreign converting entity is not effective
26 unless it is approved by the foreign entity in accordance with the law of the
27 foreign entity's jurisdiction of formation.

28
29 4-38-1044. Amendment or abandonment of plan of conversion.

30 (a) A plan of conversion of a domestic converting limited liability
31 company may be amended:

32 (1) in the same manner as the plan was approved, if the plan
33 does not provide for the manner in which it may be amended; or

34 (2) by its managers or members in the manner provided in the
35 plan, but a member that was entitled to vote on or consent to approval of the
36 conversion is entitled to vote on or consent to any amendment of the plan

1 that will change:

2 (A) the amount or kind of interests, securities,
3 obligations, money, other property, rights to acquire interests or
4 securities, or any combination of the foregoing, to be received by any of the
5 members of the converting company under the plan;

6 (B) the public organic record, if any, or private organic
7 rules of the converted entity which will be in effect immediately after the
8 conversion becomes effective, except for changes that do not require approval
9 of the interest holders of the converted entity under its organic law or
10 organic rules; or

11 (C) any other terms or conditions of the plan, if the
12 change would adversely affect the member in any material respect.

13 (b) After a plan of conversion has been approved by a domestic
14 converting limited liability company and before a statement of conversion
15 becomes effective, the plan may be abandoned as provided in the plan. Unless
16 prohibited by the plan, a domestic converting limited liability company may
17 abandon the plan in the same manner as the plan was approved.

18 (c) If a plan of conversion is abandoned after a statement of
19 conversion has been delivered to the Secretary of State for filing and before
20 the statement becomes effective, a statement of abandonment, signed by the
21 converting entity, must be delivered to the Secretary of State for filing
22 before the statement of conversion becomes effective. The statement of
23 abandonment takes effect on filing, and the conversion is abandoned and does
24 not become effective. The statement of abandonment must contain:

25 (1) the name of the converting limited liability company;

26 (2) the date on which the statement of conversion was filed by
27 the Secretary of State; and

28 (3) a statement that the conversion has been abandoned in
29 accordance with this section.

30
31 4-38-1045. Statement of conversion – Effective date of conversion.

32 (a) A statement of conversion must be signed by the converting entity
33 and delivered to the Secretary of State for filing.

34 (b) A statement of conversion must contain:

35 (1) the name, jurisdiction of formation, and type of entity of
36 the converting entity;

1 (2) the name, jurisdiction of formation, and type of entity of
2 the converted entity;

3 (3) if the converting entity is a domestic limited liability
4 company, a statement that the plan of conversion was approved in accordance
5 with this part or, if the converting entity is a foreign entity, a statement
6 that the conversion was approved by the foreign entity in accordance with the
7 law of its jurisdiction of formation;

8 (4) if the converted entity is a domestic filing entity, its
9 public organic record, as an attachment; and

10 (5) if the converted entity is a domestic limited liability
11 partnership, its statement of qualification, as an attachment.

12 (c) In addition to the requirements of subsection (b), a statement of
13 conversion may contain any other provision not prohibited by law.

14 (d) If the converted entity is a domestic entity, its public organic
15 record, if any, must satisfy the requirements of the law of this state,
16 except that the public organic record does not need to be signed.

17 (e) A plan of conversion that is signed by a domestic converting
18 limited liability company and meets all the requirements of subsection (b)
19 may be delivered to the Secretary of State for filing instead of a statement
20 of conversion and on filing has the same effect. If a plan of conversion is
21 filed as provided in this subsection, references in this chapter to a
22 statement of conversion refer to the plan of conversion filed under this
23 subsection.

24 (f) If the converted entity is a domestic limited liability company,
25 the conversion becomes effective when the statement of conversion is
26 effective. In all other cases, the conversion becomes effective on the later
27 of:

28 (1) the date and time provided by the organic law of the
29 converted entity; and

30 (2) when the statement is effective.

31
32 4-38-1046. Effect of conversion.

33 (a) When a conversion becomes effective:

34 (1) the converted entity is:

35 (A) organized under and subject to the organic law of the
36 converted entity; and

1 (B) the same entity without interruption as the converting
2 entity;

3 (2) all property of the converting entity continues to be vested
4 in the converted entity without transfer, reversion, or impairment;

5 (3) all debts, obligations, and other liabilities of the
6 converting entity continue as debts, obligations, and other liabilities of
7 the converted entity;

8 (4) except as otherwise provided by law or the plan of
9 conversion, all the rights, privileges, immunities, powers, and purposes of
10 the converting entity remain in the converted entity;

11 (5) the name of the converted entity may be substituted for the
12 name of the converting entity in any pending action or proceeding;

13 (6) the certificate of organization of the converted entity
14 becomes effective;

15 (7) the provisions of the operating agreement of the converted
16 entity which are to be in a record, if any, approved as part of the plan of
17 conversion become effective; and

18 (8) the interests in the converting entity are converted, and
19 the interest holders of the converting entity are entitled only to the rights
20 provided to them under the plan of conversion and to any appraisal rights
21 they have under § 4-38-1006.

22 (b) Except as otherwise provided in the operating agreement of a
23 domestic converting limited liability company, the conversion does not give
24 rise to any rights that a member, manager, or third party would have upon a
25 dissolution, liquidation, or winding up of the converting entity.

26 (c) When a conversion becomes effective, a person that did not have
27 interest holder liability with respect to the converting entity and becomes
28 subject to interest holder liability with respect to a domestic entity as a
29 result of the conversion has interest holder liability only to the extent
30 provided by the organic law of the entity and only for those debts,
31 obligations, and other liabilities that are incurred after the conversion
32 becomes effective.

33 (d) When a conversion becomes effective, the interest holder liability
34 of a person that ceases to hold an interest in a domestic converting limited
35 liability company with respect to which the person had interest holder
36 liability is subject to the following rules:

1 (1) The conversion does not discharge any interest holder
2 liability under this chapter to the extent the interest holder liability was
3 incurred before the conversion became effective;

4 (2) The person does not have interest holder liability under
5 this chapter for any debt, obligation, or other liability that arises after
6 the conversion becomes effective;

7 (3) This chapter continues to apply to the release, collection,
8 or discharge of any interest holder liability preserved under paragraph (1)
9 as if the conversion had not occurred; and

10 (4) The person has whatever rights of contribution from any
11 other person as are provided by this chapter, law other than this chapter, or
12 the organic rules of the converting entity with respect to any interest
13 holder liability preserved under paragraph (1) as if the conversion had not
14 occurred.

15 (e) When a conversion becomes effective, a foreign entity that is the
16 converted entity may be served with process in this state for the collection
17 and enforcement of any of its debts, obligations, and other liabilities as
18 provided in § 4-38-119.

19 (f) If the converting entity is a registered foreign entity, its
20 registration to do business in this state is canceled when the conversion
21 becomes effective.

22 (g) A conversion does not require the entity to wind up its affairs
23 and does not constitute or cause the dissolution of the entity.

24
25 PART 5 – Domestication

27 4-38-1051. Domestication authorized.

28 (a) By complying with this part, a domestic limited liability company
29 may become a foreign limited liability company if the domestication is
30 authorized by the law of the foreign jurisdiction.

31 (b) By complying with the provisions of this part applicable to
32 foreign limited liability companies, a foreign limited liability company may
33 become a domestic limited liability company if the domestication is
34 authorized by the law of the foreign limited liability company's jurisdiction
35 of formation.

36 (c) If a protected agreement contains a provision that applies to a

1 merger of a domestic limited liability company but does not refer to a
2 domestication, the provision applies to a domestication of the limited
3 liability company as if the domestication were a merger until the provision
4 is amended after the effective date of this chapter.

5
6 4-38-1052. Plan of domestication.

7 (a) A domestic limited liability company may become a foreign limited
8 liability company in a domestication by approving a plan of domestication.
9 The plan must be in a record and contain:

10 (1) the name of the domesticating limited liability company;

11 (2) the name and jurisdiction of formation of the domesticated
12 limited liability company;

13 (3) the manner of converting the interests in the domesticating
14 limited liability company into interests, securities, obligations, money,
15 other property, rights to acquire interests or securities, or any combination
16 of the foregoing;

17 (4) the proposed certificate of organization of the domesticated
18 limited liability company;

19 (5) the full text of the provisions of the operating agreement
20 of the domesticated limited liability company that are proposed to be in a
21 record;

22 (6) the other terms and conditions of the domestication; and

23 (7) any other provision required by the law of this state or the
24 operating agreement of the domesticating limited liability company.

25 (b) In addition to the requirements of subsection (a), a plan of
26 domestication may contain any other provision not prohibited by law.

27
28 4-38-1053. Approval of domestication.

29 (a) A plan of domestication of a domestic domesticating limited
30 liability company is not effective unless it has been approved:

31 (1) by all the members entitled to vote on or consent to any
32 matter; and

33 (2) in a record, by each member that will have interest holder
34 liability for debts, obligations, and other liabilities that are incurred
35 after the domestication becomes effective, unless:

36 (A) the operating agreement of the domesticating company

1 in a record provides for the approval of a domestication or merger in which
2 some or all of its members become subject to interest holder liability by the
3 affirmative vote or consent of fewer than all the members; and

4 (B) the member voted for or consented in a record to that
5 provision of the operating agreement or became a member after the adoption of
6 that provision.

7 (b) A domestication of a foreign domesticating limited liability
8 company is not effective unless it is approved in accordance with the law of
9 the foreign limited liability company's jurisdiction of formation.

10
11 4-38-1054. Amendment or abandonment of plan of domestication.

12 (a) A plan of domestication of a domestic domesticating limited
13 liability company may be amended:

14 (1) in the same manner as the plan was approved, if the plan
15 does not provide for the manner in which it may be amended; or

16 (2) by its managers or members in the manner provided in the
17 plan, but a member that was entitled to vote on or consent to approval of the
18 domestication is entitled to vote on or consent to any amendment of the plan
19 that will change:

20 (A) the amount or kind of interests, securities,
21 obligations, money, other property, rights to acquire interests or
22 securities, or any combination of the foregoing, to be received by any of the
23 members of the domesticating limited liability company under the plan;

1 (c) If a plan of domestication is abandoned after a statement of
2 domestication has been delivered to the Secretary of State for filing and
3 before the statement becomes effective, a statement of abandonment, signed by
4 the domesticating limited liability company, must be delivered to the
5 Secretary of State for filing before the statement of domestication becomes
6 effective. The statement of abandonment takes effect on filing, and the
7 domestication is abandoned and does not become effective. The statement of
8 abandonment must contain:

9 (1) the name of the domesticating limited liability company;

10 (2) the date on which the statement of domestication was filed
11 by the Secretary of State; and

12 (3) a statement that the domestication has been abandoned in
13 accordance with this section.

14
15 4-38-1055. Statement of domestication – Effective date of
16 domestication.

17 (a) A statement of domestication must be signed by the domesticating
18 limited liability company and delivered to the Secretary of State for filing.

19 (b) A statement of domestication must contain:

20 (1) the name and jurisdiction of formation of the domesticating
21 limited liability company;

22 (2) the name and jurisdiction of formation of the domesticated
23 limited liability company;

24 (3) if the domesticating limited liability company is a domestic
25 limited liability company, a statement that the plan of domestication was
26 approved in accordance with this part or, if the domesticating limited
27 liability company is a foreign limited liability company, a statement that
28 the domestication was approved in accordance with the law of its jurisdiction
29 of formation; and

30 (4) the certificate of organization of the domesticated limited
31 liability company, as an attachment.

32 (c) In addition to the requirements of subsection (b), a statement of
33 domestication may contain any other provision not prohibited by law.

1 (e) A plan of domestication that is signed by a domesticating domestic
2 limited liability company and meets all the requirements of subsection (b)
3 may be delivered to the Secretary of State for filing instead of a statement
4 of domestication and on filing has the same effect. If a plan of
5 domestication is filed as provided in this subsection, references in this
6 subchapter to a statement of domestication refer to the plan of domestication
7 filed under this subsection.

8 (f) If the domesticated entity is a domestic limited liability
9 company, the domestication becomes effective when the statement of
10 domestication is effective. If the domesticated entity is a foreign limited
11 liability company, the domestication becomes effective on the later of:

12 (1) the date and time provided by the organic law of the
13 domesticated entity; and

14 (2) when the statement is effective.

15
16 4-38-1056. Effect of domestication.

17 (a) When a domestication becomes effective:

18 (1) the domesticated entity is:

19 (A) organized under and subject to the organic law of the
20 domesticated entity; and

21 (B) the same entity without interruption as the
22 domesticating entity;

23 (2) all property of the domesticating entity continues to be
24 vested in the domesticated entity without transfer, reversion, or impairment;

25 (3) all debts, obligations, and other liabilities of the

3 the extent and as approved in connection with the domestication, and the
4 members of the domesticating entity are entitled only to the rights provided
5 to them under the plan of domestication and to any appraisal rights they have
6 under § 4-38-1006.

7 (b) Except as otherwise provided in the organic law or operating
8 agreement of the domesticating limited liability company, the domestication
9 does not give rise to any rights that a member, manager, or third party would
10 otherwise have upon a dissolution, liquidation, or winding up of the
11 domesticating company.

12 (c) When a domestication becomes effective, a person that did not have
13 interest holder liability with respect to the domesticating limited liability
14 company and becomes subject to interest holder liability with respect to a
15 domestic company as a result of the domestication has interest holder
16 liability only to the extent provided by this chapter and only for those
17 debts, obligations, and other liabilities that are incurred after the
18 domestication becomes effective.

19 (d) When a domestication becomes effective, the interest holder
20 liability of a person that ceases to hold an interest in a domestic
21 domesticating limited liability company with respect to which the person had
22 interest holder liability is subject to the following rules:

23 (1) The domestication does not discharge any interest holder
24 liability under this chapter to the extent the interest holder liability was
25 incurred before the domestication became effective.

26 (2) A person does not have interest holder liability under this
27 chapter for any debt, obligation, or other liability that is incurred after
28 the domestication becomes effective.

29 (3) This chapter continues to apply to the release, collection,
30 or discharge of any interest holder liability preserved under paragraph (1)
31 as if the domestication had not occurred.

32 (4) A person has whatever rights of contribution from any other
33 person as are provided by this chapter, law other than this chapter, or the
34 operating agreement of the domestic domesticating limited liability company
35 with respect to any interest holder liability preserved under paragraph (1)
36 as if the domestication had not occurred.

1 (e) When a domestication becomes effective, a foreign limited
2 liability company that is the domesticated company may be served with process
3 in this state for the collection and enforcement of any of its debts,
4 obligations, and other liabilities as provided in § 4-38-119.

5 (f) If the domesticating limited liability company is a registered
6 foreign entity, the registration of the company is canceled when the
7 domestication becomes effective.

8 (g) A domestication does not require a domestic domesticating limited
9 liability company to wind up its affairs and does not constitute or cause the
10 dissolution of the company.

11

14 4-38-1101. Uniformity of application and construction.

28 This chapter does not affect an action commenced, proceeding brought,
29 or right accrued before the effective date of this chapter.
