21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby			
24	appropriated, to the Northwest Arkansas Community College, to be payable from			
25	the Northwest Arkansas Community College Fund, for personal services of the			
26	Northwest Arkansas Community College which shall be supplemental and in			
27	addition to those funds appropriated in Section 3 of Act 208 of 2021, the			
28	following:

34	SECTION 2. COMPI	LIANCE WITH OTHER LAWS. Disbursem	ent of funds	
35	authorized by this act shall be limited to the appropriation for such agency			
36	and funds made available by law for the support of such appropriations; and			



the restrictions of the State Procurement Law, the General Accounting and
Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
Procedures and Restrictions Act, or their successors, and other fiscal
control laws of this State, where applicable, and regulations promulgated by
the Department of Finance and Administration, as authorized by law, shall be
strictly complied with in disbursement of said funds.

8 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General 9 Assembly that any funds disbursed under the authority of the appropriations 10 contained in this act shall be in compliance with the stated reasons for 11 which this act was adopted, as evidenced by the Agency Requests, Executive 12 Recommendations and Legislative Recommendations contained in the budget 13 manuals prepared by the Department of Finance and Administration, letters, or 14 summarized oral testimony in the official minutes of the Arkansas Legislative 15 Council or Joint Budget Committee which relate to its passage and adoption. 16

17 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General 18 Assembly, that funds provided by the General Assembly for the operations of 19 the Northwest Arkansas Community College are, due to unforeseen 20 circumstances, insufficient for the Northwest Arkansas Community College to continue to provide essential governmental services; that the provisions of 21 22 this act will provide the necessary monies for the Northwest Arkansas 23 Community College to continue such services; and that a delay in the effective date of this Act could work irreparable harm upon the proper 24 25 administration and provision of essential governmental programs. Therefore, 26 an emergency is hereby declared to exist and this Act being necessary for the 27 immediate preservation of the public peace, health and safety shall be in full force and effect from and after the date of its passage and approval. 28 29 If the bill is neither approved nor vetoed by the Governor, it shall 30 become effective on the expiration of the period of time during which the Governor may veto the bill. If the bill is vetoed by the Governor and the 31 32 veto is overridden, it shall become effective on the date the last house 33 overrides the veto. 34 35
